OUR PRESIDENT.

(From Wednesday's Daily.)
(This was written for the issue of The Sentinel immediately following election, but didn't get into type for reasons given in editorial immediately preceding this.)
The majority has spoken decisively. That majority has selected Roosevelt to replace Hoover, yet for some inexplicable reason we seem to be carrying on about the same as before.

It is a relief to have the great struggle over. In some ways it is a relief to turn the reins over to others during the next four years.

Regardless of what happens we can say that the fault is not ours, for we didn't help elect the president and we won't have to prove that we spoke truly when we promised what Hoover would do. It is in many ways a relief to the republican party not to have to bear any of the responsibilities nor have any of the worries of bringing the country out of the depression.

The next four years are going to be trying years. They are going to be the years when the reins of government.

We are not going to have good times overnight. We may not have them at all during the next four years, but a tremendous majority believe they have done what was necessary to right conditions, they believe that the new administration will bring better times, and that is a psychological frame of mind that may be just the touch needed. The republicans, relieved of responsibility, are taking the results with a happy frame of mind and a willingness to be helpful, and that also should help.

But, although we may be pleased to be rid of the responsibility, although we believe the great majority has erred, we hope we are wrong and that those who made Roosevelt's election possible are right in their contention that Roosevelt can do what Hoover was unable to do.

Regardless of whether or not we believe the voters erred, everyone of us should do his part to help the administration bring us out of the mire. It is our patriotic duty so to do. It is to our own interests so to do.

It seems almost certain that four years from now we shall hear much of the same criticism of Roosevelt that we have heard of Hoover, for the people are expecting him to do the superhuman, just as they did of Hoover, and he can't do it. We are facing world-wide conditions over which we have little control. We can only ameliorate conditions until such time as conditions are believed in other countries and we resume normal business relations with the nations of the world.

But whatever may be said, honestly, of the Roosevelt administration, we trust that the lies will not be told and believed that were told and believed of Hoover. From the point of view of vilification the recent campaign was one of which the American people have no reason to be proud.

thought that we had omitted the news because our candidate had been defeated, especially as we had carried Hoover carried Cottage Grove.

The election was held Tuesday. The Sentinel was printed on Friday. It believes it has no reader so lacking in interest in national affairs that he didn't know before that time how the national contest had resulted.

The fact that Hoover carried Cottage Grove was local news and was unusual enough to be worthy of a headline. Roosevelt's election was known to all and was no longer news.

Just to show that The Sentinel is consistent, four years ago it did not carry headlines announcing the election of Hoover. The same conditions prevailed then. By the time The Sentinel was printed everyone knew that Hoover had been elected or, if he didn't know, his interest in public affairs was so small that there was no need of his knowing.

LIQUOR AT PUBLIC GATHERINGS.

The vote on November 8 by which the prohibition law was repealed by a huge vote seems to have gone to the heads of a few of the wets, and they already are making ammunition for the prohibitionists, these few are already doing the things that the prohibitionists would have done if liquor should again be legalized. Legal authorities of state and county have expressed the opinion that possession of liquor is no longer a crime in Oregon. It has been reported to The Sentinel that at a public gathering in a public building following election a wet, name unknown to The Sentinel, openly flaunted a bottle of liquor. We are with the prohibitionists in inveighing with all the energy we possess against acts of that kind.

That is not personal liberty, that is interfering with the rights of others. Those who oppose liquor have a legal right to attend a public meeting or gathering of any kind without having liquor flaunted in their faces. They have a legal right to attend public gatherings without having to come in contact with intoxicated persons.

So far as that goes, those who flaunt liquor at public gatherings, and drink it at public gatherings, are likely to find that such acts are not legal and were not legal even in the old saloon days.

Those who claim that personal liberty grants them the right to make and have liquor should grant to others the personal liberty that they demand for themselves. The dregs, under the head of personal liberty, have at least as much right to have liquor kept out of public gatherings as the wets have to consume liquor in private.

TROUBLES OF THE NEW COURT.

The county judge-elect and the county commissioner-elect, who have promised an annual reduction of \$250,000 in county expenses, and who have been put on the spot by being put on the budget committee in taxes want the cuts to be made in order to carry out their program, have found that it is easier to make promises in a campaign than it is to fulfill them afterward.

The budgeters have found that those who voted for the new deal in order to get this huge reduction in taxes want the cuts to be made everywhere except in items in which they are interested, while the new members of the court find that they haven't a chance to make the reduction promised unless they are permitted to slash every item over which the county court has any control.

The position of the new members of the county court is the best example we have ever seen of being between the devil and the deep sea. The huge number who voted for the defeated officers believed in the policies of these officers, and their wishes can not be lightly set aside, for they are a large and energetic minority, while a large number of those who voted for the victors did not realize what a slashing is necessary if \$250,000 is to be saved.

The Sentinel believes that some savings may be possible, it has never known of a body spending public funds that couldn't make savings, and it believes that Fred Fisk, judge-elect, and Cal Young, commissioner-elect, will make savings if it is possible to do so without seriously hampering the conduct of the county's business, without seriously interfering with care of the destitute, but right now it would be a heap rather be in the position of the defeated officers who have no promises to fulfill than in the position of the victors.

But let us be absolutely fair even to those we opposed.

Whether or not Fisk and Young make good on their promises, let us bear in mind that they are upstanding citizens and honorable men who will give their best in the service of their county and are entitled to kindly consideration even when they make mistakes. May they not be abused for mistakes of the flesh, not of the heart, as have been those who will step out January 1. Remember that these are trying times and the most faithful servant, who works long hours for little pay, is likely to be unjustly criticized even by those who voted him into office.
