HITCHING RACKS ARE BACK.

Many heated battles, though they were mostly of words, raged in Cottage Grove and other cities years ago over the hitching rack problem. As streets were improved and cities began to take on airs, there was a demand that hitching racks be moved from business districts. Stores no longer wished horses tethered at their front doors. Barnyard aromas and the attendant flies were declared a nuisance that no self-respecting city would permit.

When an effort was made to install hitching racks at a distance from the main section of the city, horse owners objected.

Then rural residents declared they would not trade in a city that did not provide racks where their nag might be permitted to stand for hours switching ravenous flies. They would send their money elsewhere, although elsewhere the same restrictions would have been imposed if the same farmers had attempted to tether the motive power for their vehicles while doing their trading. Also rural residents had to have racks that were convenient. They weren't going to carry their purchases for several blocks to reach their vehicles, and they weren't going to be forced to patronize livery stables.

Gradually most rural residents became owners of motor vehicles, and the battle of the hitching racks subsided because those who would use them became so few in numbers as to be negligible.

The lively stable, in olden days a popular rendezvous, was effaced from the business life of the city. In Cottage Grove even the buildings which once were stables have been torn down and have been supplanted by garages and service stations, neither of which offers the social advantages of the old-time livery stable where problems of state and nation, county and city were solved. Ninety per cent of the youngsters of today prob-

bly wouldn't be able to drive a team of fast horses that were good for eight or ten miles an hour on a gallon of oats. They certainly wouldn't know whether to start at the head or the tail to place the harness. They never will be able to talk reminiscently of the days when they hung the reins over their necks while out with the sweet little damsel that afterward became the head of the household. That is a real tragedy. Even the household is disappearing.

But with a gallon of gas selling at about the same price as a bushel of oats, Old Dobbin is coming back. Farmers are learning that it is cheaper to farm with horses than with gasoline-propelled vehicles, besides they can produce the fuel necessary to keep the horses going. Reports from great farming sections are that many farms have returned completely to horses. Incidentally a general movement of that kind will take care of a large part of the grain surplus and will also put many men back on the farms.

So great has become the movement back to the good old horse and buggy days that had become almost legendary that the Lane county court has been requested to again provide suitable hitching racks close to the business district, and the county court has said that it will do so.

Soon the hitching rack battles will be resumed in Cottage Grove and elsewhere.

Why, back in Ohio a sensation was created a few days ago when an implement dealer received an order for a 1933 buggy with balloon tires, free-wheeling and other conveniences.

For one we wouldn't mind handling the ribbons again over the backs of a team of spanking bays, and we'd ask our old sweetheart of 30 years ago to resume her old place at the left as of yore. The buggy we used had a right-hand drive.

OUR POSITION ON N. R. A.

There has been much comment about the unanimity of the newspapers for the NRA program. Many have been especially curious to know why republican newspapers have given such hearty support.

The position of The Sentinel is easily explained.

In the first place we don't care where prosperity comes from, nor what party brings. The republicans were not any too successful, due in large part to lack of confidence in the administration. Whether or not such lack of confidence was justifiable makes no difference now.

We have an administration which came into power with the greatest popular vote ever given the candidates of any party. With the confidence of the nation, and with the time having arrived when, according to past experience, an upturn in the pendulum is due, the administration, with the approval of members of congress of the opposing party, offered a plan that was recommended to us as one that would give Old Man Depression a solar plexus. The minds that evolved the plan are of such caliber that The Sentinel would feel presumptuous in attempting to pick flaws in the plan. It accepts the plan without argument because it was evolved by greater minds than ours, because it was evolved by those who have had every opportunity to know what ought to be done or what ought to work, who are close to the problems of government, because we are confident the leaders are sincere and honest in their efforts.

Although we remain a republican newspaper, we feel that politics should not be an issue, that what we want is better wages for the worker and food and clothing for every resident of the land. We want the NRA to work.

We don't see how the plan can fail to work, but if it should not work, we do not want it to be said that it failed because the opposing party failed to give cooperation. We wish to settle once and for all whether or not a plan such as the NRA, with the cooperation of the people, is a workable one. Inasmuch as the administration has embarked upon it, it would be worse to try to stop the experiment from being tried than to give cooperation and still have it fail.

The Sentinel has no desire to see the republican party come back into power through the failure of a plan that would have been successful without republican support. It would much rather see the plan work and have the democrats remain in power another four years.

No better plan has been offered, so we should give fullest cooperation to the one that is before us, regardless of where it comes from.

Roger W. Babson predicts that the country is going to go through some kind of an upheaval that will place it in control of the middle class. There should be no fear for the country's welfare if it should pass into the control of that class. The danger is in its control by the so-called capitalistic class or by the radicals.

Nudism is reported to be still on the increase, despite the fact that the NRA program is supposed to give us the wherewithal with which to buy clothes. If NRA doesn't work there is danger of us all becoming nudists regardless of whether the idea is popular.

The big issue in Oregon right now is a tax that will provide about \$7,000,000. We have a plan designed to hit every resident of the state equally. Impose a tax of cents on every idea suggested for a tax that would hit only the other fellow.

English scientists have declared it will never be possible to produce life in a test tube. We regret hearing that, as we had in mind several we were going to suggest for the test tube experiment.
