W. C. T. U. HAS WORK TO DO.
The W. C. T. U. is composed of some of the most splendid women of our land who sincerely believe in prohibition and have bent every effort to prevent the legalized return of Demon Rum and every thing that goes with the liquor traffic.

We use the expression "legalized return" because we never have had real prohibition. While the Sentinel never has taken a position favoring such legalized return of liquor, it never has become agitated over the prospects of such a comeback for Old Man John Barleycorn because it has believed it quite probable that legalized liquor, out in the open, can be as well controlled as liquor sold surreptitiously. It also believes that the liquor question never will be settled so long as a large proportion of the people want liquor. Neither does it believe return to legalized liquor is going to make the liquor business clean, high class, respectable, desirable business that a lot of persons seem to believe, or pretend to believe, it will be.

The Sentinel suspects that legalized liquor will present approximately the same number of problems, and will make approximately the same amount of trouble, that contraband liquor has.
