JOBS FOR UNEMPLOYED PROVIDED BY CWA

Cottage Grove Project, Begun Monday Morning, Gives Work to 43.

Civil works administration money has made possible a project to repair the pipe line of the Cottage Grove water system, upon which a crew of 43 men will be employed until its completion, nearly all of whom went to work Monday morning under supervision of City Engineer Lester W. Coier. Funds for the purpose are from an appropriation of \$400,000,000 to be used by the civil works administration throughout the United States for the purpose of providing immediate work for unemployed men and women.

The work will range from sewing and card indexing, to house painting and repairing irrigation ditches. Common laborers will be paid not less than 50 cents an hour and skilled workers may receive as much as \$1.20 an hour; all on a 30-hour week basis. 21,000 jobs under this mammoth program, Lane county's quota being 1008, the first half of the quota to come from the relief rolls and the second half from the national employment service, preference being given to veterans for second half jobs. Men and women will be selected on qualifications for the various types of work. Cottage Grove residents desiring employment on the second half jobs should register at the armory with John C. Miller, who is acting as local representative for the government employment service. Announcements have been made that workmen on CWA projects will be protected by federal workmen's compensation against complete loss of income should accidents make them incapable of service.

City Engineer Coier, representing the city council, conferred with Raymond C. Wilson, state CWA chairman in Portland last week and secured approval of the project for repairing the city water system pipe line at an estimated expense of \$10,000, \$2,500 of which will be used for materials and \$7,500 for workers' wages, all of which money is provided by the civil works administration. Disbursements are to be by CWA paychecks and all bills have been made up that day by the foreman and must be in the hands of the administrator by that evening so the checks can be made out by Saturday.

While the minimum wage has been set at 50 cents an hour and the maximum at \$1.20 an hour, there will not be many men who will draw the latter, Mr. Coier pointed out. The figure is for skilled laborers but there will be an intermediate wage for most of the men to be classed above common laborers.

Definite instructions have been received as to what constitutes an unemployed man and who is to be assisted under the CWA program. Anyone who has a potential living or a potential job is considered as being unemployed, neither is a man with a part time job or one who has finances, even if he has no job, or a man who quits a poorer job in order to accept one under the CWA.

Following a meeting of CWA officials in Portland Wednesday of last week Chairman Wilcox sent out the following instructions to county chairmen:

"Certain projects were selected in each county for immediate undertaking. These are now being carefully computed and corrected in accordance with the discussions between the state administration and county administrations. As soon as prepared, on definite forms, you will be provided with copies thereof. In many instances this will necessitate a change in the original computation, both as to the number of men employed, man hours, and in some instances, rate of wages. The rate of wages will be based upon the ruling of the public works administration and the state highway commission, which involves intermediate rates of pay between the rates established by the civil works administration of the fullest extent, completing applications, you will receive definite instructions regarding the permanent method of selecting men for employment.

"To the maximum, depending upon the good faith of all which was so splendidly evidenced at the meeting, and in each conference with the county delegation, the ad-

Local Woman Knew Brooke Hart During His Early Childhood

To many readers of news dispatches from San Jose and Sacramento, concerning the kidnapping and murder of Brooke Hart, son of a wealthy San Jose merchant, the dumping of his trussed and mutilated body into San Francisco bay, the capture and conviction of his self-confessed slayers and their lynching Sunday night, a few hours after the mangled body was recovered, it may have seemed to be just another "kidnapping story" in "the papers," unique only in that it occurred nearer to Cottage Grove than is usual for such crimes to be perpetrated, but to one Cottage Grove woman it appeared to be exactly what it was—a stark and tragic atrocity.

Bohemia District Mines Are Under Inspection

F. C. Innes, mining engineer, and Ole Grotting, both of San Francisco, are in the Bohemia district in the interest of a San Francisco syndicate inspecting a number of mining properties having arrived about two weeks ago from Cascade, Ida.

428 Accidents Reported. Industrial accidents numbering 428 were reported to the state industrial accident commission for the week ending November 25. There were three fatalities: August Kurtti, Astoria, fall; James R. Hobbs, Portland, watchman; Israel Bodmay, Portland, deliveryman.

"In this connection, I again call your attention to the responsibility which lies upon your administration, particularly in the selecting of the timekeepers on the job, and the foremen whom you are selecting by cooperation with the local subdivision actually doing the work. The efficiency and correctness of the entire accounting system will rest upon the initial records of the timekeeper. The measures of efficiency on the jobs selected will depend upon the ability of the foremen.

"Although many of the projects approved carried necessary materials to be paid for from CWA funds, great caution you not to incur any considerable liabilities for materials until definite instructions have been made for paying same. This need not delay the undertaking of any project, but the purchasing of only the most essential material needed for a short period should be made now," Chairman Wilcox' letter of instructions concluded.

Here is the text of the executive order addressed to bankers of the nation by President Roosevelt in the matter of cashing CWA pay checks:

"The nation-wide civil works program, which the government launched in order to give men and women employment in place of relief is now under way. More than one million employees of the civil works administration will receive their first week's pay at the end of this week, on Saturday, November 25.

"They will be paid by checks drawn upon the treasury of the United States. To prevent delays in the payment of this initial week's wage, it is essential that our banks throughout the country cooperate to the fullest extent, cashing these checks at par upon proper identification. This identification will, in most cases, be an identification card given to payee by the local civil works administrator.

"I urge bankers to communicate with the local civil works administration to make certain that checks will be cashed promptly and in full."

Christmas Seal Sale Is Launched

Thanksgiving day marks the beginning of the 1933 Christmas seal sale, a campaign which is launched each year by the National Tuberculosis association to finance health work in the communities and states in which the funds are gathered.

From December 1 until Christmas, county and community leaders will personally solicit sales and manage the drive. Sale through the mail is to be made December 1, provision being made for remittance in each case, according to Mrs. Howard R. Taylor, Eugene, Lane county chairman. It is expected that the majority of sales in the county will be made through the mail, with the voluntary return of the seals or remittance for them, she said.

The official tuberculosis seal this year outlines the silhouette of three boys and a yule log over a background of orange, yellow and white. The double-bar cross of the association is printed on each stamp with the words "Christmas Greetings."

Voluntary workers utilize the funds gathered each year to carry on the tuberculosis association's efforts to prevent the disease, discover individual cases through local clinics and in schools, and to cure patients and care for them in hospitals. About 95 per cent of the money is spent in the state, a large part of it going directly for county health work and clinics, the association says.

Pigskin Supremacy Undisputed for First Time in Several Years.

For the first time in a number of years the undisputed football championship of Lane county is vested in the Cottage Grove high school gridirers aggregation, which won the title in the last two minutes of play. The powerful Eugene high team was held to a 6-6 score and also had to take to the air in the closing minutes of the struggle.

In seven games on the conference schedule Cottage Grove won five, tied one and lost one, scoring 95 points to opponents' 20. The games and scores were: Reedport, 19-7; Eugene, 6-6; University, 7-0; Roseburg, 12-0; Albany, 0-7; Springfield, 45-0; Lebanon, 6-0. In addition to the regular schedule the team defeated the alumni, 22, and the second string played a 6-6 tie with Junction City.

"Highlander" Johnston, in the Eugene Register-Guard, writes: "The only happy high school coach in the county is Orio Bagley of Cottage Grove. His footballers are county champs, and have lost just one game this season, to the powerful Albany eleven. They hold wins over University high and Springfield, a tie with Eugene. Groves also had best ball-player in conference, for consistent brilliance, game after game. Horn, the flashy halfback, is a sweet enough ballcarrier for anybody's club."

Coach Bagley has succeeded in imparting good strategy and a fine spirit of cooperation in the team, and the support and encouragement of the faculty and student body have been important factors. Glen Smith, backfield coach, has also contributed to the smooth functioning of the machine.

The selective-captain system was used this year and Dusenberry, Stewart, Kelly, Ray Thies and Horn acted as team captains in various games. Dan Kelly being elected honorary captain at the close of the season.

LUMBER BUSINESS IS DECIDEDLY UP IN AIR

Recent Buying Orgy Likely to Bring Many Months of Low Placements.

(Crew's Lumber Digest.) The general outlook of the lumber market is filled with so many uncertainties that no one can say just what the future holds.

One thing seems sure, the next 45 days will in all probability see the volume of buying drop to the lowest point recorded in the north-west for such a period in many years. The reason for this is the fact that an abnormal volume of placements, which were made just prior to the establishment of the minimum prices under the code, have without a doubt absorbed more than the normal demand would have been between now and the middle of January, if not later.

There are two ways of weighing the possible effects of this situation. If everyone, large mills, small mills and wholesalers, had shared alike proportionately in the advance bookings, it would look as though it would prove a blessing in that, having enough on their files to carry along, it would be easy to sit back and ask good prices and present a solid front. Unfortunately that is not the case. Some mills, mostly the larger operations that have capable wide awake sales departments, have ordered files that will make it easy to drift through the remainder of this month and all of December without further sales. Inquiry indicates that the extent to which the mills renege out for business tapers off in about the same relation to their capacity does.

Christmas Seal Idea Originated by Danish Postal Clerk in 1903

Christmas seal sales began when a Danish postal clerk interested in his government in the sale of stamps to raise funds for the construction of a tuberculosis hospital in 1903. The idea was tried in Delaware in 1907, and since 1910 has been under the management of the National Tuberculosis association. The 1933 seal marks its twenty-fourth year.

"Tuberculosis is preventable and curable" is the slogan for this year's Christmas seal sale, adopted because it signifies the purpose for which funds are gathered in the annual drive of the National Tuberculosis association through local leaders. A program of prevention through education, the organization of nurses and clinics to seek afflicted patients, and the provision of facilities for care and cure of these victims are made possible by Christmas Seal penalties.

Cameron Arrested for Forgery in Albany

Albany, Ore., Nov. 22.—Duncan P. Cameron of Eugene, unfranked pastor of the Cottage Grove Presbyterian church, and one-time department chaplain of the Oregon American Legion, was arrested today, accused of forgery.

Cameron was arrested last night after he had been accused of cashing three spurious checks in many local stores. He was bound over to the circuit court grand jury in a justice court hearing this morning. He was unable to post \$500 bond.

At his preliminary hearing Cameron told the court that this, and other reputed misdeeds which led to his unfranking, were due to a mental condition induced by shell shock which he said he suffered while serving with the Canadian army during the World war.

A Lane county complaint awaits him too, state police say, for a \$10.85 check given to a Eugene merchant.

which means that the smallest of the mills will be the first to need business and so on up. The whole-salers have, or it might be better to say, will suffer the most, for in the scramble to sell ahead such an orgy of price cutting was carried on directly by the mills that in the short length of time it was done they had little opportunity to reconcile disparities and get the party of the business that they would have secured had it been placed in the regular way.

Many glaring inequalities and discriminations are said to exist in the code which may make it hard to be believed, promise to place the small mills and wholesalers in the position where they will get business only after the larger mills equipped to receive their product have more than they can handle. The small mills claim that through changes made in the price list after it left the Pacific coast, differentials required to meet their stock have been eliminated through provisions on weights and other rules and regulations that make it utterly impossible to compete on a delivered basis, which after all is the only price in which the buyer is interested.

The wholesalers claim that the new rules of trade practices have placed the mills in the wholesale business without any restriction as to the profits they may make by buying from each other on any price basis they may choose, and point to the unprecedented volume of business which the large mills have placed with the small mills during the past three weeks as bona fide evidence that their fears are justified. The wholesalers have their profits specified and otherwise have well defined loads down only which they may travel in the conduct of their businesses.

It would require most of the space devoted to reading matter in this issue to enumerate the debatable subjects that have arisen already in connection with the code and the next two weeks will see some interesting developments as the various branches of the industry mill about trying to find just where they stand. In the meantime there is no going to be enough buying to be worth while reporting.

HEART ATTACK TAKES HOMER A. GALLOWAY

Former City Recorder, Editor, Veteran, Business Man, Answers Final Summons.

Homer A. Galloway, former city recorder, newspaper editor, business man, a veteran of the Spanish-American war, is dead. He succumbed to a heart attack Monday evening, at 9:20, in his usual health and cheerful spirits, he sat quietly with his wife in their home. At 9:25 he was gone. Mrs. Galloway summoned neighbors, who came at once, to find him beyond human aid, his body lifeless upon the floor.

Mr. Galloway was a newspaper editor for many years, a professional man, he had not followed since coming to Cottage Grove with his family from Enterprise 13 years ago. He was engaged in the insurance business several years and also served as city recorder, but failing health necessitated his retirement from activities some years ago.

Homer A. Galloway was born in Clayville, Pa., February 17, 1868, and was aged 65 years, 10 months, 9 days. His family removed to Aledo, Ill., in his infancy, where he grew to manhood. He was educated at the University of Illinois at Urbana. Following several years of newspaper work in Illinois, Iowa and Ohio, he made a trip to Australia, and on his way back stopped at Honolulu, where he enlisted in the navy June 3, 1898, and served throughout the Spanish-American war as chief petty officer on the U. S. S. Charleston, and later on the Brutus and Alava.

Discharged in New York August 29, 1901, he returned to Aledo, and there married Sarah Heaton June 17, 1903. In 1904 they went to Redding, Cal., from there to Oregon City, and from there to Enterprise, where they remained until 1920, when they came to Cottage Grove.

Besides the widow, three children survive. They are Mrs. Marshall Dresser, Hillsboro; Mrs. Charles Bonnett, Troutdale, and Robert O. Galloway, a son.

Mr. Galloway was an elder in the Presbyterian church, a member of the Masonic and Modern Woodmen lodges and a charter member of the local camp of United Spanish War veterans.

Funeral services will be conducted from the Mills chapel Friday afternoon at 2:30 o'clock by Rev. I. G. Shaw, pastor of the First Christian church. Interment will be at the A. F. & A. M. O. O. F. cemetery with the Masonic lodge in charge of the service, and the body will be laid to rest with military honors.

Jean Allison Given Coveted Appointment

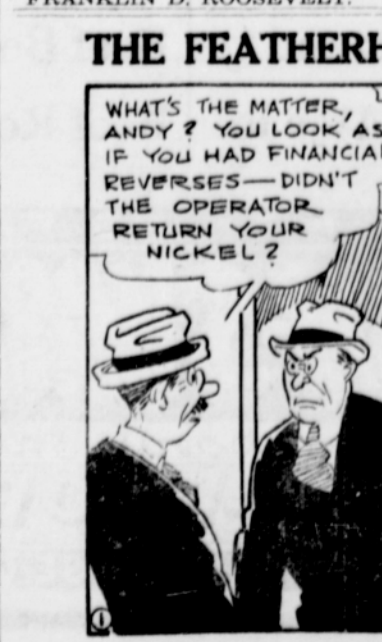

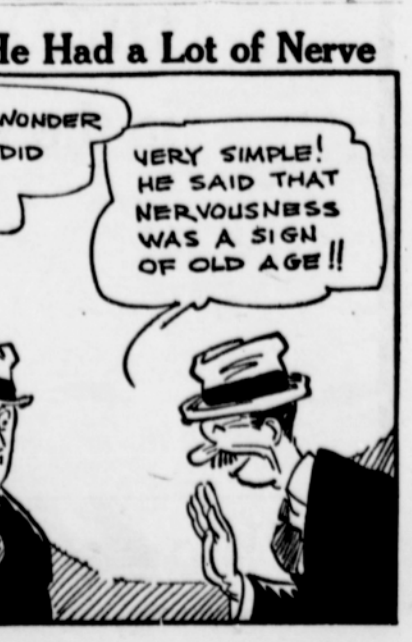
