The footprint of a strange amphibian that wallowed in the mud and vegetation covering Pennsylvania's anthracite region 245,000,000 years ago has been preserved for science. The discovery was made deep in the East Boston mine, some distance from the town of Luzerne, by Roland T. Bird, paleontologist for the American Museum of Natural History. "Amphibians such as left their imprint on the slab I found here," explained Bird, "were the first vertebrates able to leave the water and exist for any time on land."
