Static-Free Radio Nears

A new type of radio entertainment, virtually free from static and annoying interference, awaits only the advent of Frequency Modulation (FM) broadcasting on a nation-wide scale.

FM, the invention of Major Edwin H. Armstrong, was originally created to eliminate the static and background noises that so frequently interfere with Amplitude Modulation (AM) broadcasting. Its importance to the public lies in the fact that it offers vastly superior broadcasting service, according to an article in the May issue of Science Illustrated magazine.
