A SOLDIER'S DIARY.

(Continued from first page.)

tents that we were unable to lie down at all length. We were already so dirty and tired from our trip on the boat and train that we were pretty weak, mostly exhausted from the effects of our feed and rest. We had lived on travel rations from the time we left New York, July 6, 1918. We stayed here that night and the next day about 3 o'clock we marched to the dock and on our way to the dock we were greeted by the people as we went by and they applauded us as though they were glad to see us. We loaded onto a boat which was somewhat smaller than the Scotian but much speedier. It was well camouflaged by painting and was loaded pretty near the limit. At about 6:30 or 7 o'clock the boat pulled out for a chance to cross the English channel. We had a patrol of five sub chasers till we were well out and under way, then we fairly flew on the water. Where our patrol went I never knew. No one was allowed to light a match or cigarette or have any light of any kind at any time. It was quite dark on the boat and being so crowded for room, to walk around to keep from sleeping was almost impossible. The channel was very rough and our boat rocked considerably. The channel was protected for quite a ways out by nets, that is the entrance to the harbor. There were lots of sub. chasers and other means of protection at all times. We were harassed with those life belts. I think they were more of a nuisance than of any value. We landed at Le Havre, France, somewhere about 3 o'clock in the morning. Out boat tied up at the dock but no one was allowed to get off. We had lunch on the boat about 6 o'clock and at about 8 or 9 we were going down the gang plank once more. We marched down through the city on our way to another supposed-to-be rest camp. We marched four or five miles before we reached the place where we were supposed to have a rest. We arrived worn and weary, only to be chucked into some small tents. Eight men were placed in each of these little tents and the tents were so small that we could just barely lie down. When one turned over, all had to turn. We stayed there that night and the next day we cleaned up. We all took a steam bath and the next day in the morning we polished up the camp and about 2 o'clock we were on our way once more to the depot to take a 36-hour box car ride in the notorious pullmans used exclusively by the A. E. F., "8 cheveaux or 40 hommes." We were crammed into these cars to the tune of 36 to 40 and

room was so ample that only a few of us could lie down at a time to sleep while the rest stood up. It sure is a picnic to travel this way (I don't think). Of course, in the daytime we had lots of sightseeing to occupy our time which made us forget some of the tough features of the trip. At no time did we know where we were bound for, as we were traveling under sealed orders. We arrived at a little town called Meuse. From there we started the hike movement again, and again we could not seem to find out where we were going or how far we were from our place of billeting. At last (and a blessing was sent up by every man of the company and battalion) we arrived at a little peasant village and took up billets consisting of barns, woodsheds, hen houses, in fact anything or place that would afford shelter. We were all soaked to the skin and were up against it for a place to dry out. In fact, we were in that condition all the time we were in France until the end of the war, and conditions have not improved very much since. There is still need for improvement.

One very decided feature of our movements here is that it always rains when we move to a different place. When we marched from Meuse to Sarrey we were nearly "all in." The fact was that we had been living on traveling rations too long. Traveling rations consist mostly of corn meal and hard tack. We were all so sick of corned beef that we could hardly stare it in the face. Our packs were of the full pack nature and would make a government mule balk to think of carrying one. I should judge that they would weigh between 100 and 115 pounds. We stayed about two weeks in these billets at Sarrey. We were the first Americans to be billeted in that town and the people didn't know how to take us. They acted kind of shy but the longer we stayed there, and as we became acquainted, the more they became interested. They were of the peasant class and their mode of living and means of livelihood were as interesting to us as we were to them.

The first week we were there our subsistence was mainly coffee and bread and we were able to get a few potatoes of the French people. They were no larger than marbles. Our rations gradually picked up until we fared pretty well, but at their best they made far from a meal.

The French had erected some barracks of the knockdown type sometime early in the war but had never completed them, and as the government was at a much greater expense in the billets we were in, we moved into the others. They were located just at the edge of the village on the Nogent-Montigny road. A small stream of water ran by them in which we did our washing and took our baths. We took up our new work, also our combat tactics, and every man was in the harness and working as hard as he could. Our work was pushed to the limit. At first we worked 10-hour days, which was too much for the rations we were on, and our time was cut to eight hours. We practiced several evenings with the gas masks. We started by wearing them an hour at a time, then the time was increased to two hours and this got the goat of several of the boys. We all took the gas test at a little town called Chaufont. On a hill which rose considerably above the town was an old fort called Fort Dampierre. It is quite an old fort, built during Napoleon's time. I believe that the hottest weather I have witnessed was at Sarrey, where we did some very hard work.

One night about 8 o'clock, while we were out in front of our barracks after supper the same as usual, some cleaning their shoes and equipment, who should come along but the 316th sanitary train, and I began a search for Joe Smith and the boys and was lucky enough to see him. They were on their way to Nogent le Roi. I tried to get over there to see them again but never got a chance.

I was a runner of the first platoon and was out on problems to most of these towns about twice or three times a week. While we were in Sarrey we had rifle inspection every morning. We sure enjoyed that.

We had lots of fun while we were in Sarrey, with all of our troubles. We wore our tin lizzies, as we called them, all the time.

We left Sarrey on the way to the front unaware of the fact until about 2 o'clock in the afternoon of September 3. It was very hot that day, and we were to hike with our government load to a town called Chalindry, about 17 or 18 kilometers. It was so hot that many of the boys fell out. We didn't reach Chalindry until about 10 o'clock the next day. We were about nine hours on the hike. The first night we camped on a hill slope, fairly level in places, and we sure did appreciate our sleep in the dog tents that night. We struck tents after a 7:30 breakfast and were on our way again at about 8 o'clock.

We arrived at our destination and pitched tents in a stubble field just below the depot and at the edge of the town. We were given permission to go to town, which we did, of course—always curious to see the sights. If I remember right we were there three days and, of course, we had our usual amount of rain and camped on loose ground. We were in the mud up to our shoe tops most of the time.

We left Chalindry at about 1 in the morning for Demange. It was another of those box car rides, but we were not long on the train, so we managed fairly well. We arrived at Demange about 3 o'clock in the afternoon and went into billets there. We all took a bath in the canal and we were also out on a problem and were taken through some trenches and saw wire entanglements like those we were likely to encounter on the battlefield. We were in Demange about three days and then we hiked all night till nearly morning. We halted in a small woods and slept till about noon, then picked up and retreated to a little village and stacked arms in a field just at the edge of the burg and had a hot lunch, mostly beans and coffee. Then we hiked to a hill just a short distance from Void. We staid on that hill for three days. It was covered by brush and an occasional tree or two. How it rained while we were there—it rained so hard one day it nearly put out the fires in the field ranges.
