C. G. AND EUGENE TO MIX IN PRO-CHAMPIONSHIP BALL GAME

Contest on Local Grounds Next Sunday Promises to Be the Hottest One of the Season.

The undefeated Cottage Grove baseball team will meet the Eugene team on the local grounds Sunday afternoon. The visiting team has been defeated but once. Not only has Cottage Grove not been defeated this year but it has slaughtered all opponents who have appeared with scores so lopsided that the boys almost felt ashamed of themselves. The last game was a 16 to 0 one with Yoncalla. The locals propose to win the contest Sunday and then take on the undefeated Albany team for the valley championship. The cocky Brownsville team, which was claiming the championship, has been defeated by the unvanquished Albany team.

The game Sunday is certain to be a real exhibition of the great national sport, as the visitors have some reputation as horseshoe pounders, although they never have been victorious on the Cottage Grove grounds and the locals propose that the game Sunday shall be a repetition of the old, old story.

Cellers, who has had a picnic on the mound so far this season, is planning on letting himself out a little and with King on the receiving end the battery will be one that will not give the other players many chances for errors. The locals will have the strongest lineup they have ever put on the diamond this season and she is going to be a real match from the time the first ball goes over the plate.

The game will be called at 2:30.

The husband and the little babe survive.

Years of Suffering End in Death.

Charles M. Henderer, a well known pioneer of Douglas county, who had been a paralytic for 10 years and bed-ridden for six months, died Wednesday evening at his home here, that day being the thirty-seventh anniversary of his marriage. The funeral will be held at 10 o'clock Friday, Rev. Joseph Knotts officiating.

Mr. Henderer was born at Elkton, Douglas county, June 6, 1862, and for a number of years operated a large farm near Leona. Twenty-two years ago he was in the livery business here. He had been a member of the Odd Fellows lodge for 27 years. L. S. Dimick, who nursed Mr. Henderer during his last illness, had been a schoolmate and lifelong friend. Surviving relatives are the wife, a brother, John, of Elkton, a sister, Mrs. J. M. Hedden, of Scottsburg, and the following children: Will, of Leona; John, of Springfield, and Flem, of Leona.

Mrs. J. K. Palmer Dies.

Mrs. J. K. Palmer, for many years a resident of this city, died Sunday at Los Angeles while visiting her daughter, Mrs. J. A. Stevens. The body will arrive here Friday and the funeral will be held Saturday, probably in the forenoon, Rev. Walter Callison officiating. Mrs. Palmer's maiden name was Hannah Teague. She was born at Madisonville, Ky., and was 72 years of age. She had been a resident of Oregon 17 years. Surviving children are Mrs. J. A. Stevens, Los Angeles; Mrs. L. S. Gouley, Los Angeles; Mrs. J. B. Protzman, Salem; Mrs. J. H. Brown, Salem, and J. R. Palmer, of Los Angeles.

FIRST NATIONAL BANK'S DEPOSITS PASS HALF MILLION MARK

The latest report of the First National shows deposits of over half a million, an increase of over \$25,000 over the last previous report. The Bank of Cottage Grove has enjoyed an increase in deposits of \$17,000, making a total increase of over \$42,000 for the city.

HOME MADE AMBER FLUID GETS MAKERS INTO LAW'S TOILS

Sheriff Stickle Does House Breaking Stunt at the Home of G. B. Hansard.

Two Cottage Grove men figured in a booze raid Thursday of last week. A large quantity of home-made beer was found at the home of G. B. Hansard and seven bottles of the same amber fluid were found at the home of Charles Valentine. A preliminary hearing was held in Judge Young's court, when Hansard was put under bonds of \$200 and Valentine was allowed his liberty on his own recognizance.

The case came on for hearing yesterday before Judge Young, when pleas of guilty were entered. A fine of \$250 was imposed upon Hansard and \$10 upon Valentine. There was no evidence that Valentine had sold any of the thirst-quencher, but it is said that Hansard had done quite a business and that he has several times previously been convicted of bootlegging.

In the case of Hansard Sheriff Stickle, who made the raid at the suggestion of Deputy Pitcher, had to break into the Hansard home. The sheriff rapped at the front door while District Attorney Ray and Deputy Pitcher went to the rear door. No one answered the rapping on the front door but the sheriff, peering through a window, saw Hansard pouring something out of some bottles. The sheriff then broke the sash out of a window and entered. Hansard left the house by some means, probably through another window, as the officers in the rear did not see him, and ran out through an alley into a vacant house where he was afterward found.

Hansard accompanied the sheriff back to his home where a lot of the home-made brew in bottles was found. Hansard refused at first to unlock a store room where it was suspected that some more of the liquor was hidden, but when the sheriff picked up an ax to break open the door the owner unlocked it and revealed a lot more of the concoction.

E. B. Crane Goes to British Columbia.
E. B. Crane, manager of the quicksilver mines at Black Butte, who had been away for some time, was in the city Tuesday after having closed affairs at the mines temporarily. He will go to British Columbia and Mrs. Crane and daughter have gone to Magnolia Beach, Wash., for the summer. Before leaving Mr. Crane stated that the mines would be reopened whenever the market became stabilized at \$100 or better a flask for the 'quick.' The price dropped below \$50 but has again gone up to \$95.

Automobiles Collide.

Eugene Register, July 5: Two automobiles, a Ford and a Chevrolet, collided with a crash at the intersection of Eighth avenue west and Olive street yesterday morning about 8:15 o'clock. Two wheels of the Ford were demolished and one wheel of the Chevrolet was knocked off. W. M. Hamilton, of Cottage Grove, was driving the Ford and in his car were his wife and his daughters, Levey and Electa, while the other car was driven by Fred Speer, of Milwaukee, Oregon, who was accompanied by Earl Chapman, of Santa Clara.

Dogs and Porcupines Mix.

Several dogs belonging to Leslie Grost are said to have come off second best in a contest with a porcupine, one of the animals dying from the wounds and all of the dogs suffering severely from injuries inflicted by the quills of the 'porky.' The porcupine is a rare animal in this section and the oldest inhabitants can remember of but two or three ever being found.

At least one bet on the Willard-Dempsey fight has not been paid and there is some doubt as to whether it ever will be paid. The winner has some objection, it seems, to taking his winning. The bet was between "King" George Elwood, barber, and Andrew Brund, grocer. The wager was a shave and a haircut. Mr. Brund lost and promptly offered to remove from the face and dome of Mr. Elwood whatever hirsute adornment he might find there but refused to make any guarantee against any damages that might result. Having in his mind a vivid picture of how Willard looked after the fight, Elwood has discreetly maintained that the bet was for the price of a shave and haircut and not for the actual delivery of the goods.

OATS HAVE INDICATION OF GOING 100 BUSHELS TO THE ACRE

Samples of oats that are oats were brought into the city Monday by S. K. Lewis. From their appearance they might yield 100 bushels to the acre. The stalks, which look like young corn stalks, are needed to hold up the heavy heads. The grains are almost too large for the hulls. Mr. Lewis is not certain of the variety but says that as near as he can learn they are the Canadian Side. Some years ago he bought some size of another variety. He carefully reserved this for seed and has continued resowing until now he has an eighth of an acre. He thinks he will be able to sow the whole country next year.

SAYS WICKS CROWDED HIM

D. H. Benedict Determined Offender Shall Suffer for Traffic Violation.

Roland Wicks, of Star, figures in probably the first prosecution in Lake county for so-called hogging of the road. D. H. Benedict is the complainant and he charges that the Wicks car crowded his car off the road near a railroad crossing near Saginaw, that his car went over the embankment, that occupants of the car were injured and that Wicks did not wait to give assistance after making inquiries was needed. The complainant himself is said to have sustained a wrenched back.

Wicks has appeared in the justice court in Eugene and says he was not to blame for the other man running off the grade, that he ran off before the two cars met.

THOUSANDS COME HERE TO HELP CELEBRATE NATAL DAY

Beautiful Parade, Fine Patriotic Address, Boxing, Baseball, Music and Fireworks on the Bill.

With at least 3000 people in attendance, probably the largest crowd ever assembled here, Cottage Grove celebrated the Fourth of July and the return of the soldiers and sailors in style and with eclat, whatever that is. The big day started with one of the best parades ever seen here. While there were not as many floats as have before been entered, the quality was superior.

Floats Are Beautiful.

Probably the most expensive float was that by Humphrey & Mackin, which carried off first prize in the business house division. Helliwell, Bangs & Marksbury carried off second prize. Judged solely from a standpoint of beauty, the three floats by women's clubs probably formed the prettiest division. First honors were taken by the M. P. G. club and second by the Constellation club, although the LeComus club float was the cause of much comment and was thought certain to win one of the prizes.

In the decorated automobiles the B. S. Swengel car took first prize and the A. B. Wood car second. The Swengel car was a very pretty creation. J. A. Wright had intended his automobile to be entered as a private car but through some error it was put in the business division and thus probably missed a prize.

In the civics division the fire department took first prize with a decorated hose cart and the Endeavor of the Christian church second with a very elaborate creation.

NO APPARENT REASON FOR FALL OF TREE WHICH BRINGS DEATH

With no explanation of any kind for the accident, George R. Sanders was instantly killed near Leona about 4 o'clock Wednesday afternoon while dragging logs with a team for the Leona mills. He had stopped to remove a dead snag from the skidway when a live tree toppled over onto him, killing him instantly, after which he was trampled by the horses which were struck by the branches and became frightened. An investigation revealed no reason for the fall of the tree. The funeral will be held Friday at the Leona cemetery. A wife and eight children survive.

Teachers Elected and Assigned.

Miss Lillian Leonard has been elected to teach the east side third grade, Miss Hilda Harden has been reassigned to the east side second grade, Miss Nora Queen has been assigned to the west side third and fourth grades and Miss Eva Hopper has been assigned to the west side first and second grades. Miss Jessie Smith has been elected to the east side primary but it is understood that she will not accept. Miss Georgia Kinsey has tendered her resignation as a member of the high school faculty.

The school board has adopted 75 per cent as the lowest passing grade in any grade. This is done with the idea of raising the standard of graduates.

McKenzie Pass Now Open.

The McKenzie pass, at the summit of the Cascade mountains, is now open for automobile traffic, according to Smith Taylor, forest ranger stationed at McKenzie Bridge. He telephoned today that six cars came over the pass Friday from east of the mountains, the occupants shoveling the snow out of the road so that the cars could get on this side.

The present hot weather is expected to melt a great deal of the snow and on that account no trouble is anticipated in crossing the summit hereafter.

Elwyn McCargar Is Home.

Elwyn McCargar, recently of the 12th aero squadron, is one of the latest arrivals from France and the last of the three McCargar boys to arrive home. He reached here Sunday. Elwyn served five months in the army of occupation in Germany and did considerable flying.

Eugene Guard Gives Fight Returns.

Through the courtesy of the Eugene Guard Cottage Grove was able to get the returns on the Willard-Dempsey fight almost as soon as they were received in Eugene. The news was telephoned here by rounds and was megaphoned to the interested Fourth of July crowds.

Victory Bond Payments Due.

The second payment on Victory bonds for those who took them on the installment plan is due July 15. The banks have the bonds on hand for delivery whenever payments are completed. They report that many are paying in full and taking their government securities with them.

PACKED PRODUCT DEMAND GREATEST IN HISTORY OF INSTITUTION

Gooseberries Already Sold and Shipped and Contract Offered for Pack of the Coming Season.

The bearish condition of the canned goods market is indicated by the fact that the Cottage Grove cannery has already sold and shipped this year's pack of gooseberries and has so far declined to sign contracts that would clean up their pack of all products for the year. The plant is now running on loganberries and cherries. The price being paid in cash is 8 cents for loganberries, 7 cents for white cherries, 6 cents for black cherries and 4 cents for sour cherries, which prices are far in excess of any that have heretofore been paid. All of last year's pack has been cleaned up with the exception of 20 cases of plums.

There were 90 cases of the No. 10 cans in the shipment of gooseberries. The receipts of loganberries and cherries have not been large but are far in excess of expectations.

FIRE TAKES FARM HOME CHINA TEAPOT SAVED

The farm home and buildings of G. A. Cavanaugh, on Mosby creek, were completely destroyed by fire Tuesday afternoon. There was a small amount of insurance. The fire is supposed to have started from a flue in the house. While Mr. Cavanaugh was endeavoring to save a few things from the house, the barn, containing 20 tons of hay which had just been put in and almost all the farm machinery, caught from flying cinders. A large quantity of valuable china was destroyed but one china teapot which Mrs. Cavanaugh valued highly was found after the fire on top of the smoldering ruins apparently none the worse for the experience. Mr. Cavanaugh's clothes caught fire several times but were extinguished before he was injured.

Mrs. McKibben has been a resident of Oregon 32 years.
