REVOLT OVERTHROWS EBERT GOVERNMENT

Ousted Party Calls Strike to Save Germany From Return of ex-Kaiser William.

Berlin.—The government of President Ebert, first president of the German republic, was overthrown by revolutionary troops, presumably as part of an extensive reactionary plot, on Saturday. The revolutionists, apparently working on carefully laid plans, issued a proclamation naming Dr. Wolfgang von Kapp, president of the fatherland party, chancellor of Germany and premier of Prussia.

Major General Baron von Luettwitz, former military governor of Belgium, was named minister of defense, replacing Noske.

Friedrich Ebert, president of the old government, who with most of his ministers hastily withdrew from Berlin when the revolting troops marched in and Kapp and Von Luettwitz took control, is reported to be at Stuttgart, and from this point of security is calling upon the socialists and working classes generally to stand by the old government and use the strike weapon so that the counter-revolution may be promptly suppressed.

In response to this appeal a general strike has been proclaimed in many places, but in other parts of Germany the call for a strike has not been received with favor.

While adherence to the new government has been promised by some of the outside states, Saxony has declared against it, and Bavaria, Wurtemberg and Baden have joined in denouncing the movement.

With the general strike proclaimed throughout Germany by the independent socialists, affiliated with the trade unions and other organizations, Berlin already is beginning to feel the pinch of suffering again. The water supply has been largely cut off and food is scarce. Hotels are shutting down, and if the strike continues means of transportation will be at an end.

Stuttgart.—Refusal to negotiate with the reactionary faction headed by Dr. Wolfgang Kapp, head of the new government at Berlin, was decided upon here by the council of the old cabinet, over which President Ebert presided. Unconditional resignation of the leaders of the new government was demanded by the Ebert cabinet, which arrived by a special train from Dresden.

14,000 SOLDIERS NOW IN GERMANY

Washington.—There are approximately 14,000 soldiers now in German territory. It was stated at the war department, and these forces are under the supreme command of Marshal Foch, under the terms of the armistice.

The American army of occupation numbers 85,000 men, under the command of Major General Henry T. Allen, and there are 6000 additional troops under Brigadier General William H. Sage, sent into German territory to supervise the Silesian plebiscite.

It was the opinion of officials that American or allied forces could not be used unless the German revolutionists should take steps which threatened violation of the terms under which the allied forces of occupation are in Germany.

REVOLUTION NO SURPRISE

Test of Strength of German Factions Long Held Inevitable.

Washington.—News of the revolution in Germany sustained the conviction of some officials and diplomats here that a test of strength between the socialists and the military and conservative elements was inevitable.

They said the military and conservative parties had seized upon every demand of the entente for the enforcement of the armistice and peace terms to goad the pride of the German people into resistance and had not found it difficult to fasten responsibility for acceptance of these terms on the Ebert government.

Income Taxes Stolen by Two.
Seattle, Wash.—Two unmasked men held up R. E. Stafford, cashier in the internal revenue collector's office in the Federal building at 7:15 a. m. Tuesday, forcing him at the point of a gun to open the office safe and robbed the strong box of \$20,000 in currency, and escaped. The money was taken in by the office during the last minute income tax rush.

General Wood Leads in Minnesota.
St. Paul, Minn.—Major General Leonard Wood has a large lead over Senator Hiram Johnson and Governor Frank O. Lowden, returns from Minnesota's republican preferential primary indicated.

ADRIATIC PROPOSAL IS PARTLY ACCEPTED

President Outlines Basis For Settlement but Objects to Treaty of London.

Washington.—President Wilson accepts with reservations the proposal of the British and French premiers that Italy and Jugo-Slavia undertake a settlement of the Adriatic question. He says that if Italy and Jugo-Slavia prefer to abandon the so-called buffer state containing an overwhelming majority of Jugo-Slavs and desire to limit the proposed free state to the corpus separatum of Fiume, placing the sovereignty in the league of nations without either Italian or Jugo-Slav control, the United States is willing to leave the determination of the common frontier to Italy and Jugo-Slavia.

The president says he "cannot possibly join" the premiers' suggestion that the memorandum settlement of December 9 be withdrawn; declares that "Albanian questions should not be included in the proposed joint discussions," and reiterates that the United States cannot approve of the execution of the terms of the treaty of London.

Finally, he expressed the "earnest hope that the allied governments will not find it necessary to decide on a course which the American government, in accordance with its reiterated statement will be unable to follow."

The president's note to the premiers is now being considered by the allied supreme council at London. Meantime, direct negotiations between Jugo-Slavia and Italy are proceeding.

HOUSE FAILS TO PLACE AIR BLAME

Washington.—After four hours' discussion of American aviation efforts during the war, the house, sitting as a committee, reported to the whole house that it "had come to no resolution" on the conflicting reports of the special investigating committee made after prolonged inquiry into the air program and its results.

Even this announcement by the committee of the whole did not pass unchallenged, republicans and democrats disagreeing as sharply as they had during debate on the investigating committee reports. The disposition made, however, was true to the program of republican leaders. Their spokesmen declared the only purpose was to make known the facts of the wartime aviation "failure."

Democratic speakers pictured American aviation efforts a "success" that gave the allies predominance of the air. Such "mistakes" as were admitted by these speakers were said to be only what were to be expected in so novel and gigantic an enterprise.

HOUSEWIFE HAS REMEDY

Meat Prices Can Be Reduced By Careful Buying.

Washington.—Plans for reducing the American family's meat bill were announced by the department of justice, which will urge housewives to turn from the high-priced cuts to less costly portions of the steer.

Fair price commissioners in every state will be asked to direct an educational campaign, with the co-operation of retailers, wholesalers and packing companies and the department will undertake to see to it that the consumer receives good meat at low prices and that no abnormal profits are taken on the lower priced portions.

"The housewife holds in her own hand the remedy for very high meat prices," said the department's announcement. "By turning from the expensive to the inexpensive cuts she not only will lower her own meat bills, but will drive down the price of the choice cuts."

NATION LOSES REVENUE

Supreme Court Rules Stock Dividends Untaxable.

Washington.—Corporation dividends distributed as stock do not constitute "income" and are not subject to federal income taxes, the supreme court decided in a five-to-four decision.

Provisions of the 1916 federal income tax law levying taxes on stock dividends were declared unconstitutional. The decision also nullified similar provisions of the present law and will involve great loss in revenues to the government and refunds of such taxes already collected.

Unionizing is Barred by Canada.
Ottawa, Ont.—The right of employees of the dominion government to join labor unions was denied in a letter sent by the cabinet to the dominion trades and labor congress.

Wilson Rides in Open Automobile.
Washington.—President Wilson went riding Monday in an open automobile.
