McREYNOLDS CAR 7 OF IS CAUGHT AT E' NE

Car Had Been Taken to Portland and Left for Sale; Ruse Is Used to Catch Guilty One.

The thief who stole the Dort car belonging to Kenneth McReynolds, of this city, has been captured through a clever ruse on the part of the officers. Glen Chamberlain, of Eugene, is the man charged with the crime, instead of the two young men from eastern Oregon, who were at first suspected.

The car was taken to Portland a few days after it was stolen and placed in a garage there, Chamberlain instructing the proprietor to sell it for him if possible. When Deputy Sheriff Croner was in Portland a few days later he discovered the stolen car in the garage and a plan to catch the thief was arranged. Chamberlain, who told the garage owner that his name was McReynolds, had left word to wire him in care of the Western Union telegraph office in Eugene if a buyer for the car appeared. A message was sent to the effect that the car was sold and that \$900 was received for it. Chamberlain gave instructions to send the money by wire. Croner secreted himself in a rear room of the telegraph office and when Chamberlain appeared for his money Croner emerged from his hiding place and placed him under arrest.

Mr. McReynolds arrived home with his car last week. He found that it had had hard usage, one tire being gone and the windshield broken.

Chamberlain, who is 17 years of age, has been paroled to his parents, the conditions of the parole being that he shall work for a year for his father in his sawmill or logging camp; that he shall pay all damages incurred to the automobile he stole; reimburse the county for the expense it went to in effecting his arrest, write to the juvenile officer one each week, telling what he has been working at and regarding his actions; must go to Sunday school if his mother tells him to. He is not to be seen on the streets of Eugene during his parole, except when accompanied by his parents.

SWISSHOME CALF BEATS COTTAGE GROVE VEAL BY FOUR POUNDS

A Swisshome woman would take from Mrs. M. E. McFarland, of this city, the honor of raising the largest veal calf. A story recently appeared in The Sentinel stating that Mrs. McFarland had raised a calf that weighed 113 pounds, sold for \$27 and netted \$24.93. Mrs. G. A. Brooks, of Swisshome, writes that she raised a calf which weighed 117 pounds, sold at 24 1/2 cents a pound, brought \$28.67 and netted her \$24.68. Her calf was also half Jersey and half Holstein and was also raised by Nature's own method.

COTTAGE GROVE HAS MAN ON TICKET FOR ASSEMBLY

Says What He Thinks and Does What He Says, Is Slogan.

Cottage Grove has a candidate for one of the three positions in the lower house of the Oregon assembly to which Lane county is entitled, Elbert Bede being the last one from this county to file and one of the last in the state.

The only information given in his declaration filed with the secretary of state as to what he intends to do, in case of election, is in the slogan to be printed after his name, "Says what he thinks and does what he says."

The other candidates are S. D. Allen, L. E. Bean and W. T. Jordan, of Eugene, and H. C. Wheeler, of Pleasant Hill.

MANY WOMEN GET REWARD FOR RED CROSS WAR WORK

Service certificates have been received at the Eugene Red Cross rooms for many members of Lane county who did Red Cross work during the war. These certificates are given by the National American Red Cross society to every person who did at least 800 hours of war work in the rooms of their local chapter during the period that the United States was engaged in the world war. LEGION WARNS PUBLIC AGAINST HOMESTEADS

Seattle, Wash., April 14.—Branding as worthless western Oregon homesteads announced as open to entry by ex-service men, the Elmer J. Noble post of the American Legion has made public a resolution warning war veterans against attempting to homestead these lands.

"Many disabled ex-service men have already gone down to Oregon," declared W. P. Wise, of Noble post. "We are attempting to discourage others from following their example. The American Legion posts in Medford and Portland have announced that the land left open to the service men is practically worthless."

GRANGE SELLS QUILT FOR BENEFIT OF ARMENIAN FUND

The quilt made by the women members of Cottage Grove grange was disposed of Saturday by selling numbers, which amounted to \$10, the proceeds to go to the Armenian relief fund. Emmett Sharp was the winner and, realizing the great need of help in this worthy cause, returned the quilt to be sold again for the same purpose.

POTATOES ONCE 10 CENTS THE HUNDRED NOW 10 CENTS POUND

The prevailing price of 10 cents a pound for potatoes reminds producers in this section of a time about seven years ago when spuds were a drug on the local market at 25 cents the hundred and large quantities were sold for as low as 10 cents the hundred. Many who had large sockets found it more profitable at that time to use potatoes for fertilizer than to attempt to sell them. A person who would now make such use of spuds would be likely to be sent to a federal penitentiary.

One of the storekeepers of the city relates that a frugal housewife sent one of her children to his store a few days ago for 25 cents' worth of tubers. On the way home the child dropped the package, the three potatoes dropped through a crack in the sidewalk and were lost in the grass under the walk. Housewives in many cities are organizing to boycott the potato. No such action has yet been taken here but indications are that the price at which they are being sold will serve the same purpose.

ROAD BONDS DRAW FIRE OF GRANGE SPEAKERS

Ben Keeney Pays Compliments to Bond Boosters and Hangs Hides on Walls of Hall.

If there were any friends of the proposed two-million-dollar road bond issue present at the meeting of Cottage Grove grange Saturday afternoon they failed to voice their sentiments.

C. P. Barnard, candidate for the republican nomination for county judge, took the pamphlet issued by the Lane County Good Roads association and characterized many of the statements therein as grossly misleading. He said in part:

"The table given states that the amount of taxes that will be required to meet the bonds will average \$1.07 for each \$1000 of assessed valuation, but this figure is arrived at after deducting what it is anticipated the county will receive from automobile license fees. This is an unfair method. We will receive these license fees regardless of whether or not we vote these bonds and the bonds themselves will require a tax of \$3.51 on the thousand. There is no other fair way to figure it. I also find many discrepancies in the figures given as to the probable costs of construction of roads laid out in the program. For the same classes of road to be laid under practically the same conditions we find widely divergent figures as to the probable cost. I have raised no objections to the state issuing bonds that will be taken up entirely by auto license fees. We had to have through highways built of permanent material and there was no other way to get them, but there is at this time no emergency sufficient to make necessary the issuing of such a vast amount in county bonds for county roads. It is unfair to the educational millage bills to put this proposition on the ballot at the same time. We would be just as far ahead by waiting for the fall election. Under this proposed bond issue we will build roads at the highest price paid for roads in the history of the country and we will be compelled to take up the bonds under a much lower wage level. Don't worry about the county court holding up any of the money for the cost of road building to decline. With the money available the county court is going to be importuned by the people of the county until they can't refuse to spend it."

Emmett Sharp, one of the two candidates from here for the county commissionership, emphasized his belief that if given assistance by one other member of the county court he would be able to carry out the economy program outlined in his platform.

Ben F. Keeney, former county assessor, who is something of a real orator, flayed the proponents of the bond issue and hung their hides up on the walls, where he used said hides to draw diagrams of what the bond issue would mean in extravagance and the increase in taxation. Mr. Keeney has a letter elsewhere which covers the points made in his speech.

M. Svarverud, of Eugene, spoke briefly and said that the county had in the past overcome many obstacles and was not the laggard in road building that many would have us believe. He characterized the proposed bond issue as crazy finance.

S. D. Allen, of Eugene, candidate for the legislature, urged keeping taxes down so that people could afford to own homes. "With the laboring man owning his home we need have no fear of bolshevism or I. W. Wism."

Mrs. Beebe Writes From Germany. Lieutenant and Mrs. L. C. Beebe are now stationed at Bendorf, Germany. Mrs. Beebe has gone back to his permanent rank of a first lieutenant. "It was quite a shock," Mrs. Beebe says, "to some of the colonels and majors to go back to lieutenantcies and captaincies. We have a lonely billet in the home of the wealthiest people in the town, three large rooms on the ground floor. There is a nice yard all around the house, so Wallace has a good place to play. Next week end we expect to spend in Wiesbaden and the week after in Cologne. As soon as we can get a real good leave, we plan to go to Switzerland and Italy. That probably will be in May. We have no idea how long we will be here but I'm in love with this country and hope we don't return to the states before fall anyway." Mrs. Beebe was back in Portland for a brief visit at the time of the death of her mother.

CHAUTAUQUA PROGRAM IS HUMMER FOR 1920

Dr. Ng Poon Chew, Brilliant Celestial, Is Biggest Number of Strong Lecture Program.

The first announcement of the 1920 chautauqua program indicates that the attractions to be presented are of the same high standard which has characterized Ellison-White programs in the past. Music, lecture and entertainment lovers apparently have much in store for them during the week of May 28-June 2, the chautauqua dates for Cottage Grove.

A lecture of unusual importance is announced in the coming of Ng Poon Chew, probably the most brilliant man of the Chinese race in America. Dr. Chew is editor of the first Chinese daily established in this country, is vice-president of the China Mail S. S. company, and is widely known as a statesman, orator and humorist. He will speak on a subject of vital interest to Pacific coast audiences, "China's Problems, National and International."

Other lecturers of prominence are James A. Burns, president of Onondaga Institute, nationally known as "Burns of the Mountains"; Sam Grathwell, inspirational lecturer; Evelyn Bargell, of the Chicago Art Institute, lecturer, cartoonist and entertainer, last year with the American expeditionary forces in France; Kate Upson Clark, noted editor and author, and Captain T. Dinmore Upton, one of the country's principal authorities on recreation for boys and girls.

The music of the week promises much to the music lovers of this community. On the first day Williams' Male Quartet comes in two concerts. On the second day the New York Artists' Trio will present two programs of unusual musical merit. On the third day the Morrison Girls are coming.

The musical climax of the week comes on the fourth day in the two big concerts by Taylor's Singing Band, an organization of American musicians featuring both vocal and instrumental music. With the singing band comes Tom Corwin, prince of entertainers, in two short programs of genuine fun. On the fifth day the J. Walter Wilson company will appear in afternoon and evening preludes with programs of splendid musical entertainment.

The last day brings a feature musical attraction in the Royal Philippine Sextet, a stringed orchestra of native musicians which is rated as one of the best musical organizations from the Islands.

PAPER PRICE UP; ADS AND NEWS CURTAILED

Expense of Getting Out Paper Makes It Imperative That All Subscriptions Be Paid.

Continued advances in the price of print paper make it imperative that every paper conserve that commodity and are likely to make necessary still further advances in subscription prices. Hardly a week passes in which The Sentinel is not compelled to leave out advertising and news because it does not feel justified in using the extra paper which would be required for its publication. Last week three columns of advertising and three columns of news were omitted for this reason.

It has become immediately imperative that no papers be sent to anyone who allows his subscription to get in arrears. The Sentinel can not, at prices which it now has to pay for material, send the paper to any but those who are paid in advance. Due notice of expiration of subscription will be given a week before papers are stopped.

Subscribers are likely to profit by paying a year or so ahead, as an advance in subscription price is likely to occur at any moment.

Obituary. Gavin Davidson died at the age of 86 years, April 5, 1920, at Innisfail, Alta., Can., where the funeral was held. Mr. Davidson was born in County Down, Ireland, and moved in his early twenties to Canada, where he married and settled near London, Ont., farming there for about 25 years. Failing health caused him to move to Tennessee and a few years later he came to Oregon, locating near Cottage Grove, where he resumed his farming, retiring a few years ago.

A desire to be near his grandchildren took him to Innisfail, Can., in September of last year. His death was caused by complications following grip.

Three daughters and three grandchildren survive him, his wife having died six years ago. The daughters are Mrs. T. Richardson, Cottage Grove, Ore., and Miss Janet Davidson and Mrs. E. E. Miller, of Innisfail, Can. Mr. Davidson was converted early in life and united with the Presbyterian church, remaining a faithful member until death.

WHY ONLY ONE VICTIM OF LAW, IS ASKED

Many Cases of Lack of Judgment, Carelessness and Defiance of Law Reported.

A resident of Cottage Grove, who believes in the enforcement of the traffic regulations, has asked The Sentinel why it is that only one person has so far been made an example of by the arm of the law. The Sentinel will not attempt to answer the interrogation. It feels its duty to be to create public sentiment for the enforcement of the law and trusts to the officers of the law to see that all traffic violators are arrested. Up to this date it seems that the enforcement of the law has not progressed very far.

Fred Anderson, who was bringing one of the hose carts back from the Cooper fire Thursday evening of last week, reports an instance of the little judgment used by some. As he approached the intersection of Main and Sixth, a car made the turn there and came directly in front of him with so little warning that he had to skid the wheels of the truck he was driving in order to prevent a collision. Mr. Anderson thinks the car was one from Creswell.

A person can hardly walk down the street any time of the day without observing lack of judgment and carelessness in the operation of motor vehicles and in many cases actual defiance of law and common sense.

STEALING OF Eatables BECOMING OBNOXIOUS

Some folks are getting pretty sore about what some other folks may consider playful little jokes, and some of the latter are threatened with an opportunity to consider whether or not it is a joke to be locked up where they will have no opportunity to pull their funny stunts. The joke takes the form of stealing refreshments provided for social affairs. The most recent stunt of this kind was pulled Friday night at the M. P. G. party in Moose hall. While the party was in progress and while people were passing in and out of the hall, all the cakes and cookies were stolen from the kitchen, the theft being discovered when it came time to serve refreshments. Some young lads who were informed that the party was a private one and that their company was not necessary are thought to have some first-hand inside knowledge of where the eatables went to.

C. G. INTERCHURCH QUOTA LARGELY SUBSCRIBED

Committee Will Call on Friendly Non-Church Members to Complete Amount to Be Raised Here.

Although the official campaign for funds for the Interchurch World Movement is to be conducted during the week of April 25 to May 2, the local churches already have subscribed \$7500 of the \$9000 quota for this district and expect to have the entire quota subscribed before the end of the official campaign.

The national quota is \$336,777.572. The local committee expects to canvass all friendly citizens of this section who are not members of any church or who are not contributing to any church. The city proper has been platted into districts and the canvassing teams will meet tonight. Meetings to explain the movement are being arranged for 3 p. m. Sunday at Dorena and 4 p. m. of the same day at Row River. Other communities may be visited later.

THREE THOUSAND BABY CHICKS HATCHED IN ONE DAY

Bert Hands reports what is probably the largest hatch of chickens ever recorded in Cottage Grove on one day, when 3000 fluffy White Leghorn chicks pecked their way to a full enjoyment of the salubrious Oregon ozone.

The "settings" were purposely arranged so that the hatching would occur as near the same day as possible.

Hunters Shoot Calf.

W. B. Osmond, who has a place near the Lorane mountain, reports that a calf belonging to him was shot Sunday by some hunters, who reported the accident to the owner but it was not until the calf was brought into the barn that it showed the serious effect of the injury. Mr. Osmond was in the city Monday to arrange a settlement with the hunters, who said that the shooting of the calf resulted from a belief that it was a wild animal.

Carrying His Nose in a Sling.

Otto Bureham is carrying his nose around in a sling, as the result of an accident which resulted in serious injury to the olfactory organ. He was employed at the camp of the U. S. Logging company at Rajada and was clearing away underbrush when a small maple flew up and slapped him in the face, causing the injury.

W. B. COOPERS FIND ROAST CHICKEN AWAITING ARRIVAL HOME

When Mr. and Mrs. W. B. Cooper arrived home Thursday night of last week from a trip to the north they found that in anticipation of their arrival 30 of their White Leghorn chicks had been roasted. Such energy had been injected into the preparation of the feast that the fire department was called out to hold in check the flames that were destroying the chicken house and threatened to spread to other buildings.

It is presumed that the flames started from an oil stove being used to keep the temperature of the chicken house such as would best conduce to the comfort of the chickens.

Mr. and Mrs. Cooper would have been home in time to help extinguish the flames except that they got a punctured tire and also had difficulty in getting out of a mudhole near Monroe. They had been away for the day and their daughters, Dorothy and Charlotte, were alone at the time of the fire.

BOND ELECTION PETITION IS FILED ON TIME

County Court Asked to Submit to the Voters Proposition for \$2,000,000 for County Road Work.

The petition asking the Lane county court to call a special election May 21 for the purpose of submitting to the voters of the county the question of issuing \$2,000,000 bonds for the construction of roads was filed in the office of the county clerk Saturday. The petition contained 1650 names.

According to the petition the bonds, if voted, are to run for a period of 25 years, bearing interest not to exceed five per cent per annum and to be redeemed one-twentieth annually at the end of the fifth year from the date of issue. The petition designates the roads in various parts of the county to be improved and states that not more than \$500,000 of the bonds are to be issued in a single year.

The roads designated in the petition to be improved are as follows:

Springfield to Lowell via the Mount Vernon school house in school district No. 18, \$25,000.

Thurston to Blue river, \$50,000.

Hayden's bridge, on the McKenzie river, to Wendling, \$81,000.

Hayden's bridge, on the McKenzie river, to the intersection of county road No. 528 with the McKenzie river highway one mile west of Walthersville, \$30,000.

Armitage station, on the Southern Pacific, Woodburn-Springfield railroad, to the northern boundary of Lane county in section 12, township 16 S., R. 4 W., via Coburg and the River road, \$64,000.

Junction City to the ferry at Harrisburg, \$21,000.

Eugene to Junction City via Irving, \$77,000.

Lorane P. O. to the mouth of Wildcat creek, \$25,000.

From the mouth of Wildcat creek to Cushman P. O., \$25,000.

Glenn to the south boundary of Lane county in section 6, township 20 S., R. 11 W., via Canyon station and Ada P. O., \$49,000.

Florence to the north boundary of Lane county in section 10, township 15 S., R. 12 W., \$36,500.

Florence to the Pacific highway, via Deadwood and Blachly, over the road as finally located by the state highway commission and the United States office of public roads, \$282,500.

From the intersection of the north boundary of the Cascade national forest reserve with the middle fork of the Willamette river, to the Klamath county line over the road as finally located by the United States office of public roads, \$151,500.

Junction City to Blachly P. O., via county road No. 870 and Bear Creek station, \$34,000.

From the intersection of county road No. 450 with the West Side highway to the intersection of county road No. 399 with the west line of section 24, township 15 S., R. 6 W., via the Ferguson creek road, \$27,000.

From a point on the Eugene-Elmira road one mile west of Crabtree Hill to the Harpole school house in school district No. 30, \$50,000.

From the N. J. Bryant store at Franklin east along the present road to the intersection of county road No. 348 and county road No. 160, \$10,000.

From a point in section 28, township 16 S., R. 5 W., one-fourth mile west of the quarter section corner between sections 20 and 29 township 18 S., R. 5 W., to the northern boundary of Lane county in section 9, township 15 S., R. 5 W., via Crow, Elmira, Franklin and Ferguson, \$176,000.

Elmira west through Noti on the present road to its section crossing of Elk creek, \$48,000.

Eugene, from west end of Eleventh avenue to the intersection of county roads Nos. 155 and -729, commonly known as Gillespie Corners, via Coyote creek, \$118,000.

Eugene to the south boundary of Lane county in section 31, township 20 S., R. 4 W., via Spencer creek, Gillespie Corners and Lorane P. O., \$166,000.

Cottage Grove to Lorane P. O., via Silk creek, \$94,500.

Cottage Grove to the end of county road No. 645 near the Black Butte mine, \$70,000.

Cottage Grove to Disston, \$70,000.

From a point on the Pacific highway one-half mile south of Creswell to the Coast fork bridge on the Goshen-Lowell road, via Cloverdale school house in school district No. 2, \$40,000.

Lowell to the intersection of the north boundary of Cascade national forest reserve with the middle fork of the Willamette river, \$105,000.

Goshen to Lowell, via Pleasant Hill and Dexter, \$84,000.

MANSLAUGHTER IS VERDICT AGAINST CLARK

Jury, After Having Been Out 23 Hours, Comes to Agreement With Recommendation for Leniency.

Manslaughter with a recommendation for the leniency of the court was the verdict of the jury in the Martin Clark murder case. The verdict was rendered at 8:15 Saturday night after the jury had been out for 22 hours and 45 minutes.

When the verdict was read by Judge Skipworth he asked the foreman, Frank B. Harlow, what was meant by leniency in this case. Mr. Harlow replied that it was agreed among the jurors that a short term in the penitentiary was deemed sufficient punishment. Clark was taken back to jail by Sheriff Stickels later. The accused received the verdict with the same stoicism that has characterized his demeanor from the start. When the verdict was read a slight twitching of his mouth was observed but aside from that there was no sign of emotion. He said little and was very quiet as he accompanied Sheriff Stickels back to jail.

The jurors met last night that this verdict was agreed upon as a compromise. All day Saturday the vote stood nine for manslaughter and three for acquittal, said Foreman Harlow. It was seen that a disagreement would be had if there was not a break in the balloting soon and the three who stood out for acquittal finally agreed to sign a verdict calling for manslaughter with leniency.

BUSINESS MEN DONATE TO BASEBALL CLUB

The business men of the city have subscribed liberally to the support of the baseball club for the coming season, the amount raised to date being about \$500, a large portion of which will be used for the erection of a grandstand, for a new fence around the grounds and for the purchase of uniforms.

The uniforms will be charged against the members of the club and must be returned at the end of the season. In case a member does not return his uniform, the price of it will be deducted from his share of the profits at the end of the season.

WALKER-COTTAGE GROVE HIGHWAY IS INSPECTED

Members of the Lane county court, engineers of the Southern Pacific company and engineers of the state highway commission inspected the new highway between Walker and Cottage Grove Wednesday. Construction work on this stretch is still in progress, but parts of it have been in use since last fall. This new construction covers a distance of nearly four miles and eliminates four very dangerous railroad crossings, the new highway extending entirely on the west side of the tracks.

As the highway was cut out of the side of the hills for a long distance near Cottage Grove, the work has necessarily been slow and tedious ever since it started a year and a half ago, and progress was slow because of lack of labor and other difficulties.

Because of the fact that these crossings have been eliminated the Southern Pacific company is sharing in the expense of the construction work. When the changes contemplated by the county court and the highway commission are completed there will be but one grade crossing in the entire distance between Cottage Grove and Eugene as against 11 before the improvements began.

FRED LOCKLEY HERE ON NEWS MISSION FOR PAPER

Fred Lockley, of Portland, one of the numerous citizens of Oregon who wishes to serve Oregon as secretary of state, but better known to fame as an author of magazine articles, and as a special writer for the Oregon Journal, was in the city from Saturday to Monday working up material for a series of articles on the Opal Whiteley case, in which he took a great deal more interest than he did in the possibility of being selected to occupy an office on the ground floor of the capitol building. He made a brief address before the commercial club Monday evening, reviewing some of his experiences in France and telling ways of making a live city.

MRS. ALEXANDER THOMPSON SPEAKS HERE TOMORROW

Mrs. Alexander Thompson, of Portland, member of the legislature, prominent in women's clubs and one of the best known platform speakers in Oregon, will be the principal speaker at the teachers' institute to be held in the high school building here tomorrow afternoon from 2 to 4 o'clock. Principal C. A. Howard, of Eugene, will be among other prominent speakers present. Music will be furnished by local talent. All teachers and patrons of southern Lane county will participate.

COOPER HOTEL BUILDING SOON TO BE OCCUPIED

The W. B. Cooper hotel building will be at once put into condition for occupancy and Mr. Cooper plans to have it ready some time in June. The building has been partially completed for several years, but the heating system and lighting system are yet to be installed and considerable other work remains to be done to fit it for use. Mr. Cooper has not yet leased the building but says that several are ready to take the building and open it to the public as soon as it is ready for use.
