SOURCE OF CONTAMINATION IS DISCOVERED

Health Officer Orders All Habitations Removed From Fork of Prayther Creek.

The source of the contamination in the city water supply reported some time ago has been discovered through the efforts of Health Officer Oglesby, in the east fork of Prayther creek. Samples were taken from both forks of Prayther creek and at the Prayther creek intake. The west fork water was found to be pure. Dr. Oglesby has issued orders that any camps or residences maintained on this fork must be removed at once, that as soon as this is done the reservoir be drained and flushed and that the entire water system of the city be flushed.

W. Franzer Johnson, president of the U. S. Logging company, which operates in the reserve, in Portland, but it is understood that he took action a week or more ago to see that full cooperation is given by his woods crews and employees and has agreed to see that any ditching found necessary to turn seepage in another direction is done immediately. No logging operations are being carried on in this vicinity, the camp having been moved before contamination of the city water was found.

DYNAMITING OF TROUT ON COAST FORK REPORTED

Resident There Issues Warning That Violators of Law Are Known and Violations Must Cease.

The dynamiting of trout on Coast fork is indicated by an advertisement which a resident of that section publishes in this issue. He says that the parties are known and that they will be promptly reported to the proper authorities if the lawless act is repeated. In placing the ad, the advertiser stated that several charges were placed with in a distance of two miles and that he found dead fish along the whole distance.

Dynamiting fish is a serious offense and with a game commission that is determined to stamp out violations of the law it would not be surprising if some drastic action were taken.

Dr. Sheldon, of University of Oregon, Will Be Orator at Final Program Tonight.

Vera Cochran was very dignified as a high school teacher.

Kathleen Allen was the mother of the little bride and made a pleasing old friend for "the lady of the library."

The play was directed by Miss Lulu Harris, the senior class adviser. The numbers between the acts, a vocal solo by Leslie Hull, an instrumental solo by Marina Lowry, a vocal duet by Ethel Mackey and Lucile Davidson and a vocal solo by Myrtle Potts, added much to the enjoyment of the evening.

MODERN PHARMACY THIEF CAUGHT AT PORTLAND

Confesses to Burglarizing Store Here and Tells of Leaving Papers Where They Were Found.

A confession to the robbery of the Modern Pharmacy in this city several months ago has been made by Earl Lee, alias "Jack Martin," alias "Massachusetts Buck," alias "Jack Gordon," who was recently captured in Portland. John C. Venatch, deputy United States attorney, in writing to Marshal Piteher, says that Lee is a professional burglar and has served several penitentiary terms. In his confession Lee says that he kept nothing except the money stolen, leaving some of the papers in a shed at the rear of the hotel and the remainder in a gravel pit in the railroad yards. All the papers referred to, with the exception of some bonds, were found on the day following the robbery in the places indicated.

Mrs. Clara L. Rinehart, wife of L. J. Rinehart, died Tuesday morning of cancer. The funeral was held yesterday from the Mills chapel.

Clara Loop was born December 22, 1865, in Allegheny, Pa., moving with her parents to Michigan and later to eastern Oregon, where she married C. O. Childers. Mrs. Henry Seide, of this city, is a surviving child by that union. Later she married Mr. Rinehart, who survives. Mr. and Mrs. Rinehart lived here for 20 years, moving to Montana and returning here about two years ago.

Tested Recipes

Ham Muffins—One-fourth cup butter, three-fourths cup chopped ham (cooked), one beaten egg, three level teaspoons baking powder, three-fourths cup graham flour, one level cup white flour, one cup milk. Beat butter to cream; add ham and mix well; then add egg, graham flour and white flour sifted with baking powder and milk. Bake in hot oven 20 minutes.

Cabbage With Rice and Bacon—This is a Syrian dish and when cooked right is a very palatable way to cook cabbage. The rice should first be cooked in the usual way and should be very thick, in fact, cold rice is better. Pour hot water over the cabbage leaves so they will roll easily. Spread the rice on each leaf and roll them like cigarettes and drop into a kettle with enough water to cook the cabbage, then slice this a few slices of bacon and put over the top of the cabbage to season it. Salt to taste.

Brown Sugar Cookies—One cup of brown sugar, one-half cup butter or lard, small one-half cup water, one teaspoon soda; flavor with a few drops of vanilla.

Peanut Butter Soup—There medium size potatoes, two small onions, both cut up fine. Cook till done in about one quart of water. Then add one cup strained tomato, one heaping teaspoon peanut butter, dissolved in hot water, salt and pepper to taste. Add butter the size of a walnut.

NEWSPAPERS WARNED OF LAW VIOLATIONS

Grand Jury Says Political Advertising Must Not Be Printed in Election Day Issues.

The Lane county grand jury has issued warning that hereafter political advertising must not be printed in newspapers which circulate on election day. This warning was given because of the fact that newspapers of the county have printed political advertising in papers printed on the morning of election day and circulated before the opening of the polls. The Sentinel refused considerable advertising for its issue which would have been circulated under those conditions and was, therefore, not affected by the grand jury's warning. Such papers as The Oregonian and The Eugene Register have accepted advertising for their issues printed on election day, delivered at the postoffice before the opening of the polls but actually read after the opening of the polls.

The grand jury also gave warning that the law compelling the labeling of political advertising must be obeyed.

RICHARD WHITE, BOHEMIA MINER, TAKES LIFE

Eludes Watchful Relatives, and Is Dead From Strangulation When Found by Father and Brother.

Richard (Dick) White, for many years a miner in the Bohemia district but who had made his home for several years with his sister, Mrs. Ella Thompson, took his own life yesterday afternoon by hanging.

He had returned only a few days before from the hospital at Salem and seemed greatly pleased to be again at home. His relatives had watched him closely fearing that he might attempt to do himself harm. Yesterday afternoon he went out to the barn, his father accompanying him. He went into the barn while the father remained outside. The father thought his son had gone to sleep in the hay and did not worry until another son, Arthur, who had arrived only a few days before from Chico, Calif., came to inquire where Dick was. They found him hanging in a grain box. He had taken the hay rope which was attached to a rafter in the roof of the barn, dropped it through a knot hole, had gotten onto a box to put the rope around his neck, and had evidently kicked the box out from under his feet. He was dead when found.

Eight Births and Nine Deaths.

An unusual number of deaths were recorded in Cottage Grove during the month of May and barely outnumbered the number of births, which is unusual. According to the report of Health Officer Oglesby, there were eight births and nine deaths. Of the births, five were males and three were females.

Deputy Sheriff G. B. Piteher has been summoned to appear before the federal grand jury in Portland in the case against M. F. Green, recently convicted in the district court of manufacturing moonshine whisky.

The locals did some of the heaviest stick work they have done this season. One pitcher was knocked out of the box in the third inning and the second was badly maltreated in the fourth and eighth innings.

Stewart at third did the star work for the locals, making several hair-raising stops followed by perfect pegs to first. Frank Brumbaugh, who is a new man in the lineup for this season but who did some star work last year, was back at his old job of decorating left field, where he pulled in everything that came his way.

Cellers pitched a superb game, especially considering the wet condition of the ball. Eight went down before him by the strikeout route and the few hits he permitted the visitors to get were well scattered except in the initial inning.

For the visitors, Githens and Hecker did some of the prettiest work around second seen on the local diamond this season.

Albany had by far the strongest team the locals have met this season and the visitors came fully prepared to give the locals a good cleaning. The one-sided score is misleading and was due to the fact that the box artists were unable to put the "stuff" on the wet sphere, to hard luck in the way the game broke for the visitors, and to the heavy hitting by the locals.
