ELLIS B. HARDING CHARGED WITH THEFT OF CARS

Former Cottage Grove Boy Arrested in Seattle by Federal Agents

Ellis B. Harding has been arrested in Seattle charged with being a member of a gang that has been engaged in a systematic series of car thefts, according to a story in the Portland Journal, which is as follows:

"An interstate automobile theft gang, operating between Portland, Seattle and Spokane, is said to have been broken up by the arrest in Seattle a few days ago of Ellis B. Harding, alias E. Davis, and A. G. Bergquist, alias Ed Wallace, and the subsequent location of three stolen cars.

"One of the machines found in Seattle belongs to W. E. Keiran, superintendent of the Meier & Frank company store, and another found in Yakima belongs to L. I. Sullivan of Portland. The third machine was recovered here and belongs in Spokane.

"Arrest of the men was brought about by operatives working under the direction of W. B. Bryon, chief special agent for the department of justice.

"The men are said to have confessed in Seattle to their operations and to have boasted they were making \$2000 a week.

"They stole only one make of automobile, the Dodge, and always transported the car into another state before selling it. Every number on the machine is said to have been obliterated and changed before a sale was made. Sullivan's car was identified in Yakima because he had taken the precaution of placing a secret number on the engine and then covering it with paint.

"The men are loath to talk, federal agents say, and finally refuse to tell where the automobiles now are. Since July 25, 1920, they are said to have stolen 11 cars.

"The two will be tried in the Seattle federal court on charges of stealing the Portland machine, after which they will be returned here to face trial in connection with the Spokane car.

"Assistant United States Attorney John Veatch filed a charge against Harding Tuesday in the federal court charges him with violation of the national motor vehicle theft act."

Corvallis, Ore., Jan. 15.—A new world's record is believed to have been set by a pen of Oregon Agricultural college White Leghorn hens, it was announced today, when the five hardworking "biddies" took first place for the month of December at the Western Washington egg-laying contest being held at the experiment station at Puyallup.

The college pen laid 144 eggs for the 31 days of the month. The actual record of the five birds was 25, 28, 29, 30 and 31 eggs respectively, or an average of approximately 29 eggs to a hen.
