The Story of Our States

XXIX.—IOWA



THE State of Iowa was originally occupied by the Iowa Indians. The actual meaning of the word has been interpreted in several ways. Some say it means "beautiful land," but the more likely derivation is the Algonquin word "ajawa" which means "across" or "beyond." This was probably applied to this tribe of Indians by the Illinois tribes who were hostile to them, and resided on the eastern side of the Mississippi river. The early white visitors to this region included Marquette and Joliet, who landed here on their explorations of the Mississippi in 1673.

The first settlement was made by a French Canadian named Julien Dubuque. He obtained in 1788 a large grant of land from the Indians, where the city which was named after him now stands. Here he flourished, mining lead and trading with the Indians, until his death in 1810, when this settlement was given up.

With the acquisition of the Louisiana Purchase in 1803, Iowa, which was a part of this huge territory, came into the hands of the United States from France. At first Iowa was a part of the Louisiana territory, then of Missouri territory. Later it formed a portion of Michigan territory and then of Wisconsin territory. In 1838, however, it attained a distinct individuality when it was formed into the Iowa territory.

Pioneers soon came in large numbers and about 1832 a substantial settlement was made near Burlington, and Dubuque was founded in 1833. The population grew so rapidly that in 1846 Iowa was admitted as the twenty-ninth state of the Union. Its area is 56,147 square miles and it has thirteen presidential electoral votes.

Iowa is familiarly called the Hawkeye State.

XXX.—WISCONSIN



THE many cities in Wisconsin with French names show the French influence in its early settlement. The first white man to penetrate this region was Jean Nicolet, who was sent out in 1634 by Champlain to open trade with the Indians. He landed at Green Bay and probably traversed the country to Chicago. Fur traders and missionaries followed and the latter built a mission where Ashland now stands. This was the first church erected in the state and around it sprang up the first permanent settlement. Joliet and Father Marquette descended the Wisconsin river, and La Salle explored a great deal of Wisconsin before he took his famous trip down the Mississippi. Among the fur traders who came to Wisconsin shores was Daniel du Lhut, after whom the city of Duluth, Minn., was named.

During the Revolution Wisconsin remained loyal to the British and though Wisconsin became a part of the United States by the Treaty of Paris in 1783, it was not until 1816 that federal troops really established authority there. Indian uprisings continued for some time ending only with the Black Hawk war in 1832. Then followed extensive immigration from the New England States.

Wisconsin had formed a part of the Northwest territory until 1800, when it became a part of Michigan territory, under which jurisdiction it remained until 1836, with the exception of nine years, when it was considered a part of Illinois territory. With the admission of Michigan as a state, the Wisconsin territory was created, which included also the present states of Iowa and Minnesota and portions of North and South Dakota.

In 1848 Wisconsin was taken into the Union as the thirtieth state. Its area is 56,066 square miles and it has thirteen electoral votes for president.

The state is named after the Wisconsin river. This is an Ojibwa phrase which means "gathering waters." It is sometimes called the Badger State.

OREGON NEWS NOTES OF GENERAL INTEREST

Principal Events of the Week Briefly Sketched for Information of Our Readers.

Hop picking will begin near Harrisburg about August 15.

Organization of the Clackamas County Pioneers' association has been effected.

The Cabbage Hill-Deadman's Pass road, a stretch of 12.8 miles on the Pendleton-La Grande road, has been finished.

Governor Olcott has promised to be present and speak at the dedication of the municipal aviation field at Eugene September 5.

Lane county will not produce one-fifth enough peaches for local consumption this year, according to the county fruit inspector.

Leland Smith of Portland, recently appointed to the consular service, has been assigned to the consulate of Saigon, French Indo-China.

Feed for cattle on the low lands of Josephine county is reported to be excellent. The cattle are in fine condition for this time of year.

Allen Johnston, 9 years old, whose parents live in Portland, was drowned in the Columbia river at Rainier when he was caught in a whirlpool.

A. L. Parker, an employee of the Crown Willamette Paper company, was drowned in the Willamette river at Oregon City while bathing.

Fourteen hundred pounds of molasses and 109 pounds of arsenic were sent to Crane Prairie last week to be used as poison for grasshoppers.

Approximately one-third of Umatilla county's 1921 wheat crop, or about 2,000,000 bushels, already has been contracted, the prices ranging near \$1.

The first crop of 1921 barley threshed in Lane county this year yielded 50 bushels to the acre. It was grown on the ranch of Ralph Coon, of Junction City.

The Union Oil company of California has permitted to the secretary of state \$17,796.48, covering the tax on sales of gasoline and distillate in Oregon for June.

J. E. Enyart, a former Medford banker, is promoting a company to construct an aerial system to transport tourists from the rim of Crater lake to the lake surface.

Harrisburg hop men are selling out last year's crop as low as 11 cents a pound. This time last year they refused 40 and 45 cents and later in the summer as high as 65 cents.

Work on the Oregon central military wagon road from the Rigdon ranch, 75 miles south of Eugene, to the summit of the Cascades will be completed by the last of this week.

The shortage in Umatilla county road funds due to alleged speculations for which K. C. Amann, clerk in the roadmaster's office, was arrested, will amount to between \$3000 and \$4000.

Jail sentences aggregating about a year, and fines totaling more than \$1500 were the results of recent activities of operatives of the Oregon Anti-Saloon league in Marion county.

C. H. Gram, state labor commissioner, reports that labor conditions have improved somewhat during the past few weeks, due to the demand for workers on farms and in the fruit industry.

A. P. Davis, director of the reclamation service, will pass several days in eastern Oregon in August, visiting the Powder river irrigation project August 21 and 22, and the Deschutes project later.

Approximately seven miles of white guard rails will be built on all sharp curves and deep fills on state highways in Umatilla county leading to Pendleton before Round-Up time late in September.

With the lumber mills fast getting back to normalcy in production and a consequent reduction in prices of lumber, the outlook for home construction in Baker is more favorable than for three or four years.

Fire in Brooks-Seanlon slashings along The Dalles-California highway, 13 miles south of Bend, caused so intense a degree of heat that automobile tourists were able to drive through only with the greatest difficulty.

The Oregon Wool & Mohair Growers' association has announced the shipment of ten carloads of market lambs from valley counties as the result of an order for 10,000 breeding lambs which it was asked to fill.

That the body found in the Brumfield auto wreck near Roseburg was that of W. Dennis Russell and that he met his death by gunshot wounds inflicted by a person unknown, was the verdict returned by a coroner's jury last week.

Orders were received at Eugene to move all of the airplanes and men stationed at the base of the forest fire patrol at Medford to the main base at Eugene and all patrols over the state will start from the Eugene flying field. Gasoline stations will continue to be maintained at Medford and Portland.

Secretary of the Treasury Mellon has agreed to approve the China trade act sponsored by the Portland Chamber of Commerce, for separate legislative action prior to and independent of the general revenue revision bill.

Members of Bend, Redmond and Prineville lodges of the Woodmen of the World will hold a joint session in Redmond Saturday evening, August 6, to initiate large classes resulting from the central Oregon membership campaign now on.

Word has been received at Dallas that Joseph Dennis, youngest son of Mr. and Mrs. O. E. Dennis, Oakdale farmers, who is serving in the American army of occupation in Germany, was cited recently for bravery for preventing an explosion.

Under the direction of the American Legion post, Bend will celebrate clean-up day, July 31, at Shevlin park, the tract in Tumalo canyon recently donated to the city by the Shevlin-Hixon company. Volunteer labor will put the park in order.

The month of June marked a new record in the business transacted by the state corporation department, according to announcement made by T. D. Handley, state corporation commissioner. The cash receipts of the office for the month were \$113,000.

Reports are current at Salem that E. S. Evenden, now assistant to Dr. Strayer, head of the department of education of Columbia university, probably will be offered the presidency of the state normal school at Monmouth to succeed J. H. Ackerman.

A band of 60 elk is reported to have been seen in the neighborhood of Trout Meadows in Baker county, by members of the Whitman forest service. A report has been made to the state game commission, and every effort will be made to protect the elk.

The 1600 members of the Oregon Wool and Mohair Growers association met last week in the various districts throughout the state to elect the permanent board of 15 district directors. Directors are elected by districts in proportion to the number of sheep signed.

The Willamette Valley Southern railway, through its traffic manager, has filed an application with the Oregon public service commission asking that it be allowed to put into effect reduced week-end rates between points on its lines and Portland and Oregon City.

Reduction of naval appropriations will make it impossible for the government to assign the historic battleship Oregon to the state this year at federal expense, according to a letter from Assistant Secretary Roosevelt, received by George A. White, adjutant general of Oregon.

Based upon the indebtedness of the state and its political subdivisions, aggregating \$107,400,539.84, as reported to Governor Olcott by Frank Lovell, state tax commissioner, the annual interest that must be paid to keep these obligations in good standing will exceed \$6,370,000.

Oregon's indebtedness, including all county, city, school, port, irrigation district and drainage district bonds and other obligations, aggregate \$107,400,539.84, according to a report filed with Governor Olcott by Frank Lovell, state tax commissioner.

For the first time in several years it is reported that cattle again are being poisoned by larkspur in Union county. Several members of the Summerville Livestock association have suffered the loss of several cattle on the reserve, most of the dead cattle being found near Five Point creek.

Eight hundred and sixty-three acres of Indian lands on the Umatilla reservation of an appraised value of \$86,820, will be placed on sale September 16, according to Superintendent E. L. Swartzlander of the Indian agency. The land is divided into 15 parcels, none exceeding 80 acres and none less than 35 acres of land.

Dr. W. H. Lytle, state veterinarian, has returned to Salem after 10 days at Seattle, where he attended a meeting of the veterinarians of the northwest. Dr. Lytle said reports at the sessions indicated that livestock conditions were improving throughout the west. Dr. Lytle said reports at the session indicated the indebtedness caused by the decline in prices following the war.

Marion county's flax crop, which pullers will start to harvest next week, probably will return to the growers approximately \$45,000, according to a survey completed recently by Robert Crawford, superintendent of the penitentiary flax plant. A total of 790 acres of flax were planted this year, all but 40 of which were covered by state contract. Growers will receive \$55 a ton for the product.

There were six fatalities in Oregon due to industrial accidents during the week ended July 21, according to a report prepared by the state industrial accident commission. The victims were: Ray W. Burt, construction worker, Portland; Edward Erickson, construction laborer, Goble; George H. Dayton, laborer, Grants Pass; Chris Hoyt, construction worker, Portland; Stephen Stewart, road worker, River-ton; and John C. Lewis, lineman, Salem. A total of 357 accidents were reported.

GOVERNOR SMALL OF ILLINOIS IS INDICTED

Conspiracy and Use of Public Money For Private Gain Are Alleged.

Springfield, Ill.—A bitter battle to the finish between the judicial and executive branches of the Illinois state government seemed imminent as a result of the issuance of warrants for the arrest of Governor Len Small on charges involving the misuse of state interest funds.

Governor Small, in a statement, declared he would "irrevocably refuse" to submit to arrest.

Warrants were issued for Governor Small, Lieutenant-Governor Sterling and Vernon Curtis, Grant Park banker and son of the late Senator Curtis, following their indictment on charges of embezzlement, conspiracy and operating a confidence game through the alleged use of interest on state funds for their personal gain.

The alleged illegal operations named in the indictments centered around deposits of state funds with the "Grant Park Bank," held by the grand jury to have been a fictitious institution since 1908, when it ceased to function.

Circuit Judge Smith in ruling on the question of the arrest of Governor Small on a charge of embezzlement during his term as state treasurer several years ago, held that warrants should be served upon the governor, but that the executive should be permitted to make his appearance at his convenience within a reasonable time.

PIRATE SHIP MYSTERY IS BELIEVED SOLVED

New Haven, Conn.—In the seizure of the auxiliary sword-fishing sloop Jennie T. of Northport, N. Y., the confiscation of liquor valued at more than \$50,000 and the arrests of 18 men in a spectacular raid, federal officials believed they had solved—partly at least—the mystery attached to the elusive "pirate ship" which has been sighted at various times off the New Jersey coast near Montauk Point and in Long Island sound.

The dramatic capture of the liquor-laden sword-fishing sloop as she was unloading the champagne, gin and Scotch whisky dispelled all doubt of the existence of a mystery ship plying between the Bahama islands and the Atlantic coast.

The mother ship of the liquor runners is believed to be a foreign schooner, which has transferred its precious cargo of whisky to smaller vessels off Montauk Point in recent weeks.

FIVE BIG STEAMERS SEIZED

Leases Alleged to Have Violated Contract with Shipping Board.

New York.—Five of the largest and finest steamships in the United States merchant marine, which had been chartered to the United States Mail Steamship company, were seized by representatives of the United States shipping board, because of an alleged violation of contract.

The seized vessels, all ex-German liners, are the George Washington, America, Susquehanna, President Grant and Agamemnon.

Failure of the steamship company to pay rentals which aggregated up to the time of the seizure about \$400,000, was given as the principal reason for the board's action by Elmer Schlesinger, its general counsel.

Business Men Fight Jap Deportation.

Turlock, Cal.—Business men of Turlock, through the chamber of commerce, went on record in a resolution adopted against forcible steps against the Japanese. County officials predicted serious trouble for white fruit workers if any more mob advances are made against the orientals, such as the recent raid in which about 60 Japanese were loaded into trucks by a crowd of white residents, carried out of town and ordered never to return.

Life Is Washington Dry Agent.

Washington.—Appointment of Roy C. Lile of Seattle as federal prohibition director for Washington, succeeding Donald A. McDonald, was announced by the internal revenue bureau.

Seattle Gives Millions For Power.

Seattle, Wash.—The city council here adopted an ordinance appropriating \$5,500,000 for the further development of the Skagit river power project.

Governor Hart Replies to Critics.

Olympia, Wash.—In an address before the convention of the Washington State Bar association here, Governor Louis F. Hart replied to critics of his administration.

M. Lane County, Oregon on the 23rd day of August, 1921, at the hour of 10 o'clock a. m. for the purpose of viewing out and locating either a suitable road not exceeding sixty feet wide, or a gateway not less than 30 nor more than thirty feet wide, or both, as may be found best by said road viewers, having regard to all surrounding circumstances and conditions of the case, from the farm or residence of said petitioner to the nearest point practicable on a public road and to assess the damage to be sustained thereby.
