OREGON SKYLINE TRAIL IN EXCELLENT CONDITION

The Oregon skyline trail from the Cascade summit immediately south of Maiden peak north to Taylor lake is open and in excellent condition, according to Forest Supervisor N. F. Maeduff, who has just returned from an inspection trip in the Oakridge district. This section of the skyline trail has an average of one signboard every tenth of a mile so that the novice should be able to follow it without the least difficulty, in fact, if one attempts to get off from the trail a signboard is almost sure to scream aloud.
The crew on the Willamette road has completed its work above Beaver marsh and is moving down to Emigrant creek where it will start construction of a new piece of road, which when finished will eliminate the worst remaining hill on the upper Willamette road, from Emigrant creek to Beaver marsh. Mr. Maeduff hopes that the section from Emigrant creek to Beaver marsh may be completed this fall, although this section alone is more than two miles long and involves some very heavy grading.

FORMER SCHOOLMATE OF TAFT IS STREET BEGGAR

Eugene, Ore., Aug. 10.—Life's paths for schoolmates often diverge widely. This is the impression Judge Alta King got from Will Martin, aged 40, in police court this morning. After the judge had given him 20 days in jail on a charge of being drunk and disorderly on the streets Saturday evening, Martin quietly informed King that he was an old schoolmate of William Howard Taft.
Martin was arrested Saturday evening by the police while he was drunk and begging on the streets. He had a bottle of Florida water in his pocket and told the officer he had drunk two others. Martin's sentence was suspended on provision he leave town forever. He promised the judge he would "blow" by noon.
Among Martin's personal effects, found in his pockets, was a newspaper clipping concerning ex-President Taft. When the judge handed the clipping back to him, Martin informed the judge he was a schoolmate of Taft's.

HOUSING SITUATION IN EUGENE BECOMES CRITICAL

Eugene Register: That the housing situation in Eugene is fast becoming critical and if not remedied in the near future will mean the loss of many possible residents to the city, is the opinion of many local business men and real estate dealers who see in the shortage of homes that are available for renting a condition that calls for quick action if the city is to benefit by the residence of the many people that inquire concerning homes here.
All local renters report that they have many more applications for homes to rent than they can accommodate and that if more homes are not provided before the winter it will mean a great loss to the city, as many of the possible renters, having become discouraged in their search, have left for other cities or have decided to remain at their present homes until the situation improves.

WASHINGTON MEN PRAISE OREGON HIGHWAY SYSTEM

Oregon roads are excellent and Oregon's road program, far more extensive than Washington's, will place this state in an enviable position among its neighbors, according to James Allen, state supervisor of roads for Washington who, with a party of Washington road boosters, spent a few days last week in the Willamette valley.
By this fall there will be but 36 miles of unimproved road on the Pacific highway between Portland and Seattle, and by the close of 1922 there will be excellent roads the entire distance, according to Mr. Allen.
Washington at the present time has but \$7,000,000 under contract, while the Oregon road program calls for an expenditure of approximately \$15,000,000.

MOTORCYCLE RIDER DIES AS RESULT OF INJURIES

Walter Matney, the 22-year-old Albany youth who was injured Sunday night when his motorcycle collided with a car driven by F. S. Malcolm, of Monroe, on the west side highway near that town, died at Mercy hospital in Eugene Tuesday afternoon.
The young man sustained a fracture of both legs, fracture of the hip and a fractured skull, besides internal injuries.
The accident in which young Matney was injured occurred in Benton county as it is understood that the officials there will investigate the affair. It is reported that both vehicles when they collided were without lights, the time of day being about 8 o'clock in the evening.

GRADING OVER MOUNTAIN TO BE FINISHED THIS FALL

The Iver J. Rosten company, of Portland, who have the contract to grade 2.3 miles of the Eugene-Florence highway from the summit of the coast mountains to Blachly, are making excellent headway on the work. Mr. Rosten expects to finish his contract this fall.
Washburne & Hall, the contractors on the 12 miles of grading between the summit and the Bear creek falls on the east slope of the mountains, have their grading contract almost completed. An excellent grade up the slope of the mountain is provided by this new road.
No action has yet been taken toward surfacing either section of this road.

JAUNT TO WESTERN LANE COUNTY FAIR PROBABLE

The Cottage Grove chamber of commerce has received a communication from the Eugene chamber of commerce earnestly soliciting the attendance of a delegation at the Western Lane County Fair, to be held September 8 at Florence. The Eugene chamber points out that a large attendance from the eastern end of the county will help to cement the western and eastern ends in bonds of friendship. Those willing to make the jaunt are asked to make such fact known to Secretary Miller, of the Cottage Grove chamber of commerce, not later than September 5. The round trip fare is \$5.38.

McVeigh Crossing Nearly Finished.
The concrete work on the big overhead crossing where the main line of the Southern Pacific crosses the Pacific highway at McVeigh point, four miles south of Eugene, is practically completed and the wooden forms are now being removed. It is said to be one of the highest structures of its kind in the state and will be one of the most expensive when completed.
The outfit of the contractors who have the job of making the extensive fills on either end of the structure is on the ground and the work of moving the 35,000 or 40,000 yards of earth required in the fills is expected to begin at once.
