Sealed bids will be received by the State Highway Commission of the State of Oregon in room 529, Multnomah County Court House at 10 o'clock a. m. on October 25, 1921, for the following project:

Cottage Grove section of the Pacific highway in Lane County, 7,488 lin. ft. of paving, described as follows:

Beginning at the north city limits of Cottage Grove, following Ninth street to its intersection with the north property line of Main street, then beginning at the intersection of Fifth and the south property line of Main street on Fifth to the south city limits thence across the Coast Fork of the Willamette River to connect with the north end of the present pavement approximately 500 feet south of the river crossing.

Tested Recipes

Rhubarb Conserve.

If you have some pineapple left after a meal, combine it with figs and rhubarb and make a delicious and different conserve. Use one and one-half pounds of figs, three pounds rhubarb, one orange, one lemon, one cup diced pineapple, one-half cup nut meats, one-half teaspoon ground cloves, one teaspoon cinnamon, three pounds sugar. Wash the figs and cook a few minutes longer, then add the rhubarb cut in inch lengths, the grated rind and juice of the lemon and the shredded rind and diced pulp of the orange nuts, spices and sugar. Cook until thick, watching carefully to prevent burning. Turn into jelly glasses and cover with paraffin when cool.

Raisin Gingerbread Is Good.

Old-fashioned raisin gingerbread is quite as good as fancy cake and is much easier to make. Mix one cup of buttermilk with one cup of molasses and one teaspoon of soda. Add one beaten egg and three cups of

flour sifted with one-half teaspoon each of ground cinnamon, cloves, mace and one teaspoon of ginger. Mix well and stir in two cups of chopped raisins. Pour into buttered shallow pan and bake in a moderate oven.

Macaroni Balls.

Boil half a package of macaroni as directed, chop fine, add half a cupful of grated cheese, salt, pepper, a tablespoonful each of crumbs and chopped nuts and the yolk of an egg.

Mold into balls and set to cool. When ready to use dip the balls in egg-roll in fine crumbs and fry in hot fat. Drain the balls on brown or blotting paper and serve them with a cream sauce. Garnish with parsley.
