Eligible Forms of Documentation

Address Verification

For tribal member applicants and applicants for non-tribal custodial parents addresses, the following types of documentation are acceptable:

- Telephone bill
- Water/sewer bill
- Cellular telephone bill
- Natural gas bill
- Garbage collection bill (regular weekly service)
- Property tax statement
- Monthly mortgage statement
- Formal rental agreements from outside parties or agencies

All documentation must be in the **applicant's name** as it appears on the tribal roll and list the street address (not just mailing address) where service is provided.

Unacceptable forms of verification:

- Notes, rental agreements, or letters from family, friends, or co-habitants in the residence
- Medical bills
- Driver's licenses
- Utility bills in someone else's name

Custody Verification

For non-tribal custodial parents, the following types of documentation are acceptable. These verification(s) must accompany the application form.

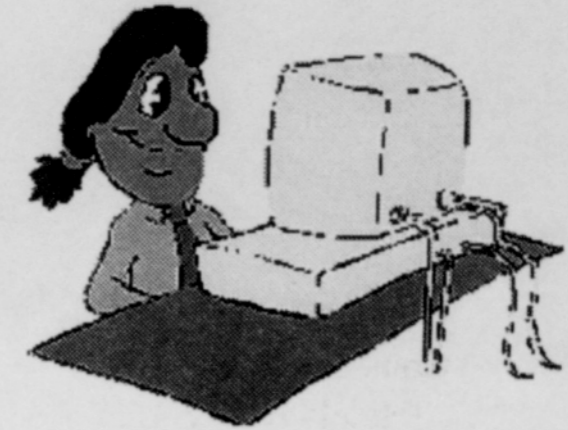
- Divorce decree awarding custody to applicant parent
- Adoption or state/tribal welfare placement records awarding custody to applicant parent
- In the absence of either of the above, copies of birth certificates listing the tribal parent applicant

Computer Requests

Deadline for applications is 4:30 p.m. on Jan. 15, 2004. Households eligible to apply include:

- Any tribal household that has not previously received a computer
- Any non-tribal household that has custody of tribal children and has not previously received a computer
- Any household with duplicate addresses that can provide proof that the person/household that previously received a computer is no longer part of their household.

The burden of proof is on the applicant. Applicant and previous recipient must provide verification of their current residence.
