Request for Proposals

for Architectural and Engineering Services "Multi-Purpose Tribal Food Distribution Facility"

The Confederated Tribes of Siletz Indians has released a Request for Proposals for architectural and engineering services for the design and construction of a USDA warehouse and food distribution structure.

Minimum qualifications required to submit a proposal are:

1. At least three years proven experience as a licensed and bonded architect and/or engineer in the state of Oregon
2. Must be able to complete the project as stated in the Services Agreement Contract and in a timely manner
3. Must provide proof of professional liability insurance

Proposals submitted will be evaluated based on **experience and capability, Indian preference, and fees.** An internal Review Committee will evaluate the proposals with final selection by the Tribal Council.

No proposals will be accepted after that time.
