## Scam Alert

### Beware of Bogus Issuance Requesting Form W-8 BEN

Several tribes have received a fax issuance on what appears to be an IRS letterhead, informing them that they are non-resident aliens and are exempt from federal taxation. The information in the letter is not only incorrect, but the letter itself is bogus.

This letter is **not** from the Internal Revenue Service and you should **not** follow any of the instructions contained within the letter, nor complete or submit the form that is attached to it.

The letter is a scam being perpetrated to attempt to secure financial information from unsuspecting individuals. In addition, the attachment to the letter is not a legitimate Form W-8 BEN, as evidenced by numerous typographical errors, including referring to our country as the "United State" of America.

The fax number does not belong to the IRS and all IRS e-mail addresses end in the suffix "@irs.gov," which is not the suffix used in the e-mail address in the letter.
