the airport had received.

Grossi said that work on the tie-downs, the information kiosk, signage for the airport and the botanical trail was being completed. He said that following delays caused by the Biscuit Fire and the inclement weather, work has continued and will be completed as soon as possible.

Grossi reported that the directional signage had arrived and needed to be installed, with four signs at each end of the runway. It was decided that a several board members could form a group and get the job done.

There was a question as to whether buildings were going to have to be modified if a Global Positioning System (GPS) was implemented. Under the current Airport Layout Plan (ALP) the buildings will not be affected except for possibly a light having to be installed. There is also the issue of trees having to be removed to be eligible for grant money funding.

Grossi stated that if the board decided to really pursue installation of a GPS it would take approximately a year to complete.

The advisory board has been aware of several people with potential businesses wanting to build hangars in the industrial park adjacent to the airport. The business owners stated that it is vital to the development of their businesses that they be near an airport and are impatient to get development going.

The board informed the business owners (who were present at the meeting, but not identified) that they want to do whatever they can to get them what they want.

Unfortunately, power and water are not installed at the park yet. A pump and pump house need to be installed, and the biosewage project has not been completed.

When contacted by the advisory board concerning the industrial park progress, Al Koski, Josephine County Community Development coordinator, said that all services should be completed and ready by the end of July 2003.

Board member Ed Russell inquired why \$500,000 was budgeted and something as important as power hadn't already been installed, since it had been budgeted in.

Josephine County Commissioner Jim Brock said that maybe Koski could provide a timeline as to when the power, sewer and water services would be sure be available. He informed the board that there might be some project funds available if there was a shortage.

Brock also said that \$12,000 in lottery funds will be available for the airport for economic development and that a Workers Compensation case had been filed by a former airport caretaker for age discrimination, and if there were a settlement the amount would be put back onto the airport during a five-year period.

Valley resident Bob Perkins noted that Viridian, which is growing the experimental alyssum in the Rough & Ready Flat area, wants to build a smelter to process the alyssum at the industrial park and is concerned about pollution issues.

Grossi said that Viridian had contacted him on the subiect and that he had seen a photo of the smelter. He stated that the smelter is self contained and non-polluting.

"There would be criteria that would have to be met before the final decision," Grossi said.

Russell approached the fact that Viridian had not planted a plowed area and was concerned about the dust factor. He asked Brock if Viridian had posted a bond to take care of the dust issue.

"I can't recall the contract at this time," said Brock.

The next advisory board meeting will be on Thursday, April 17. Anyone can attend.


