#### Lost five days in wilderness, **Cave Junction man located**

A Cave Junction man missing in the wilderness for five days has been found.

Timothy Strunk Yost, 62, told friends he was going to be visiting a casino on the coast on May 30, but friends became worried when he did not return home as anticipated.

He was reported missing on Monday, June 2. On Wednesday, June 4, Yost's vehicle was reported to be parked at the Babyfoot Lake trailhead approximately 17 miles northwest of Cave Junction out Eight Dollar Road.

Deputies responded that evening and confirmed that it was his vehicle. It was locked, and there was no sign of Yost.

Search operations were conducted in the area during a three-day period. Members involved in the search included Josephine County Search and Rescue including a dive team and K-9 team, sheriff's office and Mounted Posse, Curry County Sheriff's Office and Search and Rescue, Jackson County and Lane County K-9 teams, Air National Guard, American Red

Cross and many private citizens.

On Saturday, June 7, citizens floating down Illinois River near Miami Bar heard a cry for help from Yost.

He was found tired and dehydrated, but otherwise in good health.

One of the rafters floated down to Oak Flat to phone 911.

American Medical Response, U.S. Forest Service and Josephine County Sheriff's Office responded, and after a medical evaluation, a sheriff's deputy took Yost to his residence.

Yost said that he went to the area to see Babyfoot Lake and had become lost within the first hour.

Along his journey, he visited such places as the Chetco River and Pearsoll Peak.

Unofficial reports indicate that it is easy to become lost in such wilderness areas, particularly because of the burned areas after last year's Biscuit Fire.

Those in such areas can easily become disoriented.

He requested a clarification of the working relationship between the community and the city. He also sought a

clarification of the view of the valley's future and specifications of development on items such as guest house, residential accessory buildings and hardship residences.

"All development is not

necessarily bad," he said, noting that Cave Junction is in a "unique position."

He noted however, that there needs to be some level of caution in terms of building and growth. A balance (should exist) between allowing mobile homes, hardship residences to accumulate in certain parts of the community.

Preservation of singlefamily dwellings, where grandma or grandpa can live in back of a house instead of being put in an assisted-living facility, is needed, he indicated.
