\*Deputies checked on a dog tied up without food and water in the 600 block of S. Junction Avenue. Deputies fixed the dog's leash and located food and water.


\*Deputies investigated a possible case of criminal mischief at Lake Selmac RV Resort at 11:47 a.m.


