IVCRT Insights

Illinois Valley Community Response Team just received notice that the grant application to U.S. Dept. of Agriculture Business-Cooperative Services to increase the revolving loan fund (RLF) was approved.

The \$95,000 award brings the total funding for the RLF to \$255,000, \$40,000 of which was CRT funds and the remainder from USDA.

Begun in June 2000, the RLF has granted 33 loans, 10 of which have been paid off. The purpose of the RLF, which is administered by a separate volunteer loan board, is to make small-interest loans available to area entrepreneurs, who otherwise would not qualify for credit from other sources.

Loans can be used to expand existing businesses or to establish new businesses. The maximum loan amount has been raised by \$10,000 and the maximum loan period is 10 years. Currently, the annual interest rate is 5 percent.

To apply, there is a simple loan application that has to be filled out. After the applications are submitted, they are reviewed by CRT staff.

An orientation meeting is held where applicants can present their business ideas and get feedback from other applicants as well as written comments from CRT staff. Assistance in preparing financial projections is available. The next step is to appear before the loan board and make a presentation on the business and the loan request.

Following a question-and-answer session, the loan board makes its deliberations.

If positive, a credit check is made on the applicant. Previous credit problems do not automatically disqualify an applicant. The way in which the debt

was handled is taken into consideration. If the applicant has had a bankruptcy, an explanation must be given, and there must be two years without credit problems following the bankruptcy.

Because it is a revolving loan fund -- meaning that loans have to be repaid so that new loans can be made -- the loan board is very careful in only approving loans it believes will be repaid.

However, the board does keep in mind its mission of serving entrepreneurs who otherwise would not qualify for more formal conventional financing and tries to be flexible in assessing applications.

Loan applications are accepted four times a year. The deadline for submission of the next round of applications is Oct. 8.

Ward has extensive experience in working with non-profit organizations.

There is still no word on the 10-year contract for the Oregon Caves National Monument concession. The National Park Service Review Committee has met, and its decision could come any time.

With two months left in the season, sales projections for the year have already been met. There has been an increase in the

consignment sales from area artists and crafters, and in purchases by the Oregon Caves Outfitters of wine, beer, and produce for the dining room.

An Employee Appreciation Day was held last week to thank the staff for its hard work this season.

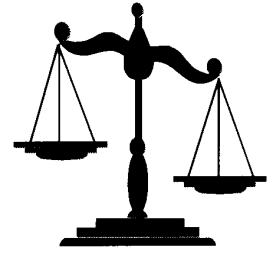
In reading guest comments, visitors continue to
