

Tales from the Police Blotter

Sunday, Dec. 30

*Lisa Ray Hazzard, 40, was arrested on a warrant for the previous charge of possession of a controlled substance of methamphetamine in the 400 block of N. Old Stage Road.

*In the 400 block of S. Redwood Hwy. a man said several items were missing from his truck including a paintball gun, paintballs, and a CD player. Someone broke his back window to gain entry.

*In the 400 block of S. Redwood Hwy. a man said items were missing from his vehicle and his driver's side window was broken.

*A woman in the 500 block of Schumacher Street said two of her vehicles were vandalized. One was spray painted and someone went through the glove box of the other. Deputies filed a report for criminal mischief.
