How did you come to work at the monument?

I stumbled upon Ron Phillips on the Internet; I was looking for a volunteer position. When he found out that I had hotel experience, he asked me if I wanted to run the hotel. It got to be a dream job. I've been working at hotels since 1986. I worked at El Dorado Hotel in Reno, Nev. From there I went to Lake Tahoe, then to Sequoia National Park, then to Danali National Park in Alaska; then Valdez, Alaska; Fairbanks, Alaska; then to Maine before coming here last year.

How was the trip?

Well, my girlfriend and I just packed up a U-Haul trailer and headed out. We didn't have a place to live, and I had never met the guy (Ron Phillips); kind of a leap of faith. We spent the first couple of weeks in a room at The Chateau until we found a place in town that we are renting now.

Was there much difference between here and the East Coast?

Well, the attitudes are quite a bit different on the West Coast. I grew up on the West Coast, so I am more comfortable here than I was in Maine, that's for sure. Folks on the East Coast are a little more uptight than people on the West.

What do you like about working at The Chateau?

It's a beautiful building. Nice, small little lodge; it's not too big. Working in the hotel business has allowed me to see many beautiful parts of the country. Working at The Chateau is a dream come true; kind of a melding together of my love for helping the community and my love of old buildings and being up in the woods.

Any family in the area?

No, actually. I was born in Okinawa, Japan. My father worked in food service on an Air Force base there when I was a baby. When I was about 1 1/2 years old, we moved to Tucson, Ariz. where I grew up. My brother is still there. And I still own a place in the desert where I grew up. Once a year, I go back to Tucson to visit. Every time I go back home, I have a new appreciation for the desert. They are probably hitting 100 degrees right now.

What do you like about Oregon?

The mountains. Being out in the woods. I enjoy being amongst the trees and the rocks, and enjoy all that Nature has to offer.

What do you like to do for fun?

Well, we like to take our American Eskimo dog, "Max," out for walks at Rough & Ready Creek. My girlfriend and I also like to go hiking and backpacking just about anywhere we can.

*ODOT was advised at 1:13 p.m. that a stop sign had been pulled down on Rockydale Road at Redwood Hwy.


*The owner of a video store in Selma said at 3:17 p.m. that a woman on Deer Creek Road had failed to return a couple of movies.
