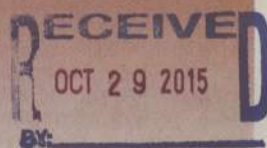

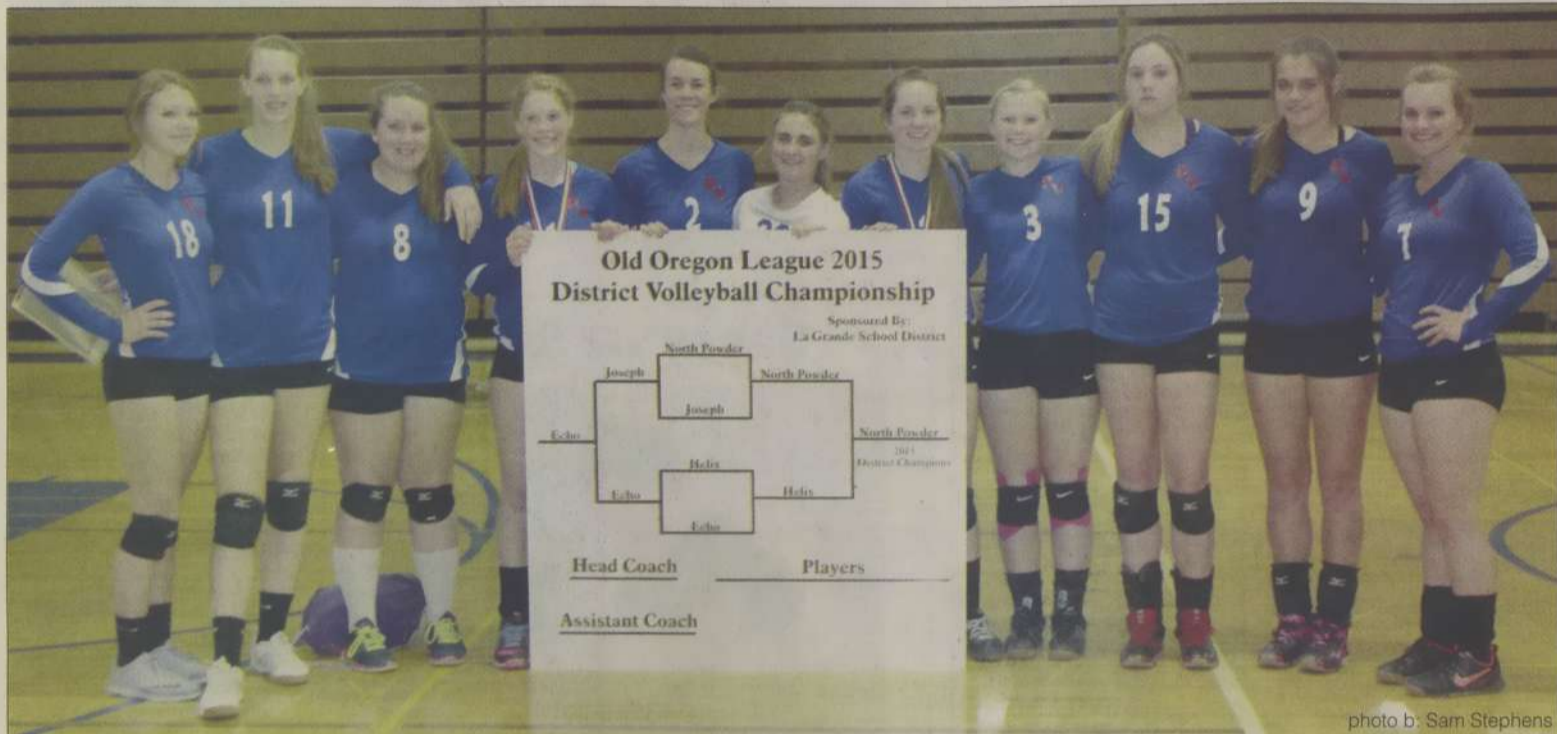

Kerns Won't Run for Re-election

Tim Kerns, Haines rancher and potato farmer who has served on the Baker County Board of Commissioners for several years since being appointed to finish the remainder of Paul York's term, announced last week that he will not seek re-election. The seat currently held by Kerns is Position One and is a four year term.

The deadline to file is March 8, 2016 and

the primary election will be held on May 19, 2016. Members of the three major parties, Democrat, Republican or Independent, interested in filing must have been a resident of Baker County for at least one year prior to the date of the election and must either pay a \$50 filing fee or gather the required amount of signatures which varies depending on the party. Democrats must gather 46 signatures, Republicans 85, and Independents 500. Those in recognized minor parties have different requirements and should contact the Baker County Clerk or the Oregon Secretary of State Elections Division with their questions.
