Many OSSA member agencies -- along with many city police departments and the Oregon State Police -- have sent personnel to help Sheriff Ward patrol the community and maintain public safety during this critical time.

We continue to be asked when the standoff at the Malheur Wildlife Refuge will end, and which agency will make that decision. We'd like to clar-

ify the jurisdictional situation. The FBI is in charge of making and implementing plans to end the siege. The FBI has jurisdiction over the armed takeover of the federal buildings in the refuge, as well as any crimes committed therein. Questions about the standoff should addressed by the FBI, which continues to work diligently towards a peaceful solu-
