

LABOR NOTES.

The United Labor League of Camden, N. J., has placed a Legislative ticket in the field.

Unions have formed so rapidly in Des Moines, Ia., that they cannot find halls in which to meet.

San Francisco will be a closed city on Labor day, and will march 40,000 union men in a motor parade.

The Laundry Workers of Vancouver, B. C., have a little strike on their hands by one laundry refusing to sign the schedule.

The Stableners' Union of Stockton, Cal., has won a victory in a difference with its employees and a contract signed for one year.

It is reported that the Great Northern Railway Company will replace its Japanese with Italians, at about 16 cents an hour.

After a strike lasting but two days the St. Louis Pipe Coverers' Union won an increase of wages from \$3.25 to \$3.60 per day.

Team drivers at Jackson, Mich., formed a union and won an increase of \$1.50 more per week, and laborers 15 cents more per day.

The Central Trades and Labor Council of Brazil, Ind., reports having found a number of cigars on sale in that city bearing bogus labels.

The Musicians' Union of Spokane tendered the services of 50 pieces of music for the Gompers and party reception and meeting on the 9th inst.

After a fight lasting two years, the woodworkers have unionized the factory of the Philip Rinn Company, Chicago, and secured an advance in wages.

The effect of a three years' contract, recently signed by the brewery workers with the St. Louis breweries, will be the distribution of \$38,000 additional annual wage.

The Canadian Northern Railway Company has been declared unfair by the Winnipeg Trades Council, and wage-earners are warned against hiring out to the company.

The Builders' Exchange of Vallejo, Cal., served notice upon the carpenters that on and after August 1 their wages would be reduced 50 cents per day. A lock-out is the result.

The Western Union Telegraph Company, of San Francisco, has discharged six of its best operators for belonging to the union, and the Postal Company has secured their services.

Machinists employed by the American Steel and Wire Company at Salem, Ohio, will institute proceedings against the management for discharging them because they belonged to a union.

Between June 20 and November 15, 1907, there were 20 strikes in Japan, involving 3758 employees, and of these strikes 12 succeeded wholly and six in part, while two were "uncertain."

Lieutenant-Governor D. C. Coates, of Colorado, wired the officers of the Cooks' and Waiters' Union, now on strike for a six-day week, that he would come to Pueblo and act as a picket.

Twelve thousand unemployed workmen in Berlin, Germany, engaged in a house-to-house canvass, and found that there were 76,029 persons out of work, and 52,502 others only partially employed.

Farm and orchard laborers have been organized in Santa Clara County, California. Its objects are to maintain a wage scale, and to attempt to oust Japanese and Chinese laborers from the orchards.

The carpenters' strike at Natal, S. A., has been settled, the men agreeing to accept an increase of 25 cents a day, instead of 50 cents, as at first demanded; wages, therefore, are now \$3.75 a day.

Bakers of Ponce, Porto Rico, have won a strike for increase of wages. Blacksmiths and carpenters received better conditions without a strike. Two laws have been passed which are favorable to labor.

The Illinois Steel Company at Joliet, Ill., has advanced the wages of all common laborers and a part of the skilled laborers on the Joliet plant. The increase amounts to an average of about 10 per cent.

Unskilled laborers are very scarce at Cincinnati, Ohio. The wages have gone up from \$1.35 to \$2 a day and even to \$2.25. The city is paying \$1.75 a day of eight hours and many jobs have gone begging.

The strike of the machinists in the Omaha shops of the Union Pacific remains about the same. There has not been one deserter from the ranks, and the locomotive power of the road is being greatly crippled.

After a strike of 40 hours the street railway company and the telephone company of New Orleans acceded to the demands of the striking electric line men on August 4, agreeing to pay them \$3 a day instead of \$2.50.

The mines and ovens of the Montana Coal & Coke Company at Horr and Aldridge are closed by a strike. The men demanded an increase in the wage scale, which was refused by the company. About 500 men are affected.

The strike of the bridge and structural iron workers employed by the Pennsylvania Steel Company, Philadelphia, which has been on since May 1, has been settled. The men were granted their demand for 50 cents an hour.

Brewery Workers' Union, No. 5, San Francisco, has voted additional special tax of 50 cents per member to aid the striking brewery workers of Cincinnati. Heretofore the members have been contributing 25 cents per week.

Laborers for railroad and farm work have not been so scarce in Manitoba for 10 years past. It is also next to impossible to get women for housework. At Winnipeg the demand for working people in every branch exceeds the supply.

The San Francisco Board of Supervisors has passed an ordinance providing that street railway cars shall be operated within the City and County of San Francisco by competent and experienced motormen, gripmen and conductors.

One hundred and fifty Indian fishermen at Neah Bay, Wash., have gone on a strike. The Indians have been receiving 9 cents per fish from the Port Angeles cannery, but the latter

have cut the price to 7 cents, which the Indians refuse to accept.

The locomotive engineers of the C. & O. have notified the company that they will not haul coal from mines where union men are on strike.

The seamen are branching out into Cuba. A branch of the union was recently formed in Manzanilla.

Philadelphia blacksmiths have practically won their strike for a nine-hour work-day, with present wages. Out of the 200 odd shops in the city 181 have signed the union scale. Of the 363 men who went on strike 329 have returned to work in the union shops.

About 15,000 garment workers of New York, who gained their demands, returned to work Monday, while 20,000 who had settled struck again. This difficulty was owing to the fact that 40 manufacturers made settlements with the 20,000 garment workers which the contractors or middlemen repudiated.

President Corran presided at Leicester, England, at the opening of the annual meeting of the British Trades Unions Federation meeting, August 7. He urged an understanding between the workers of Europe and America to meet the effects of international capitalism. The membership of the federation was reported at 419,000.

At the last session of the Kentucky Legislature there was passed a child labor bill fixing the age limit at 14 years, a factory inspection bill providing for two factory inspectors, the legalization of Labor day as a legal holiday, repeal of the turnpike law, a two-week pay bill for miners, and a compulsory examination law for barbers.

June reports of the English cotton spinners shows that the proportion of unemployed full members was 8.6 per cent, as compared with 20.1 per cent in the previous month and 6.2 per cent a year ago. The number of dispute cases dealt with in the month was 13; in the previous month, nine; in the same month a year ago, 13. All were dealt with amicably.

The oil-well drillers of Kern County, Calif., are organizing a union, which will probably be known as Oil Well Drillers' Union of California. This is probably the first union of this kind which has ever been organized.

It is for the purpose of making a uniform scale of wages in the field. About a year ago drillers received \$7 to \$8 per day, and as high as \$10, while today they are receiving from \$4 to \$5, and other oil-field workers in proportion. The organization of this union is now well under way and labor leaders here say it will be completed by September 1. It will probably include 250 men.

Organized labor of Los Angeles, Cal., scored a victory in the Superior Court a few days ago, when Judge Smith, in the criminal department, handed down his decision in the appeal case of A. H. Ryan. Last January Ryan was arrested for parading the streets with a banner upon which was inscribed, "Proprietor of original Mug Saloon is unfair to Organized Labor." He was tried before a jury in Justice Austin's court and found guilty of disturbing the peace; but it was after the jury had been out all night that the verdict of guilty was rendered, and then only on one charge out of six. Judge Smith held that there was no misdemeanor as charged, and that the complaint was faulty.

The strike at the Fernie mines has been settled. The accepted agreement is that the underground day men accept eight and one-half hours a day, and the day to begin and end at the lamp station, which is half way into the faces. All the men must be past this station by 7 A. M., and not to pass out before 3:30 P. M., the only condition insisted on being that if this system after two months' trial is found to be a hardship on the men, the company will dispense with the half hour at noon and return voluntarily to a straight eight-hour day's work. The miners and day men agree to go to work forthwith and the strike existing at Fernie and Michel is declared off.

The annual convention of the International Typographical Union met in Cincinnati last Monday for a session of four days. Most of the delegates seem to favor Washington for the next convention, although Newark, N. J., is a strong rival. It is conceded that St. Louis will get the convention in 1904, and Nashville wants it for 1905. The convention this week will be of unusual interest, as it is the occasion of the golden jubilee. The International Typographical Union was organized at Cincinnati in 1852 after previous efforts in New York in 1850, and in Baltimore in 1851. There are now 550 locals with over 40,000 members. The first local union was organized in Boston more than a century ago.

A calamity faces the business men of Grant's Pass, or a portion of them, at least, on account of a boycott declared by the Federated Trades Union against the "unfair" stores of that city. About one-half of the stores have recognized the union. All members of the Federated Trades have been requested to patronize only these. Tuesday night a special meeting of the Board of Trade and citizens was held to consider the boycott. No decisive move could be made, as those who had recognized the union would not withdraw, and the others were equally as obstinate in refusing to sign the petition of the Federated Trades. A committee of six men, three from the "fair" and three from the "unfair" business houses, were appointed to meet and lay plans for a settlement of the disagreement. The trouble first came about through the business men failing to agree on the hour for closing. The Retail Clerks' Union asked for the hour of 6:30, and the merchants failing to agree on this, a boycott was declared by the Federated Trades against all the stores that did not sign the petition of the clerks. As the Federated Trades is some 800 strong there, the boycott will be serious in its results.

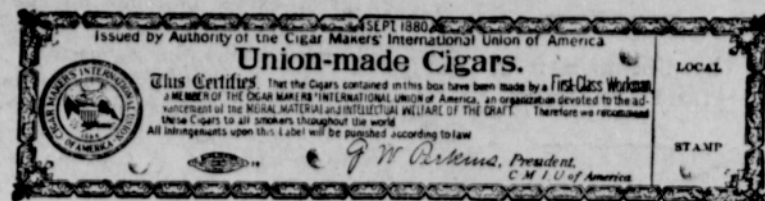
