

CONVENTION CLOSED.

The Printers Finish a Large Amount of Work.

The last three days of the International Typographical Union, held in Washington, D. C., was given to hard work, and a large amount of business was transacted.

The provision in the general laws prohibiting members from accepting work in offices where the proprietor imposes a task or "dead line" was stricken out.

A proposition submitted by Delegate Bacon, of Hartford, looking to the creation of a fidelity insurance fund for the bonding of officers was voted down, as also was a proposition of Delegate Harris, requiring subordinate unions immediately to begin the accumulation of defense funds amounting to not less than \$10 per member.

A pamphlet prepared by the Newspaper Publishers' Association, criticizing the Typographical Union's course in the Seattle and Spokane strikes, was the subject of sharp controversy. Objection was made to the circulation of the pamphlet on the ground that it did not bear the union label, but President Lynch made an earnest appeal for its acceptance and his request was granted by a decided vote.

The convention then, in accordance with a resolution adopted listened to an address by Frederick Driscoll, commissioner of the Publishers' Association, relative to the strikes in the State of Washington, which was a sharp criticism of the union and of President Lynch.

The convention adopted an amendment to the by-laws providing that when requested a representative of the Newspaper Publishers' Association shall be heard on important changes in the laws affecting their interests.

The committee appointed to make a suggestion for a memorial in honor of the late Amos Cummings made a report recommending that an appropriate monument of Colorado granite be erected in the grounds of the Printers' Home at Colorado Springs, Colo. No action has been taken on the report.

Sections 23, 47, 59, 81, 108, 109, 167, general laws, and resolution 9, were stricken out as proposed by the executive council.

Section 19, general laws, was amended by adding that where type shall be cast upon a larger body than the face it shall be measured as the face, and where cast upon body smaller than the face shall be measured as the body, this to apply to hand type only.

The executive council was authorized by a resolution to expend whatever sums may be deemed necessary to unionize Philadelphia.

A large part of the afternoon session on August 13 was devoted to the situation in Philadelphia, the discussion relating to the methods that should be adopted in dealing with conditions there. Nonunion men are in the majority among Philadelphia printers.

The sum of \$2500 was voted for organization purposes in Philadelphia, and another \$2500 if necessary.

The proposition of the committee on laws to have published annually by local unions statistics relative to population, scales of prices, hours of labor, etc., was adopted. Another important proposition adopted permits subordinate unions to incorporate in exceptional cases.

The committee in charge of the matter made a report admitting two reasons. One provides that an appropriation for an assessment of 5 cents a member the month for a period of one year be submitted to a special referendum, the money to be paid to the secretary and treasurer of the International Union and to be used in assisting the Los Angeles Union, No. 174. The other provides that in case of the failure of the adoption of the first plan the executive council should refer the referendum proposal for an assessment of 5 cents per capita a month for one year, the money to be paid to the secretary and treasurer, and by him paid to the Los Angeles strike committee, as they may decide.

Delegate Hays, of Los Angeles, verbally reported in detail that the Los Angeles Union had done everything it could during the last year. Mr. Hays first read a statement by General Otis, general manager of the Los Angeles Times, and then recounted the steps taken by the local union in this contest and gave his opinion as to the success of this fight. The vital point with the union, he said, was to win the boycott against a big department store which was advertising in the Times. He declared that the store was not doing one-half the business it had done.

President Lynch then answered the charge made by Commissioner Driscoll against him in the Spokane affair, after which the convention indorsed the position taken by Mr. Lynch.

August 15, the last day of the convention, was a busy one. A vast amount of business was pushed through, including the committee reports on label, allied trades and the eight-hour question. The last-named committee noted the progress made during the last year in the eight-hour movement, and favorably reported the following resolution, which was adopted by the convention:

"Resolved, That the committee on eight-hour day be instructed to notify local unions which have not already obtained the eight-hour day or made contracts binding them to its provisional institution, that it is the sense of the International Typographical Union that they make effort on January 1, 1903, to obtain the eight-hour day, according to plans deemed most expedient by said local unions in their several localities."

E. J. Bracken was elected fourth vice-president, and P. S. Neuberger was elected delegate to the American Federation of Labor. A resolution providing for the appointment of a committee whose duties it shall be to inquire into the relations of taxation to wages, and the advisability of nationalizing the trusts and monopolies, and report its finding in the Typographical Journal, was adopted.

The action of the convention regarding the Cummings memorial provides that, if sufficient funds can be raised for the purpose within a year, that a library building be added to the Printers' Home, to be known as the Cummings Memorial Library, instead of erecting a monument.

The Woman's Auxiliary took up the fight of the Typographical Union against the Los Angeles Times, and, after much discussion, decided to ask advertisers in that paper to withdraw their patronage.

After voting to hold the next annual meeting in St. Louis in 1904, the following officers were elected: President, Mrs. F. L. Kennedy, Omaha; secretary, Mrs. Edward Dunnell, Cincinnati, O.; first vice-president, Miss Laura Gordon, Washington.

The principal feature in the proceedings of the woman's auxiliary to the Typographical Union was the decision not to hear an address in support of female suffrage, which Mrs. G. A. Lockwood requested the privilege of delivering.

At the meeting of the stereotypers and electrotypers a committee was appointed to organize subordinate unions in the Philippines and to investigate the possibility of organizing in the Hawaiian Islands.

End of Labor Unions' Trials.

"Unless my judgment is as fault and my faith unfounded," says Judge Gray, who was president of the Anthracite Coal Commission, "labor unions will soon have passed through their period of trial and tribulation, and will emerge on a bright and sunlit plain, where true American character, the fruit of American individual liberty, will illustrate the worth of our institutions."

"Purging themselves of every antisocial and unworthy element, recognizing in others the rights they claim for themselves, with malice toward none and charity toward all, subordinate to law; with a full sense of their responsibilities as American citizens, and making their appeal to the public opinion of the country, as our fathers made their appeal, they will be held in the time to come, by employer and employed, as powerful coadjutors in the maintenance of American ideals of free government among men."

"I am encouraged in all this by the recent experience of the manner in which those engaged in your great dominant industry have, in the main, received the award of the arbitration tribunal, by which they agreed to stand. Mine workers, as well as employers, whose differences were submitted to arbitration, have maintained their self-respect by manly adherence to their plighted faith."

"No disappointments as to results have served to shake, as far as I know, the determination of those men to make good their word and deserve the encouragement they have so abundantly received from a sober public opinion."

"A free and untrammelled press is a powerful influence for good. It is a reflex of public opinion, which, on the other hand, it helps to mold and direct. We all live today under its calcium light, and the growing sense of responsibility on the part of those who conduct it is new ground for hopefulness as to the future."

"We sometimes resent its invasion of our privacy, its mistakes and false judgments, and in our anger at the original offender we are apt to forget the beneficence of the institution and think we pay a high price, a very high price, for the untrammelled freedom of the press. But do not let us forget that we have received a hundred-fold return for the price we have paid."

"Through it mainly does public opinion exert its salutary influence, and through it largely are exploited the true defenses of the individual and personal liberty."
