

HOW IT WAS DONE

your request—for three days. We were requested, thereafter, by your Honor to meet you in the matter.

"We feel it incumbent upon us under these circumstances not only to comply with your request, but to extend our proposal to the men till 3 o'clock on next Wednesday morning, in the meantime the statu quo to be maintained; and further, to emphasize our attitude toward our employees we gladly accept your suggestion that the following words be embodied in our proposal, constituting the fortieth and final clause thereof:

"Section 40. The company fully recognizes the union, as provided in this contract, and will not, directly or indirectly, interfere with or prevent the joining of the union by any man employed by the company after the date of this agreement, and it will be entirely satisfactory to the company if he should so join—the company will neither discharge nor discriminate against any employee because of his connection with the union, nor for any participation in any of the discussions or differences arising out of the present or any past controversy between the company and the union to the date of adjustment.

"When any member of the union shall have been discharged (except for failure to register fares) the president of the union shall be notified and if in the opinion of the union the discharge is unjust, the matter shall be taken up with him and the member in question by the officers of the company having in charge the employment and discharge of men."

"It is understood that one of the terms of this extension and addition is that the contract be for one, two or three years, as the union may elect within the time above limited.

"Very respectfully,
"Your obedient servants,
"The United Railroads of San Francisco. By its Executive Committee.

"Attest: Geo. B. Willcutt, Secretary."

When the Mayor had concluded the reading of these documents, a member arose and asked him, "Mr. Mayor, would you ask your own union to accept this proposition?"

The Mayor—I would not ask this union, nor any other union, to accept anything I would not ask my own union to accept.

President Mahon—Mr. Chairman, I want to have a thorough understanding here and now between this organization and the Mayor with respect to the exact terms and meaning of the proposition that he has presented to us tonight. (Applause.) Now, men, there should be no interruption, no matter of what nature. We are here to transact important business. In fact, the importance of that which we have to do tonight cannot be exaggerated, and whatever we do, let us do it in a cool, calm, business-like manner. Mr. Mayor, I want to ask you some questions. We know, and probably you know, that the company has brought quite a number of men here to act as strike-breakers. Now we want to know, what is the attitude of the company in regard to these men? If we accept this proposition, will the company ask or expect the members of this division to work with these strike-breakers?

Mayor—I will say that I have discussed that matter with the company, and this is their position, as they have stated it to me: The company has agreed verbally that it will not knowingly, during the life of this agreement, employ either strike-breakers or men known to be hostile to the union, to work in any capacity when members of the union can be had who are eligible to fill the positions.

President Mahon—Mr. Mayor, will you give this organization your support as Mayor of the city in compelling the company to live up to that agreement?

The Mayor—I certainly will give the union my support in maintaining the terms of the company's promises.

Mr. Mahon—Mr. Mayor, our men have complained that the company has, in the past, discriminated against them because of their connection with the union. You have said to us here tonight that the company will carry out its contract in good faith. While the language of the agreement proposed refers to the past, how about the future, and if there is any discrimination against the union or against its members, what will be your position?

The Mayor—I understand, Mr. Mahon, what you have in mind, and in that connection I want to again read the proposition of the company. (The Mayor then read the clause regarding discrimination.) Now I want to say to you, members that if the company does not carry out the terms of that promise, that it certainly would be a breach of faith. They would not be keeping good faith with you, nor would they be keeping good faith with the people of San Francisco, and I will say that I will do anything in my power to compel them to keep good faith in this matter. I do not know, and cannot now say just how I could compel them to live up to their promises, but this I will say, that should the time come that they break faith, then "I will go to the bat."

Mr. Mahon—Mr. Mayor, I do not want to be technical, but this is an important matter, a vitally important matter, and I want to understand this proposition, thoroughly. The company says it will not discriminate against union men. As a matter of fact, they have in the past. You say you will see that they will not, hereafter, as far as it lies in your power to prevent them. Now, sir, how far will you, or can you go in the matter?

The Mayor—I will hold the com-

pany to the terms of this agreement fairly and squarely. I consider that it was made with me as well as with your organization.

Mr. Mahon—I want to try to cover this entire question in one proposition, so that no doubt whatever may remain in the minds of any of our men regarding the nature of the agreement. Mr. Mayor, I do not question your sincerity in this matter, and I do not question the sincerity of the railroad company, although I want to say that I have been doing business with railroad companies for many years, and I have found that there are times when they need close watching. Now I want to know the proposition. That is, will you see that they carry out the terms of the contract, and if they discriminate against the members of this organization, will you stand with the men?

The Mayor—Yes, sir, I most certainly will stand with the men if discrimination is attempted or practiced.

Mr. Mahon—Now, Mr. President, I desire, while the Mayor is here, to make a brief statement in the name of the international organization. The matter now before this division is, of course, subject to a vote of the members to be taken tonight, but I want to say in regard to what has occurred, that last Saturday night, when the mayor of the city appeared before us and asked for delay, I was surprised. As a matter of fact, I did not like it. I feared more than all else that demoralization of the men would result, and I as well as the officers pleaded with the men to keep cool and consider the matter then before them calmly and dispassionately, and the action of Division No. 205 on that night shows that it comprises a well-disciplined body of men. Now we know how the company in the past has discriminated against the men of this organization. That is a fact that I have knowledge of through personal investigation made since I came to this city. We have shown to the officials themselves by men working today for the company that discrimination has been practiced. We have shown that General Manager Chapman in hiring men questioned them regarding their disposition toward, or affiliation with, unions. Men have been discharged and laid off because of their activity in union affairs. The actions of men in taking part in discussions on the floor of the meeting of the union has also caused discrimination against them. Now I, as I said before, do not want to indulge in technicalities, but I do want to protect the membership of this organization. The proposition before you tonight has been thoroughly discussed by your executive board, and you will soon come to a vote upon it, but I want to say to the mayor, before he retires from this hall, that if this proposition is accepted the street carmen will expect the mayor of San Francisco to see that its terms are fairly and honorably lived up to, and Mr. Mayor, if you do not, you will find the members of 205 rapping at your door in the city hall and telling you in no uncertain terms that you must see that that the other side lives up to its agreement, and, sir, in that event we shall certainly expect you to stand with us. And I further say that if I am called here again because of any violation by the company of its agreement made to this division, I, too, shall try, with all the power that is in me, to see that you carry out your promises to this organization.

The Mayor—Mr. Chairman and Members: I want, before I retire, to say, I endorse everything Mr. Mahon has said. This is a serious matter. I realize thoroughly that if I cannot succeed in making the company live up to its agreement, the hand of every member of this organization will be raised against me. I certainly will stand with the union to compel the company to live up to its agreement. If I do not, I realize that not only will this organization resent it, but that nine out of every ten of the citizens of San Francisco will also resent it. Now, then, I ask you to do what you think is best for the interests of all. I realize the confidence you have given me, and I pledge you that I will show you by my actions in the future that I thoroughly and heartily appreciate it. (The mayor then retired.)

President Cornelius—Brothers, you have heard all that has transpired and understand the question you are now called upon to decide. The hour fixed for the vote is now close at hand. What is your further pleasure in this matter?

Several members declared that quite a number of men had come in late and did not fully understand the proposition before the union.

Secretary Bowling took the floor, and said: "Brothers, you all understand the terms of the company's last proposition, the proposition you voted on last Monday. Now the proposition before us tonight is identically the same, with the addition of one clause, section 40, which I will read to you." (The secretary then read section 40.)

President Cornelius then read the former report of the mayor, and also the letter sent to the mayor defining more exactly the company's attitude on the discrimination question than the formal language of section 40 does.

A member then demanded to know what the position of the executive board of the union was on the question, saying that the union had heard the mayor, but the men wanted to know what their executive board thought about the matter, and the men, having confidence in the board, would undoubtedly be guided by its judgment in preference to that of anyone else. "What recommendation, if any, has the executive board to make to the men?" asked the member.

President Cornelius—As chairman of the executive board I will say that the board has considered this proposition, and that it recommends, in view of everything that affects the situation, that this organization accept the proposition presented by the mayor of San Francisco.

There was some further discussion of the proposition, and it was then decided to take a rising vote on the adoption or rejection of the agreement to run one year. When the vote was taken, but nine men in the hall arose when the negative vote was called for.
