

# CANDIDATES WITH UNION CARDS

## A CHANCE TO ELECT YOUR OWN PEOPLE



JOHN L. DAY.

Candidate for the Republican nomination for constable, West Side.

"Jack," as he is always called, has been a resident of Portland for the past 19 years and has always been a hard worker. For the past eight years he has been employed by the Portland General Electric Company. He is affiliated with Electrical Workers' Local No. 125 and is one of their representatives in the Trades Council. He is also a member of the Oregon Labor Party and has been recommended for endorsement by their executive committee.

Should Mr. Day be nominated, and from every indication he will be, he will go into the office unpledged to any broker, collection agency or political ring. He says, "I am making a single-handed fight against the graft which is being carried on by an attaché of the office at the present time. More publicity is needed and I will see that it is obtained. My platform is prompt personal service, law enforcement and opposition to graft."

### A PLEDGE TO THE PEOPLE.

Promises to Subserve Their Interests First, Without Partiality.

The following letter promising faithful performance of official duty to the people of Multnomah county, if elected to office, is being sent to the various labor unions in the city and county:

Portland, Ore., April 5, 1906.

Gentlemen—Having become a candidate for the nomination as County Judge in the Republican primaries to be held on April 20 next, I most respectfully solicit the support of all Republican voters in the county and in so doing consider it fair and right to set forth my attitude and position on some of the most important political and economic questions that are being presented to taxpayers and voters.

If I am nominated and elected as County Judge, I pledge myself to the people of Multnomah county, each and every one, upon my word of honor as a man and as an attorney to faithfully and honestly and as economically as possible, serve their best interests at all times, to hear and determine all matters that may come before me, fairly and impartially, without fear of favor, toward all men alike, be they rich or poor. ## RAILROAD ATTORNEY

TAKEN FROM THE

Senate Journals of 1903 and 1905, While Serving as State Senator

John L. Rand aspires to the nomination for Congress in the Second District, and asks the support of the bread-winners and the common people in face of the fact that he is a RAILROAD ATTORNEY, a "machine" politician, a corporation hireling, and as State senator opposed every labor bill introduced in the Senate or reported from the House, as is attested by the following record, taken from the Senate Journals of 1903 and 1905:

### HE FOUGHT THESE BILLS.

1903

Senate Bill No. 66—Relating to liability of masters to servants.  
Senate Bill No. 115—Relating to the Associated Press—to declare it a common carrier in the State of Oregon.

Senate Bill No. 148—Making eight hours a day's labor on public roads.  
Senate Bill No. 149—Making eight hours a day's labor in certain occupations.  
Senate Bill No. 210—Relating to the employment of convict labor so as not to compete with the products of free labor.

House Bill No. 39—Limiting the employment of females to ten in every twenty-four hours in any mechanical or mercantile establishments, laundry, hotel or restaurant, and to provide suitable seats for them when they are not engaged in active duties of their employment.

House Bill No. 146—To prevent blacklisting of mechanics, unskilled laborers and other employes by a corporation, company, or individual.  
House Bill No. 147—To prohibit the use of deception, misrepresentation, false advertising, and unlawful force in the procuring of labor in the State.

House Bill No. 148—To protect employes and guarantee their right to belong to labor organizations.  
Senate Bill No. 19—To provide for liens on railroad property.  
Senate Bill No. 24—Providing for direct primary elections.  
Senate Bill No. 157—To license and regulate employment offices.  
House Bill No. 74—Railway fellow servant bill.

1905

Senate Bill No. 38—A bill for an act making eight hours a day's work on public works.  
Senate Bill No. 50—A bill for an act to allow employes to maintain action against employers.  
Senate Bill No. 70—A bill for an act to protect the lives of the traveling public by limiting the hours of service of certain railway employes.

Senate Bill No. 174—A bill for an act to amend certain sections of the act making effective the Initiative and Referendum.  
Senate Bill No. 239—A bill for an act to grant to municipal corporations the power of the Initiative and Referendum.

If you have any doubt of the correctness of the above facts, look for yourselves in the Senate Journals of 1903 and 1905.

The above is a copy of a hand bill being distributed throughout the Second District by members of organized labor.

### Chinese Slave Traffic.

Slave traffic in Chinese women is increasing and Secretary of Commerce and Labor Metcalf has issued orders to the Bureau of Immigration for an investigation. Inspectors are to begin work at once in San Francisco to find the slave dealers who have smuggled Chinese women and girls into this country.

For nearly a year past the number

of women who were represented to be the wives of American-born Chinese have been getting into the country by way of the Mexican and Canadian borders and have gathered at San Francisco. Inspectors have been unable to find the alleged husbands of these women, and the Secretary issued instructions that these men and their white allies who got the Chinese slaves into the United States shall be found and prosecuted.
