Since You Asked.....

Everyone has been asking lately, just what doe's a Code Enforcement Officer do? Well here is the answer to everyone's questions. It has been requested in our community for a simplified clarification of the new Butte Falls Code Enforcement Officer's (CEO) duties and responsibilities.

The BF CEO is responsible for enforcing Butte Fall's municipal code violations. The CEO will issue citations and will respond to complaints of such violations. He/she will prepare reports when necessary on criminal activity to be forwarded to the Jackson County Sheriff's department for review and prosecution when appropriate. The CEO should be looked upon as a conduit to law enforcement. The CEO will not arrest or detain persons accept under extreme circumstances using the same authority as any citizen with citizen arrest power. He/she will assure that accurate and probative information is obtained to assist law enforcement by means of reports and/or other documentation. The primary goal is to deter persons that disrespect the law within the town. That will be accomplished by visible patrol within the town in a marked enforcement vehicle. If vehicle code violations such as speeding are repeatedly observed, notification will be made to the court and citations will be issued by mail or otherwise. Appearance in court will be required. The CEO will respond to events when requested and appropriate.

The duties and responsibilities of the CEO are multiple and extensive and include: curfew, burning, school patrol, dogs at large, etc. A copy of duties and responsibilities can be obtained at Butte Falls City Hall.
