**WE SHOULD BE READY**

People in many states are interested in the western part of Lane county and the whole coast country that is to be opened by the Willamette Pacific Railway which is building from Eugene to Coos Bay. Especially are hundreds of people of our own state looking forward to the time when they can come to the Siuslaw country by train. This desire is expressed on all sides, by people from all parts of Oregon and the North west, whenever they meet residents of this section. Most of these people are coming with a desire to invest or locate. This means the advancement and development of our towns and communities. This is what is wanted. This is what is necessary.

A large number of the residents of the Siuslaw are its pioneers. They have waited a long time. Years ago railroads were built on paper to this valley, but never materialized. Now a road bed is completed from Eugene to Mapleton, bridge piers built, steel bridges, rails and building material at Eugene to be rushed in when the laying of rails commences.

The pioneers who identified themselves with this country are deserving of great praise for the work of development they have taken part in, but the job is not finished, it will never be finished. Communities like human beings must advance, and grow, or deteriorate and disappear.

Newcomers are necessary to growth because they bring additional capital and energy. Few communities have been established and existed as towns and business centers, without their pioneers having had just as high ideals of progress as any who come later, but the task of development becomes greater and must have more people and more capital back of it each year.

A town should do something each year to advance its growth. It takes the united effort of the majority to do this. It cannot be best carried to success by new comers alone, neither can

it be accomplished by a few pioneers. There should be no prejudice harbored because of this. Yesterday the pioneers were new comers, to tomorrow the newcomer will be pioneers. Today we need action, and it ought to be concerted for the best interest of all.

Next year the Siuslaw will have to make good, as a country having attractions for the investor and home seeker. What has been done will go a long way toward proving what can be done. It is our business to do that which will attract those interested and convince them that our resources are worth investigating.

There will be at least one on large business center on this river. Just where it will be, many question. At present Florence has a most favorable outlook, but not a cinch. With the present advantages, if she does not keep the lead a large share of the blame can be charged to those living here at the present time. If she does keep the lead, which by right of priority is hers, those who are now indentified with Florence will be repaid for their efforts.

While there will be some jealousy between the towns on the Siuslaw, it is not necessary. Each can help the other. It is better that there should be competition and rivalry, as in this manner the best will be developed by each one.

Of all questions the paramount one is the development of the Siuslaw, and this can be retarded by inactivity. It is time we were getting ready to play the host to the people who will come with the railroad.

Five measures that were passed by the Oregon legislature after a thorough discussion of the merit and demerit of each one, have been brought before the people under the referendum. The only arguments presented in the pamphlet, as provided by law, are in favor of the University appropriations. In no case is a negative argument given. It looks as though those instrumental in calling the referendum had no good reason for doing so. They have just put an expense to the people of the state, believing that by chance there would be secured the satisfaction of revenge or indorsement given to selfish interests. Is this right?

The University of Oregon belongs to the people of Oregon. It is your friend. You should be a friend to it. You can show your friendship this year by voting (300. Yes) and (302. Yes). Don't forget, or you may regret.
