A WOMEN'S ORGANIZATION NECESSARY

Voters who register as independents, or who give no party preference, should remember that they will not be able to participate in the primary election, for Oregon's nominating election is conducted through the medium of parties. Voters who register as Republicans must vote as Republicans, those who register as Democrats must vote as Democrats, etc. Independents and noparty voters have no label under which they may vote in the primaries.

ELECTION DATES ARE GIVEN

Secretary of State Olcott has sent to all candidates, county clerks and other persons desiring pamphlets containing a digest of the election laws for use in the coming primary and state election campaigns. The pamphlets give the necessary information for the guidance of candidates and county clerks.

The new pamphlet shows April 10 as the latest date upon which nominating petitions for members of the national committee and United States Senators, Representatives and all state officers can be filed.

April 14 is the latest date upon which county clerks may mail printed notices of primary nominating election to the judges and clerks of the various voting precincts.

April 15 is the latest date upon which nominating petitions and notices of candidates for county, district and precinct # offices may be filed with the county clerk.

April 23-25, the county clerk shall arrange names of and other information concerning candidates, file in his office and post a duplicate therein and proceed forthwith to have official ballots printed as provided by law.

Day before primary nominating convention, or May 1, county clerk is advised by attorney Class general to close registration books.

May 4, county clerk shall designate voting places and fill all vacancies on board of judges and clerks.

May 9, latest date before primary election upon which clerk shall deliver to sheriff voting supplies for various voting precincts.

May 13, latest date upon which the sheriff shall take charge of voting places designated by county court.

May 15, date upon which county clerk shall close registration books and of primary nominating convention. Pools open at 8 a. m. and continue open until 8 p. m. Judges, at their discretion, may adjourn at 1 o'clock for one

The boys and girls of Oregon who will earnestly strive to make themselves proficient in potato growing, raising corn, vegetables or pigs, sewing, cooking and baking, or in keeping farm and dairy accounts may find themselves entitled to a reward well worthy their best efforts. The Agricultural College, co-operating with the State Superintendent of Schools, is planning to give to at least two boys from each county in the state a trip to Salem for the entire week of the State Fair. In addition, at least ten of the highest scoring prizewinners will have all their expenses paid on a visit to Panama-Pacific Exposition at San Francisco next year. It is expected that industrial clubs will be organized in nearly all the schools of the state and these clubs will be entitled to bulletins and information and advice of every sort regarding any line of work they may decide to take up. In the gardening contest fractional tracts must be cultivated and accurate records of every detail of the work and its results must be kept. It is hoped that a large percentage of all the school children in the state will take part in this contest.
