To this command she adds that a new volume of her own, just published, the result of of natural selection is the best means of promulgating the faith, and then says: "The Bible, 'Science and Health,' with 'Key to the Scriptures,' and my other published works are the only proper instructors for this hour. It should be the duty of all Christian Scientists to circulate and to sell as many of these books as they can." Those who disobey this command are told that they will be liable to lose membership in the church. Another order is given, that, when her "Science and Health" is read in church, the title of the book and its author are to be announced only once; but this calls attention to the fact that "Science and Health" is treated very much in the same way as the Bible, and is, apparently, put upon a basis of equal authority. The autocratic tone of these orders leads to the query whether a female pope has arisen in this country. Or is it to be assumed that Mrs. Eddy is a sharp business woman and has taken means to secure for her new book the largest sale possible? In any event, these orders are astonishing indications of how one of the most liberal of sects can be made to vield obedience to the autocratic command of a religious leader.-Christian Register.

### Queries.


