The ongoing exchange between the community of Cannon Beach and the Cannon Beach Police department is the item of discussion on every bench, in every bar and coffee shop in town. If you don't know of someone who has personally been upset with the local police force then you have probably read about it in the paper.

Many people are aware of the flyers that have circulated through town and the local tabloid (The Gazette) has been full of letters both in favor of and condemning the C.B.P.D.'s efforts in

law enforcement.

Volume 17, number 8 issue of the Gazette contains a letter by the C.B. City Manager , John Williams. The letter is sympathetically entitled "City Manager seeks information," what an appropriate title. Mr. Williams is expressing "great concern" over the exercise of freedom of speech and it would appear by his letter that he is not only surprised by the flyers touting the slogans IMPEACH THE CHIEF and RESTORE OUR SENSE OF COMMUNITY (the latter conveniently left out) but that he is completely unaware that any potential problems exist. Or is he?

The first paragraph of the letter clearly states the letters objective: identification of the party(ies) responsible for the flyers. A curious approach for one who is as he states himself "ultimately responsible for the operation of each of the city's departments." The obvious step is to research the complaint files of the C.B.P.D., not to question the flyers information and seek the party(ies) responsible.

What then is the true motive of Mr. William's letter? Is it seeking accurate information on a department he is responsible for, or looking to smooth over a blatant problem with the actions of the C.B.P.D. ?

Mr. Williams is very concerned with identifying the "substance of the allegations" personally with the party(ies) involved so that "appropriate investigations may be conducted and if recommended, the necessary changes be implemented." We can only suppose that he is unaware that in instances of "possible" police misbehavior that the police investigate themselves and also decide the best remedy for the perceived problem (read best remedy to console the public rapidly). Please.

It would appear that the flyer printer(s) need not come forward and identify him/her self or themselves under "every effort ...to honor their confidentiality." Mr. Williams need only drive a rusty car through town in the evening to obtain the information he is seeking.

I believe the days of the political passivity in Cannon Beach are coming to a close. A toast (burnt and scraped) to the agents of change in Cannon Beach! The scrapings to the oblivious managing units of the established city government. Become part of the community and understand the problem instead of trying to manage it like a sheet of numbers or a game.
