ODOT Silences Environmentalists: Format for March 3 Hearing Eliminates Public's Speeches

Oregon Department of Transportation (ODOT) will hold an informal open house style public hearing beginning at 4:00pm on Wednesday, March 3 at the Maritime Museum in Astoria, about the \$5.6 million project to reconstruct 3 miles of Highway 30 from Fern Hill to the John Day River Bridge between mileposts 88.1 & 91.1. The hearing will continue to 8:30pm, but attendance will likely diminish by 6:00pm.

The Fern Hill -- John Day project is the first of four Clatsop County highway projects exceeding \$80 million scheduled to be built during the next five years, the designs of which have not gone through the public hearings process. The other projects are the \$30 million Astoria bypass, \$27 million Seaside "parkway", & the little known \$20 million Clatsop Plains freeway.

The March 3 hearing will be the first opportunity most of us have had to see ODOT's plans for this project. ODOT's strategy in dealing with the public is to keep a low profile until its political ducks are in a row. Though open public involvement in the design process is mandated, ODOT tries to have project designs as nearly as possible set in stone before the general public is informed. ODOT wanted to skip the Fern Hill - John Day public hearing altogether, but under protest scheduled the upcoming hearing.

To eliminate outcry of dissenting viewpoints ("grandstanding by a vocal minority") ODOT has devised an extended informal "open house" hearing format statewide that fragments the public & eliminates the open expression of ideas before a seated public assembly. Posters and maps are displayed around the room. To discourage assembly and round table discussion, all but a few chairs are removed from the hearing room. Friendly ODOT representatives will stand around the room to talk with you. You will be able to step aside to speak to a court reporter instead of, not additional to, speaking before assembled citizens. As part of a fragmented and quieted public, you will miss hearing and building on the ideas of others. ODOT may or may not bring multiple copies of the Environmental Impact Statement for on the spot review. Probably not.

Before attending, try to take a fresh look at the unmodernized remainder of old Highway 30, the object of much unquestioning public consternation, and the strikingly beautiful countryside through which it winds. What would you recommend be done to improve the road for commuters, tourists & all of us without degrading the environment? What would be destroyed in the path of ODOT's preferred alignment, soon to be unveiled to us? Would ODOT's un-preferred alternative design -- that neither of us has yet seen -be less destructive of farmlands and other resource lands?

See you at the hearing, such as it will be! The process of public involvement must be improved so environmentally sensitive less devastating alternative designs can be developed with the help of an informed public. ODOT's management need not fear involvement from a fully informed public. The public anger they seek to suppress directly results from the suppression itself.

Conserve Clatsop County's dwindling resources!

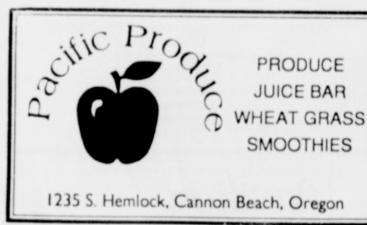

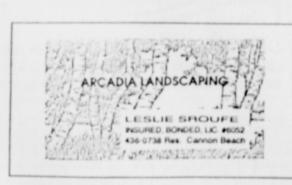

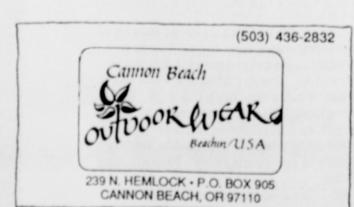
