Thanks! you folks have done it again! In the face of imminent peril you have allowed us to survive for a while longer. The response to our year end statement was wonderful. We have even had folks ask for a rate increase for their ads — eat your heart out Oregonian! Below you will find our Year End Statement for our advertisers, and our supporters. We also would like to draw your attention to our subscription rate increase. Due to the coming postal rate increases and the cost of handling, NEW subscriptions to the Edge will be \$30, renewals will, of course, remain at the same rate at which you originally subscribed. We do have several folks whose subscriptions have expired. If your Edge bag and/or copy have an Upper Left Coast Productions stamp on them, you can assume it is time to renew. We appreciate your support.

In April, our THIRD anniversary, we plan to do an issue that focuses on the people who make the Edge happen, our advertisers.

As you know, the advertising policy of the Edge is to support businesses that are supporting the community and the planet. Our object is to help our readers find our advertisers, so our advertisers can continue to afford to support the community and the planet, and of course the Edge. We do not wish to cause our advertisers any hardship, especially small operations with one or two folks working together. We know how hard it is to sometimes decide which bill to pay. If it is between the phone bill and the Edge, pay the phone bill! If your rate is too high, contact us and we will talk. If you have had positive or negative feed-back about the Edge or your ad, please, let us know.

We think you have the right to know what we do with your money, so here is a breakdown. Each issue costs \$572 to print at Tualatin Yamhill Press in Hillsboro. Coyote Dist. gets \$50 to cover the Portland, Salem, Corvallis and Eugene Area (a rate increase is due). Postage is approximately \$150 per month to mail papers to folks up and down the coast from Newport to Astoria, and our subscribers in 22 states and Australia. We also on occasion pay our regular contributors a small honorarium of \$5 per article or trade out for subscriptions. We often must make PMTs of photographs and reductions of graphics etc., which averages out to about \$10 per issue. plus phone and envelopes and general office stuff. This usually ads up to about \$900 to \$1000 per month. Where does that money come from? Mostly from you, but if you look at the January Edge you will see approximately !!! ads and at \$20 each, we should be making in excess of \$2000 or \$1000 profit. Well, not really. Of the !!! ads. 36 are free, folks that we believe our readers should know about in spite of the fact that they can't afford the cost of an ad; 16 are public service ads, like KMUN, KBOO, and various non-profit estabishments and events; and 11 are barter -- we trade for help in distribution, or for articles, or what have you. That leaves 48 paid ads. And, no, they are not all \$20 ads, some are \$30, our most expensive so far is \$50, but some are as little as \$6. So, as you can sees the \$1000 nut is not always so easy to crack each month. Last year the Edge ended up \$2000 in the hole, but we believe we have made a difference. And as we grow and more people read us and support our advertisers, we believe a lot of our free ad folks will be able to contribute. and help us get our head above water.

Last year in our "Year End Statement" we said we were trying to grow to 16 pages and 5000 copies per issue. With your help we have reached that goal, and we are now aiming at 20 pages and 7000 copies as we approach our third year as an alternative voice on the Upper Left Edge of America.

Happy New Year, and we look forward to working and growing with you in 1994. We can't do it without you, so keep those checks coming!! Thanks.

Dear Editor

I attended the Seaside Planning Commission Meeting on Tuesday, January 4, 1994. One of the ajenda items was a petition submitted by Oregon Natural Resources Council. This was a request asking the Planning Commission to initiate a zone change at the high salt marsh located on Cascade Trust property slated for the, so called, Sahhalie Condominiums.

Presently the zoning for this important salt marsh is illegally designated as A-3. This is a zone designation indicating a freshwater coastal lake. To date, the City of Seaside has not been able to sustantiate this erroneous zoning with proper documentation, but for development purposes, continues to process this most significant salt marsh on the lower Necanium under false quide lines.

The O.N.R.C. petition presented to the Seaside Planning Commission could have started the process for designating the tidally influenced marsh as A-1, Natural Aquatic, as it deserves. This proposal was quickly swept to yet another corner, with the Commissioners deciding to consider zone changes at their upcoming wetlands review and workshop. Another missed opportunity in the name of politics as

I urged the Planning Commission to consider the possible liability issues of the Cascade development proceeding with bridge building, under the false guide lines of a freshwater marsh. Building standards should conform to this fact. There seemed to be little concern forthcoming from the Seaside Planning Commission, but what can we expect?

The record stands for itself. Seaside will

continue to accomodate development to the detrement of our most significant natural resources. If you decide to do anything about it, be prepared for a discouraging experience. I'm now convinced! Little environmental protection will be effected in Seaside until the current office-holders, Council and Planning Commission, are changed.
