We phoned the two candidates for Mayor and asked them sixteen questions. We then sent a copy of the questions and our notes of their answers to them so they could elaborate on their answers. These are the results of that process. The questions appear in plain type, the answers given over the phone are in Bold type and their written elaborations are in Italics. Where the answers were the same we have left out the redundancies for the most part. Where the wording has been changed we have supplied both versions. In the written answers we have included grammatical errors and mispellings, because we believe it is valid information that could help people determine their choices. We will endorse a candidate in our November issue. We hope this helps our readers better understand these two middle-aged white men who wish to represent Cannon Beach in the office of Mayor. Kirk Anderson: 595 N Elm, 436-1174 Arrived '78. 1990 elected to council, served on Park & Comm Serv. 3 1/2 years Comm., 2 yrs as chair. Works at the Driftwood Inn.

Questions: How do you feel about and/or what should the city do about the following;

- 1.) Wetlands protection: Protect all we can.
- 2.) Dunes: Support overlay plan, and the Grading plan if it includes the total beach, not just parts. The provision for remedial grading is important as it allows homeowners to protect their property on an individual basis.
- 3.) Short term rentals: Supports
 Ordinance, serves on review
 committee which will fine-tune the
 ordinance.
- 4.) Motherhood: Yes. I'm married to
- 5.) Apple Pie: Tes, especially when made with Granny Smiths.
- 6.) City services; police, public works, energy committee: Proud of Recycling efforts, the Information officers, the Police department, fire department, shuttle, lifeguards, and the public works department. The Park maintenance is superb.

Questions: How do you feel about and/or what should the city do about the following:

1.) Wetlands protection: In fapor of

protection, but feels different levels of wetlands should be treated differently. I om in favor of protecting wetlands but feel different priorities of wetlands should be treated differently. Let me explain. In Cannon Beach's study wetlands are classified as significant or unsignificant with priorities of high, medium and low assigned to each site surveyed. The sites that were assigned a overall high rating were for the most part a true wetland and I agree that sites with an overall rating of high should be protected. Ratings of low and medium are assignments where they did exhibit some characteristics of wetlands such as plant growth but never were rated as critical so to get a rating of high in those ratings are some wetlands where the reason why they are wetland is drainage from development on adjacent lands. I feel C.B. Planning Commission should revisit the Wetlands issue and determine if those sites in low and medium priorities are significant wetlands. I would like to see the city protect the high priority of wetlands but would like the decision on Med & low priority wetlands left up to the Corp of Engineers or the Division of State Lands. I feel we have a responsibility to wetland owners to relook at low & medium priority wetlands. I do not support regulating low and med priority wetlands.

2.) Dunes: In favor of protection and preservation, but feels a homeowner should be allowed to push sand back on to the beach away from a home, but should not be able to remove sand from the beach. In favor of protection with exceptions. I feel an oceanfront property owner should be allowed with the proper permits to push sand that is inudating their homes back to the beach, but should not be able to remove sand from the beach areas.
