"16 YES Allows terminally ill adults to obtain prescription for lethal drugs. No Cost. Death With Dignity is opposed by the Catholic Church's Oregon Catholics for Life PAC and they sight Michigan Judge E. Thomas Fitzgerald who said " The guarantee of personal privacy has been extended to activities relating to marriage, procreation, contraception, family relationships, and child rearing and education." Judicial discovery of a right to terminate one's life is not a logical extention of this catalog of rights." Excuse us? You marry, have babies, raise kids, send them to school, then you die, right?
