MEETING HIGHLIGHTS CITY COUNCIL JANUARY 3

- +New Councilors Frank Little and Laurel Hood took the oath of office along with Mayor Kirk Anderson. Councilor George Shields and Mayor Herb Schwab were presented with certificates of appreciation for their service to the community.
- +Held an on-the-record appeal by David Brands of the Planning Commission's approval of SR 94-07, Steve Martin setback reduction application in conjunction with the construction of an additional story on the Surfside Motel. The Council, by a 2:1 vote (Councilor John Buckley was absent and Councilor Frank Little stepped down from consideration) overturned the Planning Commission's decision and denied the setback reduction request. (A)
- +Held a public hearing on a proposal to install sidewalks on the south side of Sunset Blvd between Hemlock Street and Spruce Street and directed staff to carry out the improvements. Another component of the recommended sidewalk improvements will be constructed in the near future to continue the sidewalks on the south side of Sunset Blvd under the Highway 101 overpass to connect with Elk Creek Road. (B)
- +Held a public hearing and adopted an ordinance amending the Zoning Ordinance to permit the installation of microwave receiver dishes with a diameter of 30 inches or less.
- +By a vote of 2:2, failed to adopt final findings of fact for an ordinance that would have required living plant material in required front yards (setback areas) in residential zones.
- +Adopted the 1994-95 Parking and Traffic Management Plan as recommended by the Planning Commission with one modification; the City Council deleted a plan component that would have permitted the use of the Cannon Beach School playground area for parking during busy summer weekends.

- +Appointed Jim Hannen, Karen Sharp and Lucille Houston to membership on the Energy Committee; appointed Steve Osburn to the Budget Committee.
- +Approved the following community grant recommendations of the Parks and Community Services Committee: Administrative School District #10, Student Assistance alcohol and drug intervention program \$550; Sunset parks & Recreation for operation of Seaside Youth Drop-in Center \$2000; Seaside Youth Center, Inc for transportation services three days per week between Seaside and Cannon Beach \$1000; Cannon Beach Historical Society for landscaping \$250; Cannon Beach Arts Association for 1995 Concerts in the Park series \$1500; and Cannon Beach Arts Association individual artist grant program \$900.
- +Adopted an ordinance correcting an error in a 1980 ordinance regarding vacation of a portion of Hemlock and Third Streets in the area of Whale Park. (C)
- +Approved a request by Police Chief Dave Rouse to permit the development of a nine month trainee/intern position. Council also discussed a Police Department request for a review of the city's requirement to have emergency personnel live within eight miles of the city limits; a request was made for consideration of a city policy to assist police officers with the purchase of housing. The Council agreed to form an ad hoc committee comprised of Herb Schwab, George Shields and Councilor Frank Little to study the request and report back to Council.

- +Appointed Vic Stamm as Cannon Beach representative to the Clatsop Economic Development Council Transportation Committee and voted to send a letter of support for a Clatsop Community College grant application to provide better Internet and Telecommunications connectivity within Clatsop, Tillamook and Columbia Counties.

PLANNING COMMISSION SPECIAL MEETING JANUARY 10

The Planning Commission held a special meeting at 8:00 am on January 10th to consider findings of fact regarding the Holland Subdivision proposal. The Planning Commission had tentatively denied the 11 lot subdivision request after a public hearing at its November 1994 meeting but, with two members absent, the Commission failed to adopt the findings for denial that were available at the December Planning Commission meeting. Two sets of findings, one for approval and one for denial, of the subdivision request were prepared for the special meeting on January 10. Findings denying the request were adopted by a 4:3 vote. (D)

DESIGN REVIEW BOARD JANUARY 19

- +Held a public hearing on Alec Giess application for conversion of an existing single family dwelling into a duplex. The property is located at 279 East Monroe. (E)
- +Reviewed sign placement for Coaster Office Building located at 1315 South Hemlock. (F)
- +Held a public hearing on City of Cannon Beach application for the construction of a permanent bandstand located in main City Park at 247 North Spruce. (G)
- +Held a public hearing for City of Cannon Beach application for the placement of Frankie Kehl memorial log slice in Las Shirley Park located at 187 Fifth Street. (H)

At the March 7 Council meeting, revisions to development standards in the downtown commercial area will be considered. The proposed revisions include: permitting the replacement of an existing building's floor area without the requirement of providing off-street parking; establishing an off-street parking requirement of 1 space per 535 sq ft of commercial area and 2 spaces per 535 sq ft of restaurant are; generally requiring the retention of existing off-street parking; permitting off-street parking to be located anywhere in the downtown area; and establishing a maximum floor area ratio of .7. Interested persons are encouraged to obtain a copy of the proposals from City Hall. (I)

ENERGY COMMITTEE NEWS

Representatives of Osburn's Grocery, Mariner Market, Tolovana Market, Surfcrest Market and Family Market were invited to the December meeting of the City's Energy Committee to participate in a discussion on source reduction in grocery stores in Cannon Beach. Source reduction is one of the goals the Energy Committee members want to devote their time to in 1995. Steve Osburn of Osburn's Grocery and Ned Roache of Mariner Market attended the meeting and provided their input. Both businessmen agreed that one way to reduce packaging would be to sell more items in bulk, but they indicated that customers have to want them that way, and they felt that demand had decreased. Committee members agreed to research the topic of source reduction at the grocery store and manufacturer level and report back to the committee at a future meeting.

On other Energy matters, the changing of City Hall light bulbs to more energy efficient ones has been completed, and plans are underway to remodel and update the recycling bins at the post with better signage so that sorting of papers is more efficient. You can help the community recycling effort by recycling last year's telephone books. Telephone books are being collected at City Hall, 163 E. Gower, Cannon Beach Post Office at 155 N. Hemlock, Tolovana Post Office, 3140 S. Hemlock, Arch Cape Post Office, 1420 Highway 101 and the Cannon Beach Recycling Depot located on E. 2nd north of the water treatment ponds. The phone book recycling program is available for a limited time only between January 19 through February 3.

REQUEST FOR PUBLIC INPUT ON SHORT TERM RENTALS

The Short Term Rental Review Committee which was formed several months ago by City Council has made the following recommendations regarding the city's short term rental ordinances:

Establish stronger local management requirements; make the occupancy limitations of each rental unit more realistic in relation to the size of the unit and the parking spaces provided; establish a system for random room tax and building safety audits; continue to allow the licensing of existing short term rentals for another three years beyond February 1997, but allow no new short term rentals.

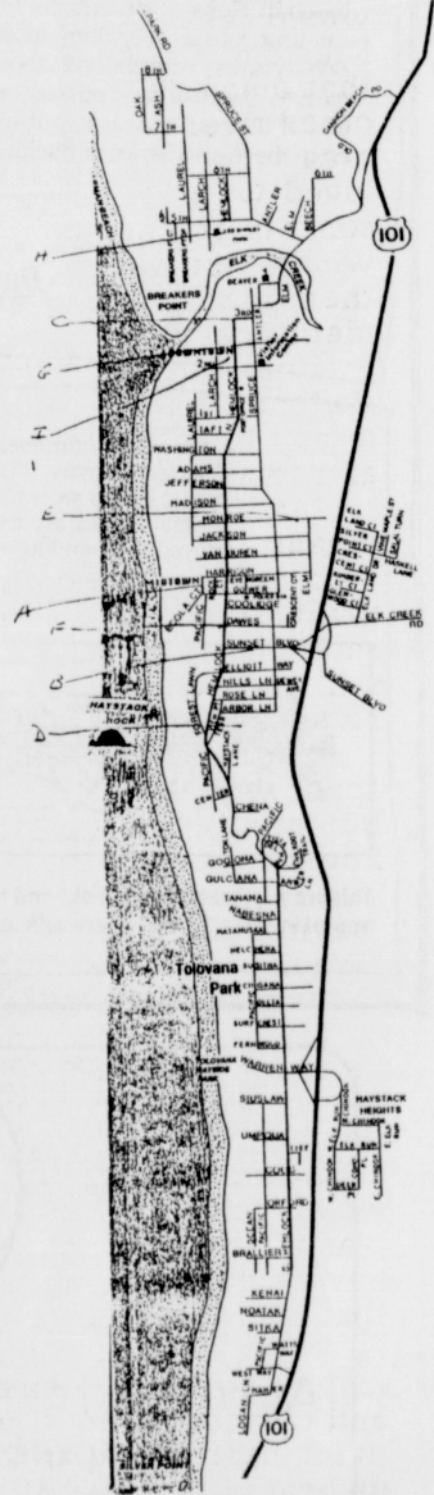

Prior to completing work on identifying necessary amendments to the Municipal Code to implement any or all of the recommendations, the Planning Commission would like to get a general sense of the community response to the recommendations. An opportunity for public input has been scheduled for Saturday, February 18, 1995 at 10:30 am at Cannon Beach City Hall. Copies of the Committee recommendations are posted at the post offices and are available at City Hall.
