#### **MEETING HIGHLIGHTS** CITY COUNCIL **JANUARY 2, 1996**

Continued a public hearing on proposed amendments to the Municipal Code requiring that, to obtain a building permit, a property owner must submit a land survey performed or validated by a licensed surveyor since 1-1-86. Council tentatively adopted the amendments which will be considered in ordinance form at the February meeting.

Appointed Hugh Milloy and Les Wierson to three year terms on the Public Works Com-

Held public hearings on Cannon Beach Sanitary Service requests for rate increases. Council approved a rate restructuring intended to encourage recycling and approved a rate increase to reflect an increase in the fees charged by Gearhart Transfer Station but will hold a work session on January 23 to further discuss an 8%. overall rate increase requested by CBSS.

Heard public comment on the services provided by Falcon Cable Company. Joel Billings, Falcon district manager for the Cannon Beach area, was present to respond to some questions and comments at the meeting and will provide additional information in writing regarding those questions he was unprepared to answer at the

Council received the report prepared by Keech and Associates recommending alternatives to address the safety hazards of the north entrance into Cannon Beach. City Council has scheduled a public hearing on the issue on Tuesday, January 23 at 8:00 p.m. at City Hall.(A)

Councilors adopted (by a 4:1 vote) a motion to present an offer to Cannon Beach Resorts Inc., on behalf of the city, to purchase the Cannon Beach RV Parkfor \$2,100,000. The terms of the purchase include a \$940,000 down payment with a 7 year note on the balance at an interest rate of 9%. The property being considered for purchase is about 20 acres in size and does not include the mini-storage buildings. The RV Park is one of the sites that was considered by the Blue Ribbon Committee on Future Space Needs for potential school. sports park and arts center locations.(B)

Council provided staff with direction in the development of a policy addressing structures that encroach into public rights-ofway. The proposed policy language will be revised and will be on the February Council agenda for further discussion

Councilors determined to permit partial paving of Spruce Street, from the driveway of the new fire station to Sunset Boulevard rather than paving the entire block through to Dawes Street.(C)

Councilors adopted a resolution declaring the city's intent to extend sidewalks on the north side of Sunset Boulevard along a 50 foot section between the Hallmark overflow motel building and the new fire station.(D)

Adopted an ordinance to bring the Cannon Beach Zoning Ordinance into conformance with the requirements of recently adopted state legislation regarding public earing procedures.

Held a public hearing on the proposed 1996 Parking and Traffic Management Plan updates. Councilors asked staff to study potential changes in the route of the Shuttle to free up loading zones on Hemlock Street for use by delivery trucks. The issue will be further discussed at Council's February 6 meeting.

Reappointed Frank Little and Bud Kramer as the city's representatives to the Clatsop Economic Development Council.

Approved the community grant recommendations made to Council by the Parks and Community Services Committee. Included in the awards of second round grant funds for the year are:

## PLANNING COMMISSION

**DECEMBER 21** 

Held a public hearing and recommended denial to City Council of a request for a zone change by Terry and Carmen Swigart. The applicants request a zone change from MP, Manufactured Dwelling and Recreational Vehicle Park, to RM, Residential Motel, for a 9 acre parcel of property at the north end of Cannon Beach, currently part of the SeaRanch RV Park and Horse Rides. The request will be considered by the City Council at the February 6 Council

Held a public hearing on a minor partition request by David Holland to partition an existing 3.84 acre lot into three parcels. The property is located east of Hemlock Street and south of Arbor Lane. The Planning Commission denied the partition request. Holland has appealed the decision to the city Council; the appeal will be heard at Council's February 6 meeting.(G)

Held a public hearing and approved a sign variance request by the Tolovana Inn Homeowners Association to permit the replacement of an existing, non-conforming sign in conjunction with the Tolovana Inn

which is located at 3400 S. Hemlock Street.(H) Continued a public hearing on a proposal to require surveys more than five years old to be lidated by the surveyor who performed the original survey. The Planning Commission directed staff to modify the proposal to permit any licensed surveyor to provide the validation service and to require validation only on sur veys conducted prior to 1986. The proposal will be considered by City Council.

Heard public comment on the proposed 1996 Parking and Traffic Management Plan up-dates. The Planning Commission modified the proposal before referring it on to the City

Approved the final plat for phase 1 of the Chapman Point Subdivision. Phase 1 of the man Subdivision includes the seven lots located north of 7th Street.(I)

#### CITY COUNCIL SPECIAL **MEETING JANUARY 16, 1996**

After holding an Executive Session, City Council held a special meeting and determined to not pursue further a Clatsop County Circuit Court order compelling the city to issue approval for the Shorewood Subdivision application. The City Council denied the Shorewood application for tentative subdivision plat approval in August 1995; the applicant, Shelter Resources, Inc., subsequently filed a petition for a writ of mandamus with the circuit court because the city's final decision on the application was not rer dered within the 120 day period prescribed by Oregon statutes. The Shorewood subdivision application will now be subject to Design Review Board hearing and consideration Shorewood Subdivision application is for a 19 lot subdivision located on a 3.53 acre parcel of land east of City Hall.(J)

The City Council also determined to file a petition for review by the Oregon Supreme Court in the matter of the Holland Subdivision request. The City Council denied the Holland Tentative Plat Subdivision request in March 1995; Mr. Holland appealed the matter to LUBA (the Land Use Board of Appeals) where the city's denial was upheld. Holland then appealed the decision to the Oregon Court of Appeals which has issued a remand of the decision to LUBA to determine a specific point of law related to the use of Comprehensive Plan policies as approval criteria. Council decided, on the advise of the city's legal coun sel on the matter, Ed Sullivan, to request a hearing by the Oregon Supreme Court rather than reconsideration at LUBA.(G)



Dear Mr. Quarles,

Since your letter to the members of the Cannon Beach City Council will appear both in the Gazette and the Upper Left Edge, I felt this response should serve the same purpose and inform the citizens of Cannon Beach.

I read your letter about the potential RV Park purchase in total amazement. Where were you when the citizens of Cannon Beach voted to approve General Obligation bond for the construction, purchase or acquisition of public facilities and services? Where were you when the Blue Ribbon Committee, composed of 12 experienced members of our community, spent many, many hours studying the space needs of Cannon Beach, and made their number one recommendation the acquisition of the RV Park property? Where were you during the public hearings held on this matter? I have not seen you at many council meetings, perhaps one or two meetings in the past two years. If you had attended Council and Budget Committee meetings on a regular basis, you would know that Kirk Anderson has been advocating for the land trust concept for several years, and this last year succeeded in establishing a budget line item for that purpose. You would know that the purchase of the RV property could go toward achieving the preservation of our valuable urban forest land on Spruce Street, a goal that I personally favor.

Basing your information and opinion upon one article you read on one day in January, 1996, is fine as far as it goes. To offer uninformed advice to the members of this community who have worked hard, taken the time and made the effort to steer a course based on long study, citizen involvement, profession and legal advice, and consultation with the taxpayers is reprehensible.

It is not to be expected that everyone will find the potential RV Park purchase agreeable, but the hours of responsible citizen involvement on this issue have certainly provided some consensus and have served properly as a guide to the City Council in moving forward with negotiations. Whatever the outcome, the process has been all that you suggest it should be.

The Honorable City Council of Cannon Beach:

We appreciate all the effort City Hall has expended to protect the community from the Shorewood development.

We applaud the Council's actions to believe in and fight for the Comprehensive Plan, and even over the objection of the City's own lawyer.

We understand there were two legal technicalities that caused the Council to give up the fight.

First, due to confusion over a one-week extension for additional comment granted by the Planning Commission, our City Planner missed a mandatory 120 day deadline.

Perhaps in desperation, the Council then abandoned pursuit of the Comprehensive Plan to follow the questionable recommendation of the outside lawyer. Following this lawyer's advice, the City accused Shorewood of having only one exit. That the Court sided with Shorewood is no surprise. After all the Planning Commission had already requested Shorewood eliminate their second access.


