

The eleventh convention of the Oregon Christian Missionary convention will be held at Turner June 21, to July 1.

The 14 months old son of Mr. and Mrs. H. T. Tolerson, who live on Howell Prairie, Multnomah county, was so badly scalded last week by the accidental overturning on him of a bottle of boiling water, that he died from the injury received.

At meeting of Oregon Editor's Association held at Statler's hotel, Buffalo, N. Y. June 18, F. S. Harding, editor and proprietor of the Telephone Register, McMinnville, was elected president of the Oregon Editorial Association. The Association held their regular session at Salem this fall, during the state fair.

For some time postmasters, as an experiment, have been paying money orders drawn on other post-offices, when satisfied that orders were correct. This has proved unsatisfactory. The postoffice department decided to discontinue it May 31, and ordered postmasters not to pay money orders only those drawn on their own office.

Prof. E. Northup has been chosen president of the Oregon Fire Relief Association, to succeed late president O. H. Irvine, deceased. F. W. Fenton was elected to fill vacancy on board of trustees caused by election of Prof. Northup. It was provided that the president's salary should not exceed \$500 per year. It is based on a percentage of receipts from applications, and last year the president's salary amounted to about \$800.

Judge Hamilton of Roseburg, who with Judge Burnett of Salem, exchanged and held circuit court at Salem, the latter holding court at Roseburg, rendered the following decision in defaulting school land claim: Napoleon Davis: "Criminal clerk for embezzlement must be begun within 3 years from the time of the embezzlement. Whether the statute of limitations began to run from the time of the appropriation of the money, or from the end of his term of office, makes no difference in the case. In either event it has been more than 3 years since the statute began to run."

One angry depositor in the defunct Gilbert bank, of Salem, in a communication to the Daily Oregon Statesman of June 13, airs his grievance. He is indignant that Judge Bellinger had allowed Temporary Receiver Thielens, the modest, or as he forcibly puts it, "the sorberant and outrageous amount of \$250 for salary (?) and \$250 additional for expense (?) for the short time he was in charge of Gilbert Bank's bank. Five hundred dollars of the depositor's money gone glimmering in the pell, compared with some transactions in the capital of Oregon,—take for instance case of Napoleon Davis, former clerk of the state school land board, whereby the state of Oregon anticipates the tune of many thousands of dollars, and no recourse as the learned judge.

The grand jury of Marion county at the late term of court, suggested in vigorous terms, several very important improvements in the county jail for the more so to restrain of prisoners by new cells of the latest improved style; also a better means of ventilation than by the windows. Better protection for the jailer on entering jail, such as double doors and other safe protection. Toilet rooms for women's cell, and lady employes of the court house. After personal inspection of poor farm, of the man-gement of which there had been complaint, the jury report that it needs better attention than it has had in the immediate past. They found the county past had been somewhat negligent in looking after affairs of said farm. Mattresses were found that were ants for use anywhere, and should be destroyed and replaced by new ones that can be renovated. There should be considerable improvement in beds and cleanliness of inmates. Old furniture in the inmates rooms should be replaced by new.

Dr. H. J. Minthorn and family are down from Hot Lake and will probably remain somewhere in the valley, as Cook & Minthorn have disposed of their interests in the health resort at Hot Lake. Dr. Hutchinson arrived from Netarts the first of the week, where he went in search of sea bird eggs. In company with Ellis Hadley of Dayton, and a couple of young men from Portland a trip was made to an inland rock some distance from the shore, where hundreds of eggs were gathered from which the boys will add to their collections. One morning doctor went to the beach at an early hour where he found a young sea lion that had been washed off the rocks in a storm during the night, floundering in the shallow surf. He made a charge for the youngster and finally landed him on the beach, finding him about the size of a medium sized dog and ready to defend himself as best he could. On leaving the beach the doctor left the young lion in charge of parties there and he has a feast of the sea to dispose of. He has offered his prize to the park commissioners at Portland, but they have answered that they have now have consumed so many of the cash in the treasury and they decline the offer. ### GRADUATING EXERCISES OF DAYTON PUBLIC SCHOOL.

Friday evening last, the Christian church was taxed to its utmost capacity by friends of the graduates. The 12 young lady graduates looked their loveliest, while Ollie Lamm, the only male graduate, looked somewhat unwell, but his grace and loveliness, but he was determined and apparently unmoved in the performance of his part of the program. This was the largest class ever graduated from the school.

The exercises were advertised to begin at 8:30, but Prof. Duncan remarked "that as state Superintendent Ackerman was present, and in appearance of the church, by every one, the program would begin with a quartet, 'Song of the Whippoorwill,' by Gertner, Rogers, Rogers, Macy." Miss Grace Duncan's name was then announced, and in a pleasing way she introduced the quartet, and gave them some hints as to what to expect from her classmates, who were to follow her. Miss Nellie Haddock then read an instructive composition on public hygiene, which was followed by the Class Historian, Miss Marie Smith, who gave a brief sketch of the history of the school. Miss Mollie Lavy then presented a beautiful composition on 'Opportunity and How to make the most of such.' Miss Texie Edgar followed very appropriately, with 'Self Improvement, which was a very clear and important one to all. 'Influence,' by Miss Lena Spangle, she told briefly, how the least to the greatest have an influence for good or bad, and such influence lives after them. The Hobbs' quartet sang, 'I'd Like to Hear that Song again,' and were heartily applauded. The composition on 'Heroism,' by Miss Florence Livingston, was listened to with much interest, and the Power Behind the Throne,' by Miss Thelma Bennett, was delivered in a convincing manner, and it was clearly shown that the rulers in name are often not the real rulers. Myrtle Dorey, who sang next, with a composition on 'Patriotism,' defined what it is and how it can be shown. F. E. Rogers sang a touching solo of 'Our Father,' which Myrtle Dorey then followed by 'O God, Thyself, who represented the class of 1901, at the threshold of life, where they must choose the higher and better life, though hard, and the lower and apparently easy one. Oliver P. Lawrence, who was greeted with applause, was the only boy in his class, it fell to his lot to deliver the class prophecy which he did in a very neat and creditable manner. As all the very best were present at the exercises, we hope he is a true prophet. Miss Lena Wambegans, a veiled vocalist, spoke the farewell words to the class.

The address was then favored with a song by the Hobbs-Petty quartet. Prof. S. S. Duncan, principal of the school, presented diplomas to the graduates, and a felicitous address. Afterward introduced by Lawrence, of Oregon City, who said, as President Boardman of McMinnville college, could not be present, he, as president of the board of trustees, was there to represent McMinnville college and confer the scholarship offered to the one receiving the highest average in scholarship and deportment during the school year. He also explained just what this implied, in a very clear and convincing manner, and the scholarship admitted them to any course in the college, and they had free access to the apparatus of same. He complimented the class much, and remarked that he thought the essays the best that he ever heard (great applause) and believed it required a high average to secure the scholarship, and then presented the same to Myrtle Dorey. He was right in thinking Myrtle received a high average, as in four studies she never fell below one hundred and only lost thirteen points during the year. The class, with all present, rejoiced with pride in that she secured the well merited honor.

Professor Duncan next introduced J. H. Ackerman, State Superintendent of Public Instruction, who delivered the address to the class. He would be pleased to give the best address in the fall, if answered permitted. Prof. Ackerman rightly believes the home one of the most important things in this world. He complimented the people of Dayton on their school and class, but asked where were the other boys who started with the young man of this class, and why did they not stay and finish school. The program ended with a good night, song by the quartet. To say that the exercises were a success and gratified with the graduating exercises of the Dayton public school is putting it very mild.
