## AS WE SEE IT

Many have been the lines printed on the pages of every news-paper in the State on the issue of Woman suffrage, and up to this time I have not seen my sentiments entirely expressed in any issue.

You ask us are you in favor of woman suffrage? We answer no and yes. There are some points in woman suffrage that we are in favor of, but a great many more that we are not.

In my last issue a Suffragette expressed herself. Among other things said by her was the belief that men and women could and would regulate the juror question My friends if woman is given the power of the ballot and wishes to place herself on an equality with man, bringing herself from the position she now occupies, to a point far below it, I am in favor of showing her no leniency.

Woman is now looked up to by man and is treated with a great deal more respect than she will be when she enters the polling place and casts her ballot.

Woman was never intended to match her strength or Intellectual power against man because she is not physically constituted to withstand the strain. In regards to women running barber Shops our friend the suffragette said, "It was work only fit for a man." This may be true, but if woman wishes to place herself as our equal she must remember she is, or will not be considered any better than man.

She also says children are neglected more every day for frivolous things. This is only argument against the granting of suffrage, for the reason that, if children are neglected now for frivolous things, what will be the outcome if woman does have an opportunity to work in a political way for a measure of some

importance?

Though the mind of woman is as strong as that of man for a short time, how much more frequent is the case of complete mental and physical break down, called "Nervous Prostration," in woman than in man. We use this because when suffrage is granted, women must do the strenuous work of the political world as well as men, and must face the hardships the same, and we do not believe they are able to stand it.

We believe they are better protected as they are.

## OPPOSITION TO WOMAN SUFFRAGE

That the entrance of women into general wage earning has unquestionably lowered the wages of men, is no longer a disputed question. There are men today who cannot support their families because their wives are doing for less money the work with which they once received their incomes. The economic independence of the wife, as argued by the suffragist, is distasteful to American women. If the woman does not take enough into the home without wage earning to make her contribution equal to the man's to make the partnership a fair one, then there must be something wrong with the woman.

The cry has been heard so long in this country, that every woman should be economically independent has had sad effects. The desire of the women to be out doing the worlds work is not helping the Nation. The revolt of womankind against those necessary tasks which were accepted by our grandmothers is threatening many of the homes of this country. Suffrage will not make our existing homes more stable, or imbue the young woman who becomes inoculated with its precepts, with the ambition to start one of her own. On the other hand it is likely to fill her with contempt of old traditions and thus greatly harm society.

Suffrage would inevitably break down many of the barriers which our wise fore fathers erected to protect youth. Almost every bad sociological condition of the time has grown out of the destruction of those old time safeguards. Their protection against further assaults must largely lie with women; suffrage of itself, would not sustain, but weaken them, and the absorption of women in affairs in which their help is really most needed would so occupy their time that they would cease to be their guardians. Too strong a tendency toward liberty in the past has often led to license, and history repeats itself. There is no good which the advocates of woman suffrage ever have declared the change must bring, which

could possibly be great enough to offset all the evils which would be inevitably certain to follow in its wake.
