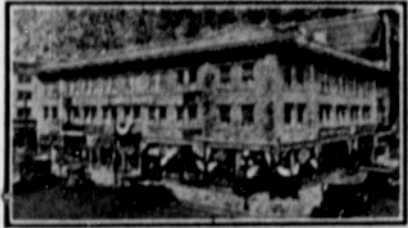

STATE NEWS IN BRIEF.

The Irrigation Securities Commission, created by the last legislature, has formally promulgated a set of rules and regulations which will govern its work.

It is expected that a state grain inspection office will be opened in Pendleton next week, said Charles E. Porter, state grain inspector, who is making arrangements for the office.

The special course for the preparation of young men for work in the ordnance department of the United States army to be given at the university of Oregon has been limited to 50 students.

Whitney R. Lyken is held in the county jail at Grants Pass on a charge of seditious utterances against the United States government, pending instructions from United States Attorney Reames.

Union county claims a new distinction, that of growing the biggest bean pod in the world. County Agriculturist Spillman now has on display a pod, badly shrivelled since it was picked, that even now measures 27 inches. He reports several instances of similar sizes found in and about Island City.

The appeal board at Eugene has granted exemption to Crawford William Smith, son of "Buckskin Bob" Smith, famous Indian fighter, that he may remain on his father's farm near Port Orford, Curry county and care for his parents and three sisters under 12 years of age.

James Wyre and Carl Smith, buyers for the Caldwell Horse and Mule company of Caldwell, Idaho, bought two cars of horses and mules at Heppner this week and will ship out at once. The animals are intended for the government and will be sent to the front for cavalry and artillery purposes.

State Agent Paul V. Maris and Whitney L. Boise met with the Polk county court this week, asking that Polk county take advantage of federal aid offered and give a county agent a trial. Although no decision was reached, it is believed the court will act favorably and that J. D. Cooter would be appointed.

The Pacific Telephone and Telegraph company has filed a request with the public service commission to close its long distance office in St. Paul, Marion county, stating that St. Paul now is adequately served via Aurora, Hubbard and Newberg, and that there is no necessity for maintaining the present office there.

Notice of appeal was filed on the public service commission by the Luse Land & Development company from the decision of the commission in fixing the irrigation water rates on the Sutherland Irrigation project. Appeal is taken to the United States district court at Portland. The company contends the commission has no jurisdiction.

The canneries at Tillamook are paying 8½ cents a pound for Chinook salmon, the highest price in years. Silversides, which are just beginning to run, are bringing 6½ cents, with a raise expected as the run progresses. At night Tillamook bay is so full of fishboats that it looks like the lights of a city. The report is that fishermen are averaging from \$20 to \$40 a night.

No less than 200 pigs from the boys' pig clubs of Oregon will be shown at the Oregon state fair this year, according to E. F. Carleton, manager of the educational department. The largest number will come from Umatilla and Marion counties, Mr. Carleton said. The pigs, it is expected, will average 250 pounds apiece and with a 15½ cent market, the average price would be \$38.75, or a profit of \$30 a pig.

The car shortage on the Southern Pacific dropped from 1067 to 793 last Saturday. The big difference is made in the increase in the surplus of closed cars from two to 230.

Plans are being inaugurated already by McPherson Post, No. 5, G. A. R., of Albany, for the entertainment of the grand encampment of Oregon of that organization, which meets in Albany next June.

A petition numerously signed was presented to the Lincoln County court Wednesday asking that a special election be held for the purpose of voting on a proposition to bond the county for \$200,000 to build roads in the county.

F. A. Pierce, of Day's Creek, near Riddle, a breeder of mohair goats, has reported for the California State Fair, at Sacramento, with 12 head of his fancy show stock. Mr. Pierce is the owner of Dodo, the world's champion long hair mohair goat, fleece of which measured 42 inches when clipped by the judges at the San Francisco Exposition.

W. A. Taylor, well-known rancher, living near Macleay, eight miles southeast of Salem, has received word from the State Fish and Game commission that it intends to place a herd of 30 or 40 elk on the headwaters of the Abqua river some time in the near future. No details were given as to where the elk will be secured, but probably from Wyoming.

TEUTONS ARE MOBBED

Argentinians Attack Consulate and Business Houses Burned—Passports Given German Minister.

Buenos Aires—The rioting which began here late Wednesday in an anti German demonstration continued throughout the night. Every German business house and restaurant in the downtown district was wrecked. The German Club and several other buildings were damaged seriously by fire. The police wounded seven rioters when they fired into the crowd. Three of the injured are expected to die.

Buenos Aires—The downtown section of the city was the scene of the wildest disorders Wednesday night in connection with great anti-German demonstrations in which thousands of Argentinians took part.

Many of those in the mobs carried firebrands, and as a result scores of buildings were set on fire. Several blocks of German business houses in Calle 25 de Mayo were destroyed. Early in the afternoon the German legation was stoned.

Among the structures attacked were the German Club, one of the finest edifices in the city, and the building of the German daily, La Union. As fast as the fires in these buildings were extinguished they were started again.

Mounted police patrols and the entire fire department kept rushing from one part of the city to another in an attempt to quell the riots and put down the flames. In several instances police who were attempting to shoot at those wielding torches were set upon by the crowds and disarmed.

Extraordinary precautions have been taken by the authorities to protect Count Luxburg, the German minister, when he arrives here to receive his passports.

The Argentine government at noon sent to the German legation passports to be delivered to Count Luxburg, the German minister in Buenos Aires.

The decision to hand Count von Luxburg his passports was reached by President Irigoyen after a conference with the foreign secretary, but without consulting the cabinet, which had been called to meet in the evening and receive Ambassador Naon's dispatches from Washington. The President maintained that the matter was grave enough and pressing enough to warrant his immediate decision without reference to the cabinet.

It is believed unlikely that any action will be taken toward Sweden, the explanation by the Swedish legation apparently satisfying the government that Baron Lowen acted in good faith in forwarding the telegrams, the contents of which were unknown to him.

The Argentine minister at Berlin has been instructed to inform the German foreign office that Count Luxburg has been handed his passports and to ask for explanations regarding the telegram disclosures. If the German government disapproves of the text of the German minister's dispatches, especially for the word "ass," which term the count applied to the Argentine foreign minister, the situation may be cleared. If Berlin does not disavow the minister's course Argentina will recall her minister from Germany, but may permit the legation to remain.

If Germany expresses a desire to maintain relations with Argentina, notwithstanding the expulsion of Count von Luxburg, it was said at the foreign office, this government would be willing to consider the question.

Argentina also has asked the German government for a full explanation of its present policy of sinking Argentine ships. This apparently was settled in the case of the steamship Toro, but in view of Count von Luxburg's notes, which antedated that settlement, Argentina desires a clear statement.

A rupture, the officials say, is not necessary if Germany is inclined to make concessions, but if she does not do so, it is certain there will be a break in diplomatic relations.

Carranza Is Recognized.

Washington, D. C.—Last steps in the formal recognition of the Carranza government in Mexico by the United States have been accomplished by formal notification of the election of Carranza as President and an acknowledgment by the United States. The proceeding is a technical one. Officials took occasion Friday to reiterate that no loan to Mexico was contemplated by the United States, but one is contemplated by American bankers.

8900 Captured at Riga.

Berlin, via London—Russian prisoners captured by the Germans in the battle of Riga numbered 8900, according to the official announcement issued by the German general staff. The Germans also took 325 cannon.

LABOR SUPPLY SHORT

Eastern Washington Industries Suffer On Account of Men Being Taken for War—Union is Formed.

Spokane—A labor shortage of 10,000 woodmen and mill operatives faces timber operators of eastern Washington and Oregon and northern Idaho, it was declared here Thursday at a meeting of the Loggers' club, composed of lumbermen of that section and attended also by several operators from Montana.

Of these, 7000 were lost by army enlistment or draft, it was stated, but about as many now engaged in harvesting and firefighting will be available for woods work later. The operators took no action on wages, and no decision for uniform resumption of operations was announced.

Plans for circulating among lumber manufacturers and their employees petitions for congress asking for a universal eighth-hour day in the lumber industry were formulated and the club reaffirmed its indorsement of the eighth-hour day.

A resolution indorsing the boycott of coast building trades unions against lumber manufactured in camps and mills running 10 hours a day was passed by the local Central Labor council, and referred to the Spokane Building Trades council.

Application for a charter in the American Federation of Labor was made to the Central Labor council by a newly organized union of mill workers and timbermen, which it was declared has 400 members. It is committed to the principle of the eighth-hour day, it was announced.

HUNTERS FIND GAME SCARCE

First Venture in Eastern Washington Brings Poor Results.

North Yakima—Hunters who went into the hills Sunday and Monday for grouse did not find the birds plentiful and few of them got full bags. Game Warden Greenman and a deputy stationed themselves at the forks of two roads leading into the most popular districts for hunters Sunday evening and held up and examined from 50 to 60 automobile parties returning. In no instance was it found that the bag limit had been exceeded, and only four were found who could not show their licenses, each of whom claimed they had a license but had come away without it.
