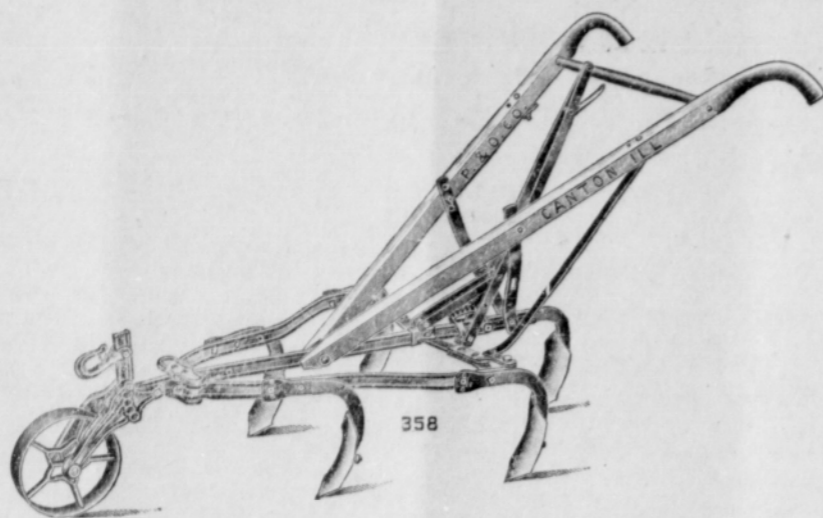

NITRATES AND POTASH.

Extensive deposits of nitrate of potash (saltpeter) are said to have been discovered in the northwestern corner of Nevada, with promising prospects over the line in California and in southeastern Oregon. Should it prove to be of commercial value it will be of great importance. Heretofore this country had to import its potash from Germany and its nitrates from Peru or Chile. To be independent of both of those distant sources of supply of these elements, so vital in peace or war, is of extreme moment to the United States. Without depending upon this possibility, however, congress wisely proposes federal aid to and supervision of manufacturing plants operated by water power for extracting nitrogen from the air. This will do much to insure cheap nitrates for agricultural purposes during peace and an ample supply thereof for explosives during war.—Orange Judd Farmer.

Myth of the Doones.

How largely Mr. Blackmore drew upon his imagination for the story of "Lorna Doone" is made clear by F. W. Eackwood in his book, "The Good Old Times." There were, in fact, no Doones. The word was simply a local bogey, a modified form of "Dane," a memory of the faroff times when the viking invaders harried the land. "The only vestige of actuality discoverable is a faint tradition that a fugitive from the battle of Sedgemoor, to escape the hangings of Judge Jeffreys, appropriated the ruins of some wretched huts in recesses of the Badworthy glen, now 'the Doon valley,' finding there a safe retreat in which he reared a considerable family, which managed to eke out a living by committing petty depredations in the district. The 'last of the Doones,' an old man and his granddaughter, are said to have perished in the snow during the winter of 1800."

Heron's Foot For Bait.

So great is the heron's repute as a fisher that it has long been thought that its feet, owing to some peculiar scent or oil which they were supposed to possess, attracted the fish, more especially eels, to within easy reach of its beak. In some places the rustic angler still believes that if a heron's foot is placed with his worms the latter are more eagerly taken by fish.—London Outlook.
