Spraying Peaches.

Wherever the blossom buds of the peach have been killed by winter injury to such an extent that there are only enough buds alive for a crop, it is suggested by the horticultural department of the New Jersey agricultural experiment station that growers give special attention to the control of the plum curculio. This insect appears at about the time the trees begin to bloom and feeds on the young leaves. The curculio does very little or no damage to the young fruit until the calyxes are shedding, when egg laying begins. By spraying the trees just as the petals have fallen from the blossoms many insects are killed before they deposit the eggs, and the danger of later injury is considerably reduced. A spray consisting of three pounds of arsenate of lead paste or one and three-quarters pounds of the powder to fifty gallons of water applied at the fall of the petals is recommended. Where the set of fruit is very light a second spraying of arsenate of lead, commonly combined with the self-bolled lime sulphur, should be made just as the "shucks" or calyxes are being shed from the fruits.
