ONLY ONE WAY FOR CHANGE—

There is indication on every hand that the American people want a change of administration in Washington, D.C. You hear it on the street. You read it in public opinion polls. You get it at every hand. They can have it if they want, but there is only one way to get it. That's by voting for Eisenhower for president and for the Republican candidates for all other national offices. There is no other way.

The Democrats are making a big play to attempt to convince the voters that by the nomination of a presidential candidate other than Truman they have made it possible for voters to "have a change" while at the same time retaining the Democratic party in power. That claim is so transparent that there aren't going to be many voters who will not see through it.

American voters already are well aware of the fact that Adlai Stevenson is President Truman's personal choice as candidate. They are also aware of the fact that Stevenson's nomination was made possible by the big-city machine, most of which have the color of gangsterism in their banners, and the extreme left-wingers, the fellows who try to laugh off Communist influence in the present administration. The voters know that the Democratic nominees will be powerless to throw off the yokes and influences of these forces if they are elected. They know that such circumstances will make any change in administration by election of the Democratic ticket a change in the faces of the leading personnel only, not a change in operations or practices.

On the other hand, the voters also know that they can be certain of a change, a prompt and sweeping change, by the election of Dwight Eisenhower and the Republican ticket. They know that such a change will sweep from places of power the Harry Vaughans, the department heads who have winked at corruption and countenanced communistic infiltration into high government posts.

There are many who sincerely want a change of administration in Washington who have not yet faced up to the fact that there is only one way to get it. Some will have no difficulty in meeting the issue when they do face. They will act in the light of their firm conviction that a change is essential to the nation's welfare. Others are going to find it more difficult. They are going to be torn between loyalty to their political party and their personal conviction that a change is needed.

We refer folks in that latter category to the dozens of solidly Democratic newspapers and leaders in many sections of the nation, particularly the South, who already have openly announced their renunciation of the Stevenson candidacy and their support of the Eisenhower ticket. It has been no easy decision for these leaders and these newspapers. Among the newspapers are many for which this is the first time since their founding that they have supported a candidate on any ticket other than the Democratic ticket—and many of these pub-

lications have been solid institutions for more than 100 years. They recognize the dire need for a change, a complete change, in the federal administration and they realize fully that there is only one way to bring that change about—by electing Eisenhower. Their realization that the situation is critical enough to warrant a break with more than a century of tradition certainly is more than sufficient grounds to bolster the courage of any rank and file citizens who are torn between party loyalty and their patriotic desire to do what is best for their country.

AN AFFRONT TO WORKERS—

Many of today's leaders of labor organization are supposed to be enlightened men who believe in fair play and work sincerely for just gains for their members without demanding the last pound of flesh. Walter Reuther, head of the big automobile workers union is generally considered to be in the more or less enlightened category of labor leaders.

That's why it was a bit astounding to us to hear the report of a statement by Reuther that he "could not agree to deliver the labor vote" for a candidate not to his liking at the Democratic convention.

A remark like that belongs back in the dark ages. It certainly has no place in the comments or even in the thoughts of a modern "enlightened" labor leader. The days when any man can deliver a block of votes of a particular segment of our people are past. Citizens of the United States today know that they are free to do as they please when it comes to voting. They know that their ballots are secret and that no labor leader or anyone else can work reprisals upon them for not voting according to the dictates of such leaders.

Reuther's statement was an affront to the workers of America. It was an insult to their intelligence and their dignity. The implication that he or any other individual can lead American workers around by the noses and "deliver" their votes for any candidate or any cause should put the workers on guard against leaders who would barter their votes as cordwood. The workers of this nation have demonstrated time and again that their votes are not for sale. They proved it most conclusively in the 1948 election when most of the big industrial states failed to support Harry Truman. They have proved it on numerous other occasions, yet men like Reuther still have the gall to insult the worker by inferring they can "deliver" the workers' votes—at a price.

Tawneys Hotel
It was about 45 years ago that the Tawneys established their first hotel several miles up the Welches road, past Welches hotel and post office. Later on they built a larger, finer hotel which, with its surrounding small open-air guest houses, accommodated as many as 125 people at once, and it was kept full, too. People in those days came and stayed a month, or all summer. There was no "here today, gone tomorrow" at 70 miles per hour, at that time. Welches, with its homey hotel and flock of cottages down by the river (since washed away) was in its heyday then also. Their newer cottages, on the road, named for flowers, are still there. Tawneys and Welches together made a famous mountain resort area until more recent years.

Part of the Tawney property was given to a Boy Scout group in Portland and was dedicated last Sunday, August 17. Another event of last Sunday was the Western Traffic picnic which was held at Welches golf course, with about 60 people present.
