

Sandy Hospital Still Town's Focal Point

The town of Sandy has been thinking about a hospital longer than some of the newcomers can remember. It was back in 1949 when the first bulldozers started moving earth on the big hill north of town. During that summer hundreds of volunteer workers—from Government Camp to Gresham—pitched in on off hours and pounded cement forms, raised studs, and bashed thumbs.

Gradually the big Sandy hospital building rose out of nothing much more than a hope and a prayer.

Then the visible activities stopped. Funds were depleted. The building was put in as good a shape as possible. And mother nature took over graying the newly cut lumber, settling the building.

However unfinished, the building still served somewhat as a focal center for the town of Sandy. Not only did it promote building activity on hospital hill, but during the past five years, it has helped make the community of Sandy pull together.

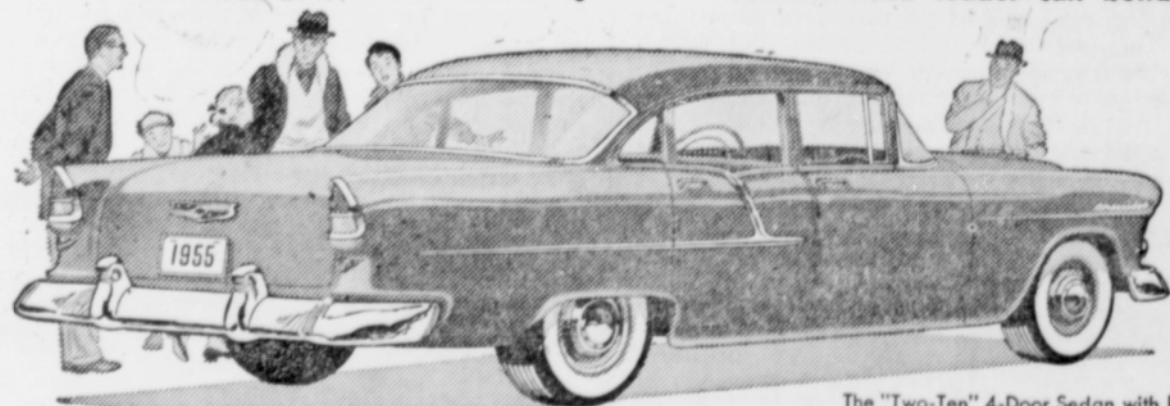

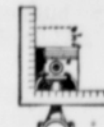

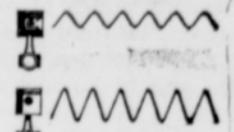
