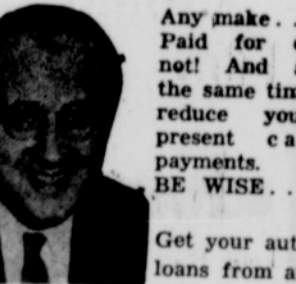

Notice is hereby given that an election will be held in School District No. 2 U.H. of Clackamas County, State of Oregon, from 2:00 P.M. to 8:00 P.M. on June 25, 1956, at The High School Building in said school district, for the purpose of submitting to the legal voters of said district the question of increasing the tax levy for the fiscal year 1956-1957 over the amount limited by section 11, article XI, of the Constitution of Oregon.
