River Needs Protection

The Post this fall played a major role in helping publicize the need for the inclusion of a 12-mile stretch of the Sandy River in the Oregon Scenic Waterways System. Hearings on this will be held July 11 in the Bonneville Power Administration Building in Portland, and July 13 in the Sandy Grade School.

The portion of the river to be considered is between Dodge Park and Dabney State Park.

We urge the citizens of the area to attend these meetings to express their feelings on this issue. The need for protection under the Waterways Act is necessary to keep this area enjoyable for future generations.

These meetings will act both as a place for the Highway Commission to hear the people and also for the Highway personnel to explain the criteria needed for the area to be classified as a Scenic Waterway.

Bank debits show increase

Bank debits for the 22 reporting banks including banks in Clackamas county were up in May, 1972, the University of Oregon Bureau of Business and Economic Research has reported.

Debits for May, 1972, totaled \$191,775,000. For April, 1972, the total was \$179,984,000 and for May, 1971, the total was \$140,726,000.

Oregon, with 392 banks reporting, had a percentage increase of 7.9 per cent in May, 1972, as compared with April, 1972, and a 25.9 percentage increase in May, 1972, compared with May, 1971.

Total bank debits for May, 1972, came to \$6,362,048,000. For April, 1972, the total was \$5,898,258,000, and for May, 1971, the total was \$5,053,622,000.

Drug counts trip local men

Two local men were arrested June 27 and lodged in Rocky Butte Jail on \$5,005 bail each. Sheriff's reports said William Hugh Gitzon, Jr., 23 and Kenneth George Bouret, 19, both of 964 NE183rd Ave. were charged with criminal activity in drugs, along with a 17-year-old boy who was lodged at Juvenile Detention Home.

Morse declares McGovern support

Former U.S. Senator Wayne Morse received an enthusiastic response July 4 when he declared he was supporting George McGovern for Democratic nomination.

Morse was speaking at a holiday picnic meeting of East Multnomah County Demo Forum at State Senator Vern Cook's home on the Sandy River near Troutdale. About 200 hundred were in attendance.

In his campaign for delegate to the national Democratic convention Morse did not declare himself for any candidate. However, McGovern received a solid victory from Oregon voters.

Morse reported that he had been to the platform committee sessions in Chicago and had

helped to defeat the George Wallace faction which wanted to outlaw busing.

Morse said there was no place in America for the apathetic movement.

He said Washington, D.C. was an example of what could happen. There 94 per cent of the students are black. Most white students go to private schools. Morse said that students in the 6th grade could only be rated at the 3rd or 4th grade level.

There are as many as 50 students in a class and in some cases the only textbook is that owned by the teacher.

He said these students were unable to succeed in high school.

Morse said the only legal tender in politics is honesty and

in this Nixon is bankrupt.

He said Nixon was trying to make it a one-man government and was destroying the three sectors of government, legislative, judicial and administrative.

Morse said the Democrats are more united now than in 1968 and he believes this will continue into the campaign under McGovern with strong support from the young people.

Morse restated his opposition to the Asian war and said the United States must get its soldiers out of Southeast Asia so that help could be given to the people there.

Victim dies

A seven-year-old Boring boy died in Emanuel Hospital June 29, of a gunshot wound he suffered June 19.

James Michael Gregg had undergone extensive surgery at the hospital earlier, after being shot through the temple with a .357 magnum revolver.

He and a friend were playing with the gun when it discharged.

Sleeping sickness epidemic feared

A horse in the Orient area has died of what may have been Equine Encephalomyelitis known as sleeping sickness.

It is not known definitely if the infection was caused by either the Eastern, Western or Venezuelan Equine Encephalomyelitis virus or if the animal died of other causes because laboratory test results are not complete, according to Dr. Carl Aschoff, the veterinarian who examined the animal.

"I might not know the cause of death until the middle of July," Aschoff told The Outlook Monday. "The tests are not back yet and the cause of death isn't definite at all." Since news of the death spread among East County horsemen, many horses have been vaccinated. Dr. Ken Conklin, Sandy

veterinarian, estimated he had vaccinated more than 300 horses since Thursday and Aschoff said he also has vaccinated at least that many.

The disease, which attacks the brain and the central nervous system, gives the animal a high temperature, makes him off his feed and causes him to be off-balance, Conklin said.

There is no known cure for the disease, Aschoff said. Only the symptoms can be treated.

"I'm not trying to push vaccinations—the tests could come back negative," Aschoff said, "but if it were my animal I'd have him vaccinated as a precaution." "I always recommend vaccinations, anyway," Conklin said. "It's a shame any animal has to die because he wasn't vaccinated."
